Inaugural Session

First Research Council Meeting (RCM) of Bihar Animal Sciences University was held on 6th November, 2017 in Conference Hall No. II of Bihar Veterinary College, Patna under the chairmanship of Dr. Rameshwar Singh, Vice- Chancellor, BASU with gracious presence of Dr. Inderjeet Singh, Director, CIRB, Hisar and Dr. N.S. Sharma, Controller of Examination, GADVASU, Ludhiana on this occasion as a nominated expert members. All the Deans, Directors, Registrar, Chairmen, HoDs and scientists of the university attended the programme. Dr. Chandramoni, Director Research, BASU welcomed and briefed about various research programme of the university. At present seven research projects funded by ICAR and DST are running in the different departments of university. Dr. Inderjeet Singh and Dr. N.S. Sharma critically evaluated and appreciated various research programmes presently running under the university. Hon'ble Vice- Chancellor appreciated the initiatives and research work presented by the scientists of different disciplines. There were three technical sessions of different research groups. Initially, seven ongoing research projects highlights were presented by Principal Investigators of the projects. Detailed discussion was held in the house regarding work done, further improvement, fund utilization, etc. and suggestions came from expert and faculty to strengthen its utility. Chairman also advised to work in the direction for development of a Centre of Mastitis at Bihar Veterinary College, Patna.

Hon'ble Vice- Chancellor informed the house that our university has made MoU with national institutes like IVRI, Izatnagar, NDRI, Karnal and ICAR-RCER, Patna for developing research activity in the university.

TECHNICAL SESSION - I

(Ongoing Research Projects)

❖ Dr. Nirbhay Kumar presented the overview of Outreach Programme on "Monitoring of Drug Residues and Environmental Pollutants". His work was appreciated by the chairman and suggested to follow standard practice of screening of large number of samples for final estimation in HPLC. Further suggestion was to increase the sample size and take the history regarding types of feed offered to dairy animals and other supplement used if any and is there any precaution taken by farmers while using antibiotics in dairy animals for better outcomes.

❖ Dr. Manoj Kumar presented the research highlight of All India Coordinated Research Projects for "Epidemiological Studies on Foot and Mouth Disease". He collected large no. of samples from farmer's door step/field condition and also took help of State Animal Husbandry Department and examined it in his laboratory for drawing any conclusion either positive or negative. Chairman asked to present detailed fund utilization status of the projects and suggested to use the fund effectively specially in TA head.

Dr. Pankaj Kumar delivered the highlights of All India Coordinated Research Projects for "Animal Disease Monitoring and Surveillance". Chairman was satisfied with his approach of collecting samples, proper utilization of funds allotted for said period and suggested to focus on future work plan.

In the meeting Dr. Pankaj Kumar, Assistant Professor, Veterinary Microbiology raised the issue of mastitis problems in dairy animals which creates heavy losses in livestock farmers and presently there is no any working centre available in Bihar to monitor it properly in all aspects. Chairman advised to frame a

proposal to develop a Centre of Mastitis where all facilities will be available at one stop solution.

❖ Dr. Pallav Shekhar presented the detailed report of Experimental Learning Unit

(Critical Care Unit). He had utilized the sanctioned amount to attain mandate of the

programme and result was found satisfactory.

❖ Dr. Gyan Dev Singh presented the highlights of Strengthening and Up-gradation of

TVCC as an Experiential Learning Unit for Pet animals. Chairman was quite satisfied

with the strengthening of TVCC through this project funds and increasing the no. of

pet animal cases day-by-day. He had utilized the sanctioned amount and result was

found satisfactory.

❖ Dr. Pankaj Kumar, Assistant Professor, AHE presented the progress report of Poultry

Seed Project. He had achieved the defined annual target of chicks distribution to

farmers. His work progress was appreciated by chairman and suggested to sale the

eggs and also to think over regarding shifting demand based egg hatching, so, that

overcrowding may be checked in farm.

Department of Science & Technology. Chairman suggested, speeding up the purchase

procedure for timely utilization of funds.

TECHNICAL SESSION - II

(Animal Health Group)

• Dr. Ramesh Tiwary presented a project proposal on studies on urohydropropulsion

and tubecystostomy for surgical management of urolithiasis in goats. After thorough

discussion on proposal in house it was suggested to delete group – C, from technical

programme. Chairman agreed with the house suggestions and his proposal may be

considered for approval under Institute fund.

Dr. Ramesh Tiwary presented a second project proposal on bone marrow derived

mesenchymal stem cells (BMNCs) for cell therapy in canine hip dysplasia. Chairman

appreciated the topic and advised to prepare it as larger project for long term running

and approved for submission in DBT/SERB or any external agency for funding.

Dr. Anjay presented new proposal on study on prevalence and genetic diversity of

methicillin resistance Staphyllococcus aureus carried by animals and human handler

in veterinary hospital. Chairman told that this is usual nature of work which is being

done at laboratory, so, there is need to work for development of an advance centre for

bacteriophages either self or any collaboration.

Dr. Pallav Shekhar presented a proposal on radiographic and sonographic screening of

cardiac, hepatic and urinogenital diseases of canine. Chairman advised that there is

need to standardize the protocol and this proposal may be considered for approval

under Institute fund.

Dr. Kaushal Kumar presented a research project on proliferation and apoptotic assessment of canine mammary tumour for early diagnosis. Detailed discussion was held on proposal and house suggested that to prepare larger project and submit under extramural funding to ICMR or any external agency for developing the cancer centre

for animals.

Dr. Ajeet Kumar presented a proposal on bio-fabrication of gold nano particles and its

anti proliferative effect in cell line. After thorough discussion in house chairman

suggested to do inter-departmental collaboration with similar area of work. This

proposal may be considered for approval under Institute fund.

Dr. Ankesh Kumar presented a project proposal on comparison and development of

standard protocol of oestrous synchronization in anoestrous buffaloes. Detailed

discussion was held in the house and members suggested to take the data of animals

coming for treatment at TVCC. Chairman suggested to adopt one village for field

study & do trial on more no. of buffaloes as well as take help of ultra-sonography if

available. This proposal may be considered for approval under Institute fund.

TECHNICAL SESSION - III

(Animal Production Group)

Dr. Pankaj Kumar Singh presented a project proposal on formulation and evaluation

of area specific mineral mixture on the performance of dairy cattle and buffaloes.

Detailed discussion was held on the proposal and it was appreciated by the house

regarding its importance in livestock farmers. Chairman advised that to elaborate

work plan for all the district of Bihar, include all 4 zones and make collaboration with

CIRB, Hisar for estimation and formulation of mineral mixture as well as take the

field data of work done by NDDB, ILRI in Bihar for future planning. However,

project may be considered for approval to initiate the work for further target under

Institute fund.

Dr. Ravi Ranjan Kumar Sinha presented a research proposal on assessment of

Moringa oleifera as a fodder. After thorough discussion on proposal in house

chairman agreed that this proposal may be considered for approval under Institute

fund.

Dr. Sushma Kumari presented a project proposal on value addition of chicken meat

and its marketing. Detailed discussion was held in the house and members appreciated

the proposal but maintaining the hygiene will be difficult due to lacking in facilities in

the department. Chairman advised to prepare the proposal accordingly for the next

meeting.

TECHNICAL SESSION - III

• Dr. J. Badshah presented a research proposal on process standardization and

optimization for shelf life enhancement of paneer from milk of Bihar origin. After

thorough discussion in house chairman advised to limit your technical programme and

go ahead with thermal sterilization process and this proposal may be considered for

approval under Institute fund.

• Dr. Sonia Kumari presented a project on study on process optimization and feasibility

to enhance shelf life of neera based whey energy drink. Chairman appreciated the

proposal and suggested that paneer whey should be bland and then whey and neera

should be mixed and tested for preparation of whey neera based drink. Detailed

discussion was held on proposal and house advised to do preliminary survey study on

neera processing and then formulate a proposal in collaboration with COMFED, Patna

for next meeting.

Dr. Rakesh Kumar presented a new proposal on development of symbiotic food

formulations utilizing locally available fruits and assessment of economic feasibility.

After discussion on proposal in the house chairman suggested revising the whole

proposal and carefully deciding about the issues related with availability and supply

of strain which is primary requirement of the project and then present in next meeting.

Dr. Binita Rani presented a project proposal on determination of adulterants in paneer

available in market. Chairman advised to revise the topic, objectives and define the

target of sampling after preliminary survey work and then present in next meeting.
