TERMS & CONDITIONS

1. Candidates registered for the Ph.D. Programme prior to July 11, 2009 shall submit a certificate in accordance with the UGC on minimum qualification for appointment of teachers and other academic staff in universities and colleges and measures for the maintenance of standards in higher education (3rd amendment) Regulation. 2016.
2. University reserves the right to cancel all and/or any one interview/candidature without assigning any reason thereof.
3. No. TA/DA shall be paid for attending the interview.
4. Interview may continue for next day depending upon the circumstances, hence the candidate may come prepared accordingly.
5. The selected candidates will be engaged on purely temporary basis (on contract) for a period of one semester/six months, which may be extended for one more semester/six months, based on the performance or terminated earlier with one-month notice on either side, without assigning any reason. Under any circumstances, candidate cannot claim any right for permanent position.
6. Candidates may note that these contract positions are basically to meet the immediate academic requirement of the university and at no point selected candidates will have any claim for regular appointment to be made in future.
7. The prescribed qualifications and experience are minimum, and does not entitle candidate to be called for interview. If number of candidate is large, a minimum cut-off in academic score can be imposed or by any other condition that may deem fit.
8. Addition/deletion/corrigendum (if any) in this advertisement shall be posted on the University website/Notice Board.
9. The number of vacancy may increase or decrease as per the discretion of the competent authority.
12. The statutory provision for relaxing of age, experience, etc. prescribed in case of the candidates belonging to state SC/EBC categories will be made applicable as per UGC norms in force at time of interview. Candidates are advised to check UGC and other relevant website for update information.
13. Canvassing in any form on behalf of any candidate will disqualify such candidate.
14. Selection will be made on the basis of candidates previous record, their performance in the test/ interview (wherever applicable).
15. Experience and qualifications will be reckoned as on the last date of receipt of application.
16. Applications incomplete in any respect will not be considered.




17. No interim queries regarding test/interview/selection will be entertained.
18. In case of any disputes/suites or legal proceedings against, the University, the Jurisdiction shall be restricted to the Courts in Patna, which is the Head quarter of the University.
19. The University will have the right to relax any of the qualifications, experience, age, etc. in exceptionally deserving cases of all posts on the recommendations of the screening and selection committee.
20. Errors and omissions are subject to corrections.
21. Applications received after the last date and without complete information or without requisite fee will be summarily rejected. The University will not be responsible for any postal delay.
22. The University shall verify the antecedents or documents submitted by a candidate at any time at the time of engagement or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
23. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
24. Candidates should send self-attested copies of relevant certificates and mark-sheet from matriculation onwards in support of their qualifications. Originals should not be sent along with the application but these must be produced at the time of interview.
25. The candidates for selection to the posts will be selected by Selection Committee through personal interview. University may conduct competitive written test for the selection of the above posts, if required.
26. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview.


