



GENERAL INFORMATION

1. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle his/her for being called for interview.
2. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed, or by any other condition that may deem fit.
3. The statutory provision for relaxing of age, experience etc. prescribed in case of the candidates belonging to SC/ST/OBC/PWD categories will be made applicable as per UGC/GOI norms in force at the time of interview. Candidates are advised to check UGC and other relevant websites for updated information.
4. The panel of selected waitlisted candidates will be valid for one year from the date of approval of competent authority and University shall make appointments on consequential/new vacancies.
5. Canvassing in any form on behalf of any candidate will disqualify such candidate.
6. Selection will be made on the basis of candidates' previous record, their performance in the test/ interview (wherever applicable).
7. The in-service candidates should apply through proper channel, failing which the application is liable to be rejected. Advance copy of the application may be considered subject to produce **NO OBJECTION CERTIFICATE** from employer at the time of interview
8. Separate application should be submitted for each post with prescribed fee.
9. Experience and qualifications will be reckoned as on the last date of receipt of applications.
10. Applications incomplete in any respect will not be considered.
11. No interim queries regarding test/interview/selection will be entertained
12. University reserves the right not to fill up any of the vacancies advertised, if the circumstances so warranted.
13. New pension scheme will be applicable with subsequent amendments.
14. In case of any disputes/suites or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Patna, which is the Head quarter of the University.
15. The University will have the right to relax any of the qualifications, experience, age, etc., in exceptionally deserving cases of all posts on the recommendations of the screening and selection committee.
16. Errors and omissions are subject to corrections.
17. Applications received after the last date and without complete information or without requisite fee will be summarily rejected. The University will not be responsible for any postal delay.
18. The University shall verify the antecedents or documents submitted by a candidate at any time at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
19. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
20. Applicants who are in employment should router their applications through proper channel.
21. The candidates for selection to the posts will be selected by Selection Committee through personal interview. University may conduct competitive written test for the selection of the above posts, if required.



22. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview.
23. When the Selection Committee considers if fit to recommend a higher initial pay or advance increments to be offered to a selected candidate, it may do so giving reasons there-for.
24. Persons appointed may be transferred to any equivalent post within the jurisdiction of the University.
25. The Chairman Selection Committee shall have the power to lay-down the procedure in respect of any matter not mentioned above.
26. The persons serving in Central/State Govt./Autonomous bodies may be taken on deputation/contract for 01 to 03 years or up to the age of superannuation.
