1. Invitation :- Bihar Animal Sciences University invites expression of interest for appointing a consultant to design, drawing, estimate & supervision of an Animal Hospital under T.V.C.C. (B.V.C., Patna).
2. Scope of Work :- Animal Hospital Will contain following units
 1. Construction of large and small animal examination section.
 2. Indoor ward along with client or farmer's rooms for large and small animal
 3. Intensive care unit for animals.
 4. Loading and unloading platform.

3. **Bid Documents**

Bids shall be prepared in two separate sealed envelopes naming the envelopes as (a) Technical and (b) Financial Bid. Both envelopes shall be kept in a bigger size envelope. Name of work shall be written over the bigger envelope.

1. Envelope of Technical Bid shall consist of:

- a. Document of Registration with any Govt. Institution of India.
- b. Annual Turnover of last five years, duly certified by the registered Chartered Accountant. A minimum turnover of Fifty Lacs in any one year of the last five years shall be required for eligibility.
- c. PAN/Service Tax Registration Document
- d. Bio Data of Key Personnel to be engaged for the proposed job
- e. Experience of successful completion of similar nature of work, supported by employer's certificate.
- f. Photographs and drawings explaining the completed jobs

2. Envelope of financial bid shall consist of:

- a. The consultancy fee offered as per square metre of the built up area of the building.
- b. Rates shall be inclusive of all taxes as the present day rates. No Extra Amount shall be paid for site visit and inspection.




4. Financial offer of only those bidder shall be opened who will qualify during assessment of technical bid.
