**Expression of Interest**

Name of Work: - Development of outdoor facilities for different sports and games.

1. **Invitation:** - Bihar Animal Sciences University invites expression of interest for appointing an agency to design, drawing, estimation, construction & supervision of development of outdoor facilities for different sports and games as per national standard.
2. Specification for the preparation of the following sports ground may be as follows but it has to be as per the Indian National Standard prescribed by authorities like IBF, FIBA, FIBA and ITF. Items like chain link fencing, water pusher, sitting arrangement, Umpire chair, Pole for different sports, net for different sports should be included in the required products.

3. **Bid Documents**

Bids shall be prepared in two separate sealed envelopes naming the envelopes as (a) Technical and (b) Financial Bid. Both envelopes should be kept in a bigger size envelope. Name of work should be written over the bigger envelope.

1. Envelope of Technical Bid shall consist of :

- a. Document of Registration with any Govt. Institution of India.
- b. Annual Turnover of last five years, duly certified by the registered Chartered Accountant. A minimum turnover of Thirty Lacs in any two consecutive years of the last five years shall be required for eligibility.

- c. PAN and GST Registration Document.
  - d. Experience of developing at least five number of courts.
  - e. Warranty Scheme if any.
  - f. Bio Data of Key Personnel to be engaged for the proposed job.
  - g. Experience of successful completion of similar nature of work, supported by employer's certificate.
  - h. Clear photographs and drawings explaining the completed jobs with brief statement.
2. Envelope of Financial Bid shall consist of :
    - a. Abstract of cost for development of each court as per specification mentioned above.
    - b. Cost shall be inclusive of all taxes as the present day rate. No Extra Amount shall be paid for site visit and inspection.
  4. Financial offer of only those bidders shall be opened who will qualify during assessment of technical bid.
  5. Neatly typed/Printed offers with the signature and seal shall be furnished with properly annexed supporting documents.
  6. Incomplete offers shall be summarily rejected. If any information will be found incorrect at any stage, the offer would be rejected.
  7. BASU reserves the right to accept/reject any of all the offers without assigning any reason thereof and no further correspondence in this regard shall be entertained.
  8. BASU reserves the right to verify the past experience of the bidder.
  9. A Pre-Bid meeting is arranged on 06.03.2019 at 03:00 p.m. in the Conference Hall of Administrative Building and the bid should be presented in power point for different sports prepared by the party with their specification.
  10. Expression of Interest should be sent to the address of correspondence by post only and should reach on or before 19.03.2019 upto 3:00 p.m. and the same will be opened on the same day at 04:00 p.m. before the bidders.
