Subject:- Transfer of Krishi Vigyan Kendra Jamui from Shram Bharati Khadigram to Bihar Animal Sciences University, Patna - Sanction thereof

Sir,

I am directed to convey the approval of the Indian Council of Agricultural Research (ICAR) for **transfer of Krishi Vigyan Kendra Jamui from the administrative control of Shram Bharati, Khadigram to Bihar Animal Sciences University, Patna, Bihar with 25.00 acre land at Village Garo, Nawada (Khata no. 124, Khasra no. 548), Block Jamui, Bihar** under the Plan Scheme of the Council subject to the Following conditions:-


- (i) The existing employees of KVK may be absorbed with the KVK, Jamui under the University.
- (ii) ICAR may not provide any of the infrastructure facilities which were provided to KVK Jamui sanctioned to Shram Bharati Khadigram. The University has to establish such infrastructure from its own sources.

3. The detailed terms and conditions governing the grant-in-aid are appended as *Annexure-I*. The proforma for submission of expenditure statement and Audit Utilization Certificate shall be used as prescribed by ICAR/GFR 2007.

4. A list of posts along with pay scales sanctioned for the Krishi Vigyan Kendra is enclosed as *Annexure-II*. The pay scales indicated in *Annexure-II* are as applicable to KVKs under ICAR Institutes. In case of a KVK under a SAU the scales of pay of all staff in the KVK are to be decided by the respective SAU. The liability of ICAR towards payment of pay and allowances will, however, be limited to pay scales as for KVKs under ICAR Institutes or actual whichever is less. The recruitment process may be initiated following the guidelines of the Council, with regard to pay scales/disciplines/qualifications of the posts in consultation with the Director, ICAR-Agricultural Technological Application Research Institute (ATARI), Patna. All relevant guidelines in the matter may be obtained from the Director ATARI, Patna.

5. Approval of the Council is to be obtained for the master lay-out and plan & estimate of buildings and demonstration units before taking up construction work as per norms of plinth area for different buildings and demonstration units as stipulated by the Council in its earlier orders. Copies of such guidelines/orders may be obtained from the Director, ATARI, Patna.

6. The exact date of start of the scheme may please be intimated for information and record in the Director, ATARI, Patna.



7. Demand of fund may please be submitted to the Council in the Patna in April and October every year. All the correspondences to this Division may be made through the Director, ATARI, Patna.


8. The expenditure on this account will be borne by ICAR out of the grants given by the Government of India every year to the Division of Agricultural Extension until further orders.

9. All infrastructural facilities including Administrative Building, Farmers' Hostel, Staff Quarters and Demonstration Units etc. are built within the earmarked land under KVK.

10. Take over all the assests and liabilities of KVK Jamui through Director, ATARI, Patna. Any other issue may be got clarified from the Director, ATARI, Patna.
