
**NOTE :-**

- Rate is based on Current schedule of rate for civil work issued by B.C.D. Govt. of Bihar.
- Earnest money is to be deposited in the shape of NSC/TD/Fixed Deposit/Demand Draft duly pledged in favour of Estate Officer, BASU, Patna.
- Eligibility Criteria for participating in tender :-
  - Registered contractor of Govt. of Bihar/C.P.W.D./M.E.S. for appropriate category for civil/Electrical work .






