GENERAL INSTRUCTIONS & CONDITIONS

- 1. University reserves the right to cancel all and/or any one interview/candidature without assigning any reason thereof.
- 2. No TA/DA shall be paid for attending the interview.
- 3. Interview may continue for next day depending upon the circumstances, hence the candidate may come prepared accordingly.
- 4. The selected candidates will be engaged on purely temporary basis (on contract) and co-terminated with GKMS Scheme.
- 5. Addition/deletion/corrigendum (if any) in this advertisement shall be posted on the University website / Notice Board.
- 6. Canvassing in any form on behalf of any candidate will disqualify such candidate.
- 7. Selection will be made on the basis of candidates previous record, their performance in the test/ interview (wherever applicable).
- 8. Qualifications will be reckoned as on the last date of receipt of application.
- 9. Applications incomplete in any respect will not be considered.
- 10. No interim queries regarding test/interview/selection will be entertained.
- 11. In case of any disputes/suites or legal proceedings against, the University, the Jurisdiction shall be restricted to the Courts in Patna, which is the Head quarter of the University.
- 12. Errors and omissions are subject to corrections
- 13. Applications received after the last date and without complete information will be summarily rejected. The University will not be responsible for any postal delay.
- 14. The University shall verify the antecedents or documents submitted by a candidate at any time at the time of engagement or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.

- 16. Candidates should send self-attested copies of relevant certificates and mark-sheet from matriculation onwards in support of their qualifications. Originals should not be sent along with the application but these must be produced at the time of interview.
- 17. The candidates for selection to the posts will be selected by Selection Committee through personal interview. University may conduct competitive written test for the selection of the above posts, if required.
