

 - d. Character certificate
 - e. GST No. / GST Certificate

6. As per amendment by reservation of rule no. 159(A) and 159 (B) of public work code vide memo प्र००७/नियम ०१/२०१५/५९३१;५, पटना दिनांक ०७/०७/२०१५, ५०% work will be reserved for SC, ST, EBC, BC and BC (ladies) up to Rs. 15 lacks of work value.


