

## GENERAL INSTRUCTION

1. Candidates registered for the Ph.D. Programme prior to July 11, 2009 shall submit a certificate in accordance with the UGC on minimum qualification for appointment of teachers and other academic staff in universities and colleges and measures for the maintenance of standards in higher education (3<sup>rd</sup> amendment) Regulation. 2016.
2. University reserves the right to cancel all and/or any one interview/candidature without assigning any reason thereof.
3. No. TA/DA shall be paid for attending the interview.
4. **Interview may continue for next day depending upon the circumstances, hence the candidate may come prepared accordingly.**
5. The selected candidates will be engaged on purely temporary basis (on contract) for a period of one semester/six months, which may be extended for one more semester/six months, based on the performance or terminated earlier with one-month notice on either side, without assigning any reason. Under any circumstances, candidate cannot claim any right for permanent position.
6. Candidates may note that these contract positions are basically to meet the immediate academic requirement of the university and at no point selected candidates will have any claim for regular appointment to be made in future.
7. The prescribed qualifications and experience are minimum, and does not entitle candidate to be called for interview. If number of candidate is large, a minimum cut-off in academic score can be imposed or by any other condition that may deem fit.
8. Addition/deletion/corrigendum (if any) in this advertisement shall be posted on the University website/Notice Board.
9. The number of vacancy may increase or decrease as per the discretion of the competent authority.
10. The statutory provision for relaxing of age in case of the candidates belonging all reserved categories of state of Bihar will be made applicable as per GAD, Bihar norms in force at time of interview. Candidates are advised to check GAD, Bihar website for update information.  
**SC/ST candidates shall have to produce caste certificate whereas EBC/BC candidates shall have to produce non creamy layer certificates issued by C.O. in favour of their claim of reservation.**
11. Canvassing in any form on behalf of any candidate will disqualify such candidate.
12. Selection will be made on the basis of candidates previous record, their performance in the test/ interview (wherever applicable).
13. Experience and qualifications will be reckoned as on the last date of receipt of application.
14. Applications incomplete in any respect will not be considered.
15. No interim queries regarding test/interview/selection will be entertained.
16. In case of any disputes/suites or legal proceedings against, the University, the Jurisdiction shall be restricted to the Courts in Patna, which is the Head quarter of the University.
17. The University will have the right to relax any of the qualifications, experience, age, etc. in exceptionally deserving cases of all posts on the recommendations of the screening and selection committee.
18. Errors and omissions are subject to corrections.
19. Applications received after the last date and without complete information will be summarily rejected. The University will not be responsible for any postal delay.
20. The University shall verify the antecedents or documents submitted by a candidate at any time at the time of engagement or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
21. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.



22. Candidates should send self-attested copies of relevant certificates and mark-sheet from matriculation onwards in support of their qualifications. Originals should not be sent along with the application but these must be produced at the time of interview.
23. The candidates for selection to the posts will be selected by Selection Committee through personal interview. University may conduct competitive written test for the selection of the above posts, if required.
24. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview.
25. **Maximum age of applicant of Assistant Professor-Guest Faculty as per Resolution No. 294 dated 07.01.2016 issued by GAD, Patna is as follows**
  - a) **Unreserved Category (Male)- 37 Yrs.**
  - b) **Backward Class and Extremely Backward Class (Male & Female)- 40 Ys.**
  - c) **Unreserved Category (Female)- 40 Yrs.**
  - d) **Scheduled Castes and Scheduled Tribes (Male & Female)- 42 Yrs.**
26. **Age relaxation in maximum age for the post of Assistant Professor-Guest Faculty is as follows: -**
  - i) **As per Resolution No. 3 /M-63/2005-2374 dated 16-07-2007 issued by the then personnel & Administrative reforms Department (at present GAD), Patna five years extra age relaxation shall be admissible to the employees of Govt. of Bihar applying for Higher Pay Scale (i.e. Grade Pay, Level etc) in services / cadres.**
  - ii) **As per Section 4.14 of Bihar Gazette (Extra) 21<sup>st</sup> March-2017, (Bihar Agricultural University, Sabour Notification dated 27<sup>th</sup> Feb. 2017)**
    - a) **The maximum age limit for entry into the service up to Asstt. Prof. rank in the University shall be as prescribed by the State Govt. from time to time. However, there shall be no age limit for appointment on Technical Posts such as Deans, Directors / Registrar/ University Professor/ Associate Professor or equivalent in the university.**
    - b) **There will be no age restriction for employees of the University seeking higher posts under direct recruitment procedures. The upper age limit for recruitment will be as per State Govt. rules.**
27. Relaxation of 5% marks that is from 55% to 50% marks at Master's Degree level for the SC / ST shall be applicable who are original resident of Bihar only.
28. Download and print out of complete application form and duly fill it and attached self-attested copies of testimonials/certificates. The envelope should be superscripted "Application for the post of ....." 29. The applicant must enclose reprint/Xerox copies of his/her at least 02 (two) published research paper along with application form (only first page).


