GENERAL INSTRUCTION

- 1. Candidates registered for the Ph.D. Programme prior to July 11, 2009 shall submit a certificate in accordance with the UGC on minimum qualification for appointment of teachers and other academic staff in universities and colleges and measures for the maintenance of standards in higher education (3rd amendment) Regulation. 2016.
- 2. University reserves the right to cancel all and/or any one interview/candidature without assigning any reason thereof.
- 3. No. TA/DA shall be paid for attending the interview.
- 4. Interview may continue for next day depending upon the circumstances, hence the candidate may come prepared accordingly.
- 5. The selected candidates will be engaged on purely temporary basis (on contract) for a period of one semester/six months, which may be extended for one more semester/six months, based on the performance or terminated earlier with one-month notice on either side, without assigning any reason. Under any circumstances, candidate cannot claim any right for permanent position.
- 6. Candidates may note that these contract positions are basically to meet the immediate academic requirement of the university and at no point selected candidates will have any claim for regular appointment to be made in future.
