- 2. ISP should have ISO 9001:2000 certification in network operations, data center operations and customer relationship management. Copy of duly attested Certificate / Document showing ISO 9001:2000 certifications to the effect should be submitted in the envelope containing technical bid.
- 3. The quotationer should have valid registration, valid GST registration certificate and Permanent Account Number (PAN) issued by respective authorities. Copies of certificates & supporting documents should be submitted along with technical quotation.
- 4.
