Candidates are advised to go through the Gazette Notification No. Registrar/ BAU, Sabour/ 1812 dated 03.01.2020 and visit BASU website before filling the form. Application must be complete and all relevant documents (self-certified) and consent for evaluation by the system must be enclosed with the application. Application form must be neatly typed in Times New Roman Font with font size 12. It must be ensured that documents pertain only to the period of assessment and due date is correctly written. Any application having documents before or after the assessment period will be rejected forthwith and no representation will be entertained.

Last date of submission of application to the respective Deans/ Directors/ Controlling Officers will be 8<sup>th</sup> May, 2020. Concerned Dean/ Directors/ Controlling Officer after proper scrutiny and required certificate will forward the application to the Registrar latest by 19<sup>th</sup> May, 2020. Subsequently, Office of the Registrar will verify the records of individuals and submit to the Screening cum Evaluation Committee of Career Advancement Scheme.

Incomplete application forms, forms received after last date and forms without consent for evaluation by this system will not be evaluated.
