The approved proceedings are placed for information. Accordingly, action was taken in and the University conducted its 1<sup>st</sup> Convocation on 15 October, 2019 successfully where Degrees and University Medals were conferred on qualified students.

Agenda No. 2: Approval for modification in provisions related to recruitment against teaching posts in the University.

Details:

As Bihar Animal Sciences University, Patna has been established in the year 2016, there is acute shortage of faculty in both Sanjay Gandhi Institute of Dairy Technology, Patna & College of Fisheries, Kishanganj. The response to advertisements of faculty positions has been very poor. It is felt that the qualification for the posts need to be broad based to attract more candidates and ensure better competition. In view the the same for recruitment of faculty at Sanjay Gandhi Institute of Dairy Technology, Patna & College of Fisheries, Kishanganj following change is being proposed:-

1.	For appointment on the posts of teachers/ scientist in Agriculture, Veterinary, Ag. Engg., Dairy Technology, Fisheries and Home Science related subject, it would be a basic requirement for the candidate applying for the posts to hold/possess respective basic professional degree at the Undergraduate level.  Note: - Professional Degree means; B.Sc. (Agriculture)/B.V.Sc. & A.H./B.Tech (Ag. Engg.)/ B.Tech (DT)/B.Sc. (DT) or equivalent/ B.F.Sc./ B.Sc. (Home Science) and Pure Science for Basic Sciences subjects.	This clause is being dropped.  Note: - For the appointments of teachers /scientist in Veterinary Faculty, guidelines of Veterinary Council of India will be applicable.

Existing provision in statute of BAU, Sabour at Chapter-XIII, Clause 13.1, Note No. 10 has been placed at Page No. 14.

Further, Bihar Animal Sciences University proposes to adopt Bihar Agricultural University, Sabour Statute amendment notification issued on 9<sup>th</sup> May, 2019 related to faculty recruitment.

Statute amendment notification issued on 9<sup>th</sup> May, 2019 is placed at page No. 15-17.

Agenda No. 3: Approval of Criteria for disbursement of stipend to Under graduate students.

To attract students towards Agriculture and allied courses, Government of Bihar pays Rs. 2000/- per month as stipend along with additional annual contingency of Rs. 6000/- per year for purchase of study material to Undergraduate students

pursuing courses in Agriculture, Dairy, Animal Husbandry and Fisheries. Presently BASU, Patna is following the rules of B.A.U., Sabour for disbursement of Stipend. However, the rules for disbursement of Stipend need to be further elaborated to bring more clarity; as proposed below:-

- A. He / She should pass and must obtain at least GPA of 5.0
- B. He / She should have attendance of at least 75% in all courses in a Semester in case of B.Tech (D.T) & B.F.Sc.
- C. He / She should have attendance of at least 75% in all courses during last six months of class attendance, in case of B.V.Sc. & A.H.
- D. The stipend/Scholarship will be disbursed on half yearly basis.
- E. Stipend will not be given to students during the period of academic or conduct probation.
- F. The stipend/Scholarship will not be given to students beyond 8 semesters to B.Tech (D.T.) and B.F.Sc. students and 4½ years in case of B.V.Sc.& A.H students.

- 4. In the middle of the page seal of University as background watermark.
- 5. In the back side of the page:
  - (a) Certificate No. for B.V.Sc. & A.H. Programme BASU/VU/00001. for M.V.Sc. degree BASU/VM/00001, for Doctorate in Veterinary BASU/VD/00001. for B.Tech(D.T.) BASU/DU/00001, for M.Tech(D.T.) BASU/DM/00001, for Doctorate in Dairy technology BASU/DD/00001, for undergraduate students of Fisheries Sciences BASU/FU/00001, for Master degree in Fisheries Sciences BASU/FM/00001, for Doctorate in Fisheries Sciences BASU/FD/00001 in these number BASU denotes University name, V, D & F denotes Faculties U, M

Agenda No. 4: Approval of Eligibility criteria and name of Graduates and Post graduate students for Award of Medals to toppers

Details: As Bihar Animal Sciences University, Patna is going to convene 1st convocation on 15 October 2019, there is need to set eligibility criteria for award of Medals to toppers, the following criteria have been approved by the Academic council:



## Eligibility of Graduating students for award of medals

- a) He/She has obtained 7.5 OGPA.
- b) Those who fail in any course or repeat a course are not eligible for the award of Medals.
- c) He/ She should not have been on Academic Probation, at any stage during degree programme.
- d) He/she should not have been on Conduct Probation, at any stage during degree programme.
- e) He/she should not have repeated any course of study i.e. He/she should have cleared all examinations in one attempt in prescribed year/ semester.
- f) In case of a tie, the Medal shall be awarded to each of the candidates securing equal marks.
- g) The Medal will be awarded batch-wise.
- h) In case of a tie, the Medal shall be awarded to each of the candidates securing equal marks.
- i) The Medal shall not be admissible to such students, who have taken semester withdrawal and got 'F' grade. However, the students who have taken course withdrawal as per regulations shall be eligible for consideration of award of Medal, if otherwise, eligible for the same.

#### Eligibility of Post graduate students for award of medals:

The Medal shall be awarded to students of M. Tech./ M. F. Sc. M. V. Sc./ Ph.D. Programmes under the following criteria: -

- a. He/ She has obtained 8.5 OGPA.
- b. Those who fail in any course or repeat a course are not eligible for the award of Medals.
- c. He/ She should not have been on Academic Probation, at any stage during degree programme.
- d. He/she should not have been on Conduct Probation, at any stage during degree programme.
- e. In case of a tie, the Medal shall be awarded to each of the candidates securing equal marks.
- f. The Medal will be awarded batch-wise to the M.Tech./ M.F.Sc. /M.V.Sc/ Ph.D. students.
- g. M. Tech./M.F.Sc./M.V. Sc. and Ph.D. students should have submitted their thesis in IV<sup>th</sup> and VI<sup>th</sup> semester and results should have been notified by the end of Vth and VII<sup>th</sup> Semester, respectively.
- h. The Medal shall not be admissible to such students, who have taken semester withdrawal and got 'F' grade. However, the students who have taken course withdrawal as per regulations shall be eligible for consideration of award of Medal, if otherwise, eligible for the same.

(5) The minimum length of experience in the case of persons with exceptionally brilliant academic records, i.e. who hold a Doctorate degree in the subject concerned and who secured a First Division, either in all the examinations, or in, exceptional cases, all except one, without having failed at any examination, may be relaxed at the discretion of the Selection Committee.

(6) The procedure for selection of Principal/University Professor/Associate Professor

and equivalent rank should involve the following:

(i) The process of selection should involve inviting the bio-data and Selection will be done through interview by duly constituted Selection Committee. The short listed candidates will be invited for interview.

(ii) The process of selection should involve the following:

(a) Assessment of aptitude for teaching and research;

(b) Ability to communicate clearly and effectively;

(c) Ability to analyze and discuss; and

(iii) It may be ensured that the process of selection in every case is transparent and credible

- (7) The minimum requirement of 55% should not be insisted upon for University Professors, Associate Professors, Registrars, Deputy Registrars, Librarians, Deputy Librarians and other equivalent posts for the existing incumbents who are already in the University system. However, these marks should be insisted upon for those entering the system from outside and those at the entry point of Assistant Professors, Assistant Registrars, Assistant Librarians and other such equivalent posts.
- (8) Incentives for Ph.D./M. Phil:
  - Four and two advance increments will be admissible to those who hold Ph.D. and M.Phil degrees, respectively, at the time of recruitment as Assistant Professor-cum-Junior Scientist. Candidate with D.Lit/D.Sc. should be given benefit at par with Ph.D. and M.Lit at par with M.Phil.

(h) One increment will be admissible to those teachers with M. Phil who acquire Ph.D. within two years of recruitment.

An Assistant Professor obtained Ph.D. degree during service career will be eligible for two advance increments when she/he moves into Selection Grade/Associate Professor cum Sr. Scientist.

(d) A teacher will be eligible for two advance increments as and when she/he acquires a Ph.D. degree in her/his service career.

(9) Service Agreement:

At the time of recruitment in University and its Colleges, service agreement should be signed between the University/College and the Teacher which should be lodged with the Director (Administration)/Principal with a copy to the concerned teacher. The self-appraisal of performance should be a part of the service agreement.

(9) For appointment on the posts of teachers/scientist in Agriculture, Veterinary, Ag. Engg., Dairy Technology, Fisheries and Home Science related subject, it would be a basic requirement for the candidate applying for the posts to hold/ possess

respective basic professional degree at the Under-graduate level.

Note: Professional Degree means; B.Sc.(Agriculture)/B.V.Sc.& A.H./B.Tech (Ag. Engg.)/B.Tech (DT)/B.Sc.(DT) or equivalent/B.F.Sc./B.Sc.(Home Science) and Pure Science for Basic Sciences subjects.
