d.	Recognition for Ph.D. guide may only be given to a teacher holding Doctorate Degree and who has successfully guided at least two candidates for Master's degree in the concerned faculty or should be a Professor/Associate Professor.
e.	The DRI-cum-Dean of Post graduate studies shall grant recognition on the recommendation of the Chairman/ HoD and Dean of the concerned faculty in all cases where the academic attainment is in consonance with the prescribed standards.
f.	In the case of persons in respect of whom qualifications and experiences are not of prescribed standards as laid down in the regulations, they will be treated as special cases and final permission shall be taken from Hon'ble Vice Chancellor.

Nothing in these regulations shall affect the recognition of post graduate teachers already granted before the commencement of these regulations under the regulations then existing.

As per the decision taken in the 7th Academic Council of Bihar Animal Sciences University, Patna held on 25/06/2020 vide Agenda No. 12, following revised rules are being adopted for allotment of Advisor to the students:

- a. Each student shall be allotted the Major Advisor for the thesis research work as per their rank/merit from the accredited P.G./Ph. D. Faculty.
- b. In every academic year, the Chairman/Head of Department (HoD) will maintain seniority lists of eligible faculty members as on 30th June of every year for guiding Master's and Doctoral students. The seniority list will be provided by the Chairman/HoD to the University (DRI-cum-Dean PGS) by 15th July of every year for allotting guide to the P.G. students. The Chairman/HoD of the concerned department, in consultation with faculty members, will prepare the list of total number of guides equal to the total number of Master's and Doctoral students. Firstly, allotment of guides will be made to Doctoral students and after that to Master's students admitted in an academic year. Allotment of guide and place of work will be made as per the choice and rank of the student.
- c. In case any faculty member has already in hand two or more Doctoral and Master's students together at any time on 30th June of every year, his/her name will not be included in the list for allotting the student. In an academic year, one student shall be allotted to a guide and maximum number students, including previous years students under his guidance, shall not exceed two in all for Doctoral and Master's together at any time.
- d. However, only in a particular discipline where there is shortage of faculty, they can be considered and also be given more than one student to a particular faculty member in the same academic year which shall be recommended by the Committee giving justification & submit the same to the DRI-cum-Dean PGS for approval. The Committee for allotment of P.G. students will be approved by the DRI-cum-Dean PGS.
- e. For Guiding Ph.D. Students, faculty members eligible for guiding doctoral students shall be considered first for guiding doctoral students as per the choice and rank of the PhD students. The students will have the choice in the allotment of advisor/guide amongst available eligible faculty members. The Committee will recommend the advisors for the doctoral students on the basis of seniority from the eligible faculty members as per the rank and preference of choice of the students.
- f. For eligibility to guide doctoral student, the faculty member holding a Ph.D. degree should satisfy the following condition(s):
 - a. Should have guided at least two Master's students

OR

Should be a Professor/Associate Professor with a minimum 10 research publications and that should be in journals with NAAS rating of more than 5.0.

g. For Guiding Master's Students:

After completing the Ph.D. allotment, the Master's students will have the choice in the allotment of advisor amongst equal number of available eligible faculty members (in cyclic order). The Committee will recommend the Advisors for the Master's students as per the rank and preference of choice of the students. The Committee shall give preference to the faculty members, who have not been allotted any student, while nominating the advisor to students for Master's degree program.

For eligibility to guide Master's Scholar:

- a. At least two years of UG Teaching
- b. Published 3 Research paper in Journals with NAAS rating of more than 4.0
- h. The names of members of the faculty from major discipline will be arranged in the order of their respective seniority in the faculty.
- i. Faculty members who are due for retirement within next 2 and 3 years from the date of admission cannot be considered for allotting Master's and Doctoral students, respectively.
- j. Likewise, in case any Advisor retires or quits the institute for any reason, the second senior most member of major discipline in the concerned student's Advisory Committee will act as Advisor in place of the outgoing faculty.

The student of Master's/Doctoral degree programme who drops the study either on Temporary Dropping or any other reason, will not be counted while reckoning the number of students already in position with a faculty member at the time of allotment of guide (i.e. first day of academic year).

The orientation course may be conducted for newly appointed teachers or all those teachers who require Orientation Programme for getting promotion in higher grade under Career Advancement Scheme of Bihar Animal Sciences University. All newly appointed teachers, within two years of continuous service, and all those teachers who require orientation for getting a higher grade will be allowed to attend Orientation Programme.

Part time/ad hoc/temporary/contract teachers who have been teaching for at least three academic sessions in an institution may be permitted to participate in the Orientation Programme to enhance their skills.

III. Duration:

> The Orientation Programme will be of one-week duration, with minimum of 06 working days (excluding Sunday and and public holidays).

IV. Course Coordinator:

> In case of Orientation Programme, DRI-cum-DEAN, PGS will appoint one of the faculty members as Coordinator of the programme. He / she will not be entitled for any honorarium.

The evaluation of the participants will be made and graded as satisfactory/unsatisfactory.

PROFILE OF THE UNIVERSITY

Bihar Animal Sciences University (BASU) has been established with its headquarter at Patna through an act of Bihar State (BASU Act No. 15 of 2016, notified in the Bihar Gazette on 29 August 2016). The new University has been carved out of the Bihar Agricultural University, as two of its constituent colleges at Patna viz. Bihar Veterinary College and Sanjay Gandhi Institute of Dairy Technology were transferred to BASU, whereas a new College of Fisheries was inaugurated on 13 June, 2018 and has started functioning at Kishanganj. To further expand the horizon of the University and strengthen the research and outreach, following research institutes, stations and substations are being transferred to BASU viz. Institute of Animal Health and Production, Patna, Exotic Cattle Breeding Farm, Patna, Central Poultry Farm, Patna, Government Cattle Farm, Gaya and Government Buffalo Farm, Sipaya (Gopalganj). The University is functioning at Patna in the Bihar Veterinary College Campus near Jai Prakash Narayan International Airport, Patna. The objectives of the University are given below:

OBJECTIVES

- To impart education in Veterinary Science, Animal Husbandry, Poultry, Fisheries, Dairy and other allied branches of learning.
- To further the advancement of learning and conducting of research, particularly, in Veterinary and Animal Sciences, Dairy, Fisheries and other allied sciences.
- To undertake the extension of education of such sciences and technologies that are relevant for the livelihood of rural people of the state.
- To facilitate and ensure qualitative improvement in the teaching and learning processes and methodology.
- To facilitate and ensure quality research in the contemporary and frontier areas of animal science and technologies.
- To facilitate the need for an organized process of lifelong learning.
- To disseminate knowledge and findings emerging in the University, its colleges, and institutions.
- To establish partnerships with the industries and other entities working in animal science and technology and agriculture manufacturing.
- To establish Hospital for treatment/ research-role of the University.
- Such other purposes as the University or Government may advise from time to time.
- To establish Dairy processing plant for production of quality dairy products, advancement of research and to import hands on training to the dairy students.

- 3. Faculty of Fisheries Sciences at Kishanganj.

BIHAR VETERINARY COLLEGE

Bihar Veterinary College, Patna, the 5th oldest Veterinary College in undivided India, was laid down on 2nd April, 1927 by Sir Henry Wheeler, the then Governor of Bihar & Orissa. The buildings were completed, laboratories were equipped but teaching and professional staff joined the college in 1930. However, the college started functioning w.e.f. 7thApril, 1927. The College made tremendous progress under the guidance and supervision of Dr. R. T. Davis, the first Principal of this historic College with a team of renowned scientists specialized in Breeding, Feeding, Management and Disease control of Livestock and Poultry. During the post-independence period, Bihar Veterinary College developed to its full capacity and occupied a prestigious status associated with strong academic base for teaching and research in the field of Veterinary Science and Animal Husbandry as well as advanced Veterinary clinical services to the society.

Bihar Veterinary College, Patna, for a long time, provided quality Veterinary education and training not only to the candidates from Bihar and Orissa but also from several other states (U.P., Meghalaya, Mizoram, Tripura, Jammu & Kashmir, Assam, Himachal Pradesh etc.) of the country as well as from developing countries like Nepal, Bhutan, Afganistan, Iran, Malaysia etc. Graduates of this college are spread all over the world and have occupied coveted and prestigious positions in State and Central Government, State Agricultural Universities, Research Institutes and National as well as Multinational Industries. It can be mentioned with proud that Dr. C. M. Singh, Dr. B. S. Rajya, Dr. G. C. Mohanty, Dr. O. N. Singh, Prof. A. Ahmad, Dr. H. R. Mishra, Dr. R. B. Prasad, Dr. V. S. Pandey, Dr. D. V. Singh, Dr. G. Biswal, Dr. D. C. Nayak etc. are /were among the glittering alumni of this alma mater.

In the beginning (1930-1949), a three-year diploma course was started awarding G.B.V.C. (Graduate of Bihar Veterinary College) Diploma. Keeping pace with the advancement of Science and Technology, four-year degree course awarding the degree of B.V.Sc. & A.H. was started in 1949. An emergency Diploma-Shift-Degree course was introduced in the year 1954-55. The professional competency of diploma holders was also updated by subjecting them to "Condensed degree course" of two years and awarding B.V.Sc. & A.H. degree. The first batch of regular degree holders, admitted in 1949, came out in 1953 and became one of the stake holders of the Livestock and Poultry Resources of India, in general and Bihar and its neighbouring states in particular.

UNDERGRADUATE PROGRAMME

Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H.)

The Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H.) degree course offered at Bihar Veterinary College (Bihar Animal Sciences University) is a full-time five and a half year duration undergraduate course of study as per Minimum Standards of Veterinary Education issued by the Veterinary Council of India (2016). This programme aims at to prepare young professionals

expertise in animal production, animal health management and veterinary medicine to be responsible and responsive to the demands of society in an ever-changing environment.

Eligibility: Higher Secondary / Intermediate/ 10+2 or equivalent examination from any recognized Board or Council with Physics, Chemistry and Biology is the eligibility criteria for admission in B.V.Sc & A.H. degree programme. Candidates are admitted on the basis of marks obtained in the National Eligibility-cum-Entrance Test (NEET) conducted at national level. Counseling of the candidate is conducted by the Bihar Combined Entrance Competitive Examination (BCECE) Board, Patna, Bihar for admission in BVSc & AH degree programme.

- The Master of Veterinary Science (MVSc) degree programme is of 2 years duration covering four semesters offered at BVC, Patna.

ELIGIBILITY REQUIREMENT

- (a) A candidate should possess at least 70% marks in aggregate or 7.0/10.0 in Master's Degree Program and in case of SC/ST, 65% marks in aggregate or 6.5/10.00 OGPA

 University follows the Veterinary Council of India (VCI) rules, the Minimum Standards of Veterinary Education (MSVE) Regulations 2016 for admission in Bachelor of Veterinary Science and Animal Husbandry – Degree Course. (For detail information the candidates may visit website <u>www.dahd.nic.in</u> or <u>www.aipvt.vci.nic.in</u>).

- B.V. Sc.& A.H. Degree course shall comprise of a course of study consisting of curriculum and syllabus spread over 5¹/₂ complete professional years including a compulsory rotational internship of "one year" duration undertaken after successful completion of all credits.
- Medium of instruction for B. V. Sc. and A. H. degree course shall be English.
- First professional year of Bachelor of Veterinary Science and Animal Husbandry classes shall commence latest by 1st September of every year.
- Each professional year shall cover at least two hundred ten days of instruction excluding time spent for annual examinations.
- The annual examination shall be conducted prior to summer vacation for the year.
- The schedule of examination during Bachelor of Veterinary Science and Animal Husbandry course shall consist of internal assessment and annual examinations.
- A candidate having attendance below 75% in a subject shall not be eligible to appear in the annual examination of that subject.
- A student shall be promoted to next higher professional class only if he or she has passed in all the subjects of the respective class by obtaining at least 50% marks in theory (internal and external combined) and practical separately.
- After passing the fourth professional examination every student of BVSc & AH degree course shall be
 required to undergo compulsory rotating internship to the satisfaction of the University for a minimum
 period of twelve calendar months so as to be eligible for the award of the degree of Bachelor of
 Veterinary Science and Animal Husbandry and full registration with the council.
- P.G. programme (M.V.Sc. / Ph.D.) shall be governed by ICAR regulations.

ACADEMIC CALENDAR

- For Undergraduate programme (B.V.Sc.& A.H.) the academic year shall ordinarily be commenced from September every year
- For Masters and PhD programmes academic calendar shall start in August every year.



The Bihar Veterinary College is a constituent college of Bihar Animal Sciences University which maintains a well-equipped central library at the university level with all the relevant reading materials to cater the needs of the students, teachers and extension specialists of the university in the Bihar Veterinary College Campus itself. The library also maintains internet services, e-journal access and CD ROM facilities to its members.


LABORATORIES INSTRUCTIONAL FARM WORKSHOP VETERINARY CLINICS HATCHERY ETC.

All the departments of college are well equipped with the laboratories for undergraduate teaching as per Veterinary Council of India and for post graduate teaching as per ICAR guidelines. The college has a dedicated Centre or Unit for providing diagnosis of infectious and non-infectious animal diseases. Diagnostic facilities like X-ray endoscopy, ultrasonography blood biochemical analyzer histopathology, antibiotic sensitivity test, infectious disease diagnosis etc. are available at Veterinary Clinical Complex (TVCC). The faculty of different departments viz. Microbiology, Pathology, Parasitology and Biochemistry contribute together in diagnostic services. Large number of cases are attended in the clinical complex and the samples are processed for diagnosis. Similarly, samples from the field are also received from government hospitals/ farmers and practitioners. As required the faculty of other departments such as Pharmacology, Animal Nutrition, Veterinary Public Health and Epidemiology as well as Veterinary Physiology also help in the diagnosis. The confirmatory disease diagnosis is the core activity being undertaken by the College to support the veterinarians and farmers of the state. The clinical and para-clinical departments collect, transport and analyse lots of morbid necropsied and other variety of samples (biological fluids including discharges, blood serum and plasma) tissue samples, urine, faecal samples etc. for microbiological, pathological, biochemical and toxicological evaluation. The quick and confirmatory diagnosis helps the clinicians and consultants to institute suitable therapeutic, preventive and curative measures. Besides this active and passive surveillance under All India Coordinate Research Project (AICRP) on Animal Disease Monitoring and Surveillance (ADMAS) and AICRP on Foot & Mouth Disease (FMD) are also undertaken so that baseline data for the state of Bihar are created for use in policy making.



As a part of experiential learning a Critical Animal Care Unit under the control of Department of Veterinary Medicine (with the funding of ICAR) and Model Demonstration unit of slaughter of small animals under the control of Department of Livestock Products Technology (University funded) has been established for providing practical training to the UG students of the college.

The Livestock Farm Complex (LFC) is having about 30 acres land out of which about 25 acres is under fodder cultivation and is maintaining different livestock units for fulfilling the needs of university mandates of UG/PG teaching, research and extension activities. The UG/PG students are being fully exposed in management of farm practices and animal treatment at LFC. At present the department is maintaining a dairy herd of 70 animals and a sheep and goat unit. The department also maintains a state of art poultry unit with setter unit (16000 capacity) and hatcher unit (10000 capacity) under Poultry Seed Project. The poultry unit maintains parent stock of Vanraja breed (1800 Nos), breeding stock of Japanese quail (300 Nos) and demonstration unit of Kadaknath.



The department of LFC is maintaining three tractors with trolleys besides equipment for farm cultivation like disc plough, harrow, cultivator and leveler, slasher, chaff cutter, grass cutting machine etc.

STUDENT INTERNSHIP/EXPERIENTIAL LEARNING PROGRAMMES

The Internship programme is undertaken by students after completion of four-and-a-half-year period during the last twelve months of B.V.Sc. & A.H. degree programme. A successful completion of all the theory and practical courses is a pre-requisite to enroll for an internship programme. Depending upon the number of students they are divided into batches. During the period of internship programme the students are rotated in different clinical and paraclinical departments of the college for a period of 3 months. Out of 3 months the majority of the period spent in the clinical departments comprising of Gynaecology, Medicine and Surgery where the interns are entrusted with a round the clock responsibility. The interns are trained in cattle production and management in the livestock farm of the university for a period of 3 weeks. The students are also exposed to the facilities managed by the State Animal Husbandry Department at different places such as Semen Processing Station, Zoo Veterinary polyclinic and Pet clinics. The students are sent outside the state in National Institutes for their exposure and field training like IVRI, NDRI, BAIF etc. The representatives of various pharmaceutical companies also interact and address the interns. The interns are paid an amount of Rs 5000/- per month as an internship allowance. At the end of the internship, each student is evaluated and those found with satisfactory performance are awarded degree.

HOSTEL ACCOMMODATION



Separate hostels for boys and girls are available at Bihar Veterinary College Patna. Hostel accommodation cannot be claimed as a matter of right. With the permission of the competent authority and guardian, students can be allowed to stay outside the hostel as day scholar.

EXAMINATION HALL

At present the examinations are being conducted in the lecture halls. A separate examination hall complex has recently been constructed for conducting examination. The External Examination and Evaluation Cell has been

established at University level with all latest facilities required for the conduct of examinations is available in the college.

EXHIBITION HALL/MUSEUM

The department of Veterinary Extension Education is maintaining a museum for display of various activities of the college through posters and models.

EMPLOYABILITY

The students who are graduated from this college have 100% employability. Majority of our graduates around 80% are employed by the government sector in the Department of Animal Husbandry as Veterinary Officers. Many of these veterinary officers join after their B.V.Sc. & A.H. whereas around 15-20% join after obtaining their specialization. Around 5-10% of graduates who opt for higher studies find a satisfying career in institutes of highest learning in research and academia (universities, ICAR institutes) both in India and abroad. Veterinary graduate students also join reputed organizations like COMFED, JIVIKA, RVC, SSB etc.

NEW INITIATIVES

VETERINARY EMERGENCY RESPONSE UNIT (VERU)

Veterinary Emergency Response Unit (VERU) was established in the college during Kosi flood in the year 2008-09 in collaboration with World Animal Protection (WAP), New Delhi. The basic objective of creating Veterinary Emergency Response Unit in this college is to develop human resources capable of conducting rescue of animals during disaster and also to prevent any outbreak of diseases post disaster as well as to conduct impact of such incidents and be prepared for future. The training comprises of a series of lectures spread over 4- days rigorous training including table top and field exercises.

Animal Disaster Management certificate course for students of Bihar Veterinary College Patna was conducted from 03.05.2018 to 08.05.2018 by Veterinary Emergency Response Unit (VERU) of Bihar Animal Sciences University Patna. Twenty-three students of 4th year under graduate course completed it successfully. Under this programme the students were exposed to five days' theory classes on prefix animal disaster lecture module and one-day simulation exercise at 9th Battalion NDRF, Bihta (Bihar) and got hands-on- training. This programme is first of its kind in the country which imparts specialized training to Veterinary students.

Regular training of veterinary Doctors of the Animal Husbandry department, GOB is being imparted apart from training to NDRF and SSB personnel. Training has also been organized for trainers by VERU unit of this college. This helps in creating human resources capable of working as trainers and work under disaster situations to save precious livestock.

SANJAY GANDHI INSTITUTE OF DAIRY TECHNOLOGY



Sanjay Gandhi Institute of Dairy Technology (SGIDT), Patna is now a constituent College of Bihar Animal Sciences University (BASU), Patna. Prior to that it was a part of Bihar Agriculture University (BAU), Sabour since 2010 and a part of RAU (Rajendra Agriculture University), Pusa since the inception of the institute i.e. from 1980.

SGIDT has been an ICAR accredited institute since 2017. The institute imparts state of the art teaching, research and extension in the area of Dairying encompassing Dairy Engineering, Dairy Technology, Dairy Microbiology, Dairy Chemistry, Dairy Extension, Dairy Cattle Nutrition, Animal Physiology and Reproduction, Dairy Economics Statistics and Computers. The institute runs a four -year degree programme leading to Bachelor of Dairy Technology (B. Tech-D.T.) and two year post graduate degree program, M. Tech (D. T.), at present. The institute has adopted the course curricula as per recommendation of the Dean's Committee constituted by the ICAR, New Delhi and presently the courses are offered as per ICAR 5th Deans' Committee. The SGIDT was established with the mandate to fulfill the requirements of Dairy Husbandry and Dairy Technology for upliftment and growth of farmers and entrepreneurs in dairy and food sectors of the state.

ACTIVITIES AND LINKAGES

Since inception the institute has provided high dividends in terms of excellent academic and research outputs. The institute has been producing B. Tech. (DT) graduates with spectacular placement records. Many students are persistently securing Junior Research Fellowship (JRF) and have qualified competitive examinations seeking admissions in National Dairy Research Institute (NDRI), Karnal and other State Agricultural Universities (SAUs) in India. A number of students have qualified CAT, GATE and are studying in IIMs, IRMA etc. Alumni of SGIDT are serving in many of the prestigious dairy

plants like AMUL, COMFED (Bihar), Mother Dairy, Nestle etc. Besides, its alumni are also serving in various Government organizations, State Agricultural Universities, national Banks etc.

Apart from teaching, scientists are involved in various research and extension activities. SGIDT is one of the collaborating centres in ICAR-ILRI research project entitled 'Development of Goat milk and meat value chain in Bihar and Uttar Pradesh'. The goal of the project is to sustainably improve the socio-economic condition of goat farmers, traders, butchers and other key factors involved in goat meat/milk value chain in selected districts of Bihar and Uttar Pradesh. Central Institute for Research on Goat (CIRG), Makhdoom, Mathura (UP) and International Livestock Research Institute (ILRI), Nairobi are the lead centres in this projects

STATUS OF THE INSTITUTE

The institute has several departments as per the order sanctioned by Bihar Government for teaching Research and Extension purposes in the field of dairy sciences. Presently under the recommendation ICAR Dean's Committee, five major departments for teaching undergraduate courses have been formed out of total nine departments sanctioned earlier. These are Dairy Technology, Dairy Engineering, Dairy Chemistry, Dairy Microbiology and Dairy Business Management. The Department of Dairy Business Management has merged the different courses of Dairy extension, Dairy husbandry, Computer and Statistics and Dairy Economics. With the passage of time a number of infrastructure development have taken place in its own campus at Jagdeopath Patna.

ACADEMIC STATUS

With the view of supply of trained graduates in Dairy Industry, the Government of Bihar sanctioned twenty five seats for admission of students earlier in BSc Dairy Technology courses. It has been upgraded since 2008 to B. Tech. Dairy technology course under ICAR IVth Dean's Committee syllabus. The Hands on Training and Experiential Learning programme in seventh semester and In-plant Training in eighth semester have been incorporated in the syllabus to make students highly professional and practical for absorption in the industry. Later on since 2016 the syllabus is further upgraded by ICAR Vth the Dean's Committee in which Student READY Programme is included in the semester breaks apart from hands on training and experiential learning programme and in-plant training programme.

ACADEMIC RULES

Bachelor of Technology (Dairy technology)

B. Tech (D.T.) is a four year Under-graduate Degree Course offered at SGIDT Patna. The course covers different aspects of milk production, milk processing, quality control and managing dairy plant operations as per recommendations of Indian Council of Agricultural Research (ICAR).

Eligibility: Higher Secondary / Intermediate/ 10+2 or equivalent examination from any recognized Board or Council with Physics, Chemistry and Mathematics or Physics, Chemistry, Mathematics and Biology. Candidate will have to qualify the Bihar Combined Entrance Competitive Examination (BCECE) conducted by BCECE Board, Patna Bihar.

ELIGIBILITY REQUIREMENT

(a) Candidates belong to general category should possess at least 60% marks in aggregate or OGPA of 6.0/10.0 and in the case of BC/EBC/SC/ST 55% marks in aggregate or 5.5/10.0

OGPA in Bachelor's Degree.

- (b) The candidate who is appearing in the final Examination for Bachelors' Degree Programme is also eligible to apply provisionally for admission with Score Card. However he/she must have final result with required OGPA, Provisional Degree Certificate and Transcript on or before the date of counselling.
- (c) Admission to Master's Degree Program is open for Domiciles of Bihar only.

SELECTION CRITERIA

- (a) Selection will be made on the basis of Score obtained by the candidate in ICAR All India Entrance Examination ((PG)-2020). The candidates will have to opt the subject at the time of counselling based on seat availability and reservation policy of Bihar Government.
- (b) Merit list shall be prepared among the candidates applied to get admitted in to Degree Programs.
- (c) Cut off marks is 40% for SC/ST candidates and 45% for all other categories in the merit list of the ICAR Competitive Entrance Exam.
- (d) In case of tie, the marks at Bachelor's Degree level examination will form the criteria of selection. If performance at the degree level is equal then their age would determine the priority.

LABORATORIES

The institute has a central fine instrument laboratory and six other well equipped laboratories where students perform the practical and research.

CLASS ROOMS

The institute has air conditioned classrooms with audio visual presentation equipment and modern facilities. A new lecture theatre complex is under construction that shall be having one large hall on ground floor of 175 seats that may be utilized as auditorium as well as for organizing seminars, meetings etc. Two 48 seated lecture halls on first floor having all modern Audio Visual (AV) facilities and acoustics are also coming up. Engineering drawing laboratory, workshop laboratory, electrical technology laboratory, fluid mechanics laboratory and Instrumentation engineering laboratory will be

extended in coming up new building of Dairy Engineering department apart from the existing dairy and food process engineering laboratory.

LIBRARY

The Existing library of SGIDT Patna provides facilities to support research teaching learning and scholarly communication across various disciplines. The library has aimed to become the informational hub for the students and the staff of the college to access national and international journals, periodicals, textbooks and reference books to the students for their course work and research through CeRA. The library has a good collection of text books, reference books, few journals, project reports and internet facility for reference purpose. Besides this, there is a central university library of Bihar Animal Sciences University at Bihar Veterinary College Campus Patna having good number of books on all the subjects, journals, periodicals, internet facility and CD – ROM reference databases to cater the need of students as and when required.




MODEL DAIRY PLANT

ICAR and Govt. of Bihar funded Experiential Dairy Plant (10000 lts/day capacity) with facilities for processing product development quality analysis and packaging of milk and milk products which is under construction.

COMPUTER LABORATORY

The institute has a well-equipped computer centre and is connected through Local Area Network (LAN) for access to internet. Staff rooms and various laboratories have also been provided with internet connection through LAN. The faculties students and staffs use this laboratory for training/ teaching computation report preparation and surfing the net for academic activities. Most of the faculties of the institute have been connected with the local area network (LAN) of the institute to have broadband internet access and other services at their desktop. One new Computer language laboratory has come up in the institute.



LANGUAGE LAB

A Language Lab is established in the institute for improving the communication skills of the students. A full batch of 25 students can practice different exercises under the supervision of a language teacher. The language software has already been procured. The process of procurement of computers is underway and very soon the language lab will become operational.

STUDENTS HOSTEL

Adequate hostel facility is available for both boys and girls UG and PG students. The hostel inmates are provided with Volleyball and Badminton courts RO drinking water in-house mess and common room.

INTERNET FACILITY

The institute has access to internet facility through BSNL broad band as well as Wi-fi network provided by the Railtel.

EXTENSION ACTIVITIES

Transfer of technology being one of the mandates of the institute it is actively engaged in dissemination of existing as well as developed technologies to the farmers for their upliftment and economic growth. The institute has also been extending consultancy services on the informal basis to dairy entrepreneurs in the state and has been instrumental in encouraging investment in fresh proposals and in up gradation of existing processing facilities in the dairy sector.

The institute has plan to set up a consultancy service cell to render these services on formal basis. Participation in extension programmes in adopted villages Krishi Mela Agricultural Exhibitions TV and Radio interviews are a routine affair of the scientists in the institute.



The village Parsa has been adopted by the institute under the scheme 'Mera Gaon Mera Gaurav'. Two teams consisting of scientists of the institute have been constituted to pursue various activities and provide technical assistance and information to the farmers/ dairy farmers of the village.

BACHELOR OF FISHERIES SCIENCE (B.F.Sc)

B.F.Sc. is a 4-year full-time residential degree programme offered at College of Fisheries, Kishanganj. Fisheries science is the academic study of understanding and managing fisheries. It is a multidisciplinary science that draws on the study and investigation of fish production, fish health, fish processing, aquaculture and fishery resource management, fishing technology and management, fisheries environment and fisheries extension. The course aims to produce graduates capable to perform operation and maintenance of fish farms identifying fish diseases and work in allied areas.

Eligibility: Higher Secondary / Intermediate/ 10+2 or equivalent examination from any recognized Board or Council with Physics Chemistry and Biology. Candidate will have to qualify the Bihar Combined Entrance Competitive Examination (BCECE).

There is one Boys' and one Girls' hostel for the College of Fisheries with 100 rooms capacity each. The allotment of rooms will be made under the instruction of the DEAN, College of Fisheries on the basis of lottery system.

LABORATORY FACILITY

The College has well developed laboratory facility for conducting practical teaching to the students.

CONDUCT AND DISCIPLINE

The student should obey the rules and regulations of the University. Students are expected to maintain good relationship with the University Authorities, teachers and non-teaching staff of the University. It shall be presumed that guardians of the students have agreed that their wards shall comply with the rules and regulations of the University and behave politely with the authorities/Teachers/Staff of the University. Failure to comply with these rules students concerned will be liable for disciplinary action including expulsion of the student from the University. The decision of the University Authority in such cases shall be final and binding on students and their guardians.

The course curriculum and examinations procedure including fail/pass in different academic courses and year will be strictly adhered to as per guideline of ICAR in B.F.Sc. and Masters' degree courses.

EDUCATIONAL TOUR

The University organizes Educational tour Block Training In-Plant Training etc. for the students of the different faculties subject to the availability of fund from the State Government (for the purpose).

LIBRARY

There is a well-developed library in College of Fisheries Kishanganj campus.

FACILITIES AT UNIVERSITY LEVEL SCHOLARSHIP

- Bonafide students undergoing any of the Undergraduate Degree program belonging to the state
 of Bihar will be given a fellowship of Rs 2000.00 per month and Rs. 6000.00 per year as a
 contingency grant.
- M.V.Sc. and Ph.D. undergoing students will be given Rs. 2000.00 and Rs. 3000.00 per month as scholarship respectively.

ANTI RAGGING CELL

In pursuance of Supreme court judgment of 8.5.2009 and subsequent UGC guidelines notified for higher education institutions to curb the menace of ragging notified by Gazette notification on 4.7.2009 the University follows these regulations and subsequent guidelines issued on the matter in letter and spirit. The University has followed 'Zero-Tolerance' towards the menace of ragging. Much before the beginning of the academic session anti-ragging action plan is notified by the Deans and monitored on regular basis. The committees are constituted which involve the faculty members and a duty calendar is also notified each year.

UNIVERSITY LIBRARY

Bihar Animal Sciences University maintains a well-equipped central library at the university level with all the relevant reading material to cater the needs of the students, teachers and extension specialists of the university. The library also maintains internet services, e-journal access and CD-ROM facilities to its members. The library has a spacious and independent building spread over two floors. First Floor accommodates collection of Books for SC/ST Book Bank, Newspapers and paper back Volumes of the Periodicals. Second Floor accommodates Reference Books, Current Periodicals and so on. The library has large collection of books journals periodicals etc. Besides, CD ROM database have also been created and used by the P.G. students and research scholars for retrieval of reference pertaining to the research in the field of Veterinary and Animal Sciences, Dairy Technology and Fisheries Sciences. The internet facility has been created very recently. The library provides photocopies facilities on payment basis for copying documents. Online access of journals from CeRA, e-theses from Krishi Prabha, Open Access Journals BioOne ASM and CAB Abstract with full text are also available.

Sports and Recreation Facilities:

The University has a large playground for athletics Cricket Football and Volleyball court. The Boys and the Girls hostels of all the colleges have independent badminton and volley ball courts. All the hostels have table tennis chess and carom facilities for residents. The university also publish sports calendar for organizing different events at university level.



HOSTEL RULES

- Students are expected to maintain gross discipline and desired academic atmosphere in the hostel.
- All kinds of shouting hooting violent knocking or any other act likely to cause disturbance to inmates are strictly prohibited.
- Ragging of any type will be dealt with severity and may result in expulsion from the University.
- Maltreating or abusing the hostel employee is strictly prohibited.
- Leave for absence from the hostel for one or more nights must have the approval of hostel superintendent.

- Students absenting themselves from the hostel without prior sanction of leave by the hostel Superintendent is punishable.
- Night roll call will be undertaken by the hostel Prefect at 9:00 P.M. in winter and 10:00P.M. in summer and every boarder must present in his room at the time of roll call.
- After roll call no student is allowed to leave the hostel however, in case of emergency he must inform the hostel prefect/ Superintendent.
- Absence from the hostel for whole night without prior permission of the Superintendent will be
 considered as an act of gross indiscipline and misconduct and will call for punishment.
- Expulsion from the hostels will be done in case of continuous absence of boarders from the hostels without prior permission of hostel warden/ Chief Hostel Warden.
- Guests are not permitted to stay in hostel except in the case of father / brother provided that they
 come at an odd hour. The name and relationship of the guest so allowed to be entered in the
 hostel guest register.
- Lady guests are not permitted in any case to visit the room and stay in the Boy's Hostel.
- Boarders keeping guest without information and permission will be liable to punishment.
- No boarder is allowed to change his room without permission of the hostel superintendent.
- Light must be switched off when not in use.
- Students are advised to use LED bulb to save electricity.
- Boarders are warned against tampering electric appliances.
- Use of heaters electric rod iron geyser is strictly prohibited and punishable.
- Keeping Motor cycle/cycle in verandah corridor dining hall and common hall is prohibited.
- · Four wheelers are not allowed in the hostel.
- Students are expected to show a sense of responsibility in the maintenance of hedges lawns flowers and hostel landscape.

CURRICULA DELIVERY THROUGH IT (SMART CLASSROOM/INTERACTIVE BOARDS)

A facility to access free internet Wi-Fi has been created in the University campus by Govt. of Bihar. Besides this all lecture halls have a multimedia facility and interactive board with smart classroom facility. A Network Centre/ Data Centre have been established in the BASU to carried out all the computerized activities in Colleges/ BASU. 50 Mbps leased line have been installed through Railtel. The internet connectivity has been provided in all buildings. A computerized Payroll system have been developed recently by NIC for preparing salary bills and its payment online to officers and employees of all branch establishments of the

College / BASU. Biometric Machine has been installed in each Colletge / Units of the University to monitor the attendance regularly. Measures have been taken to implement the e-office and chanakya software developed by N.I.C. in all departments of the college/ BASU. First Part of Chanakya Software has been customized as per our requirement by NIC and customizations of other Modules are under process. The employees concerned with this work will also be provided proper training for operating this software/ application by the NIC. The details of books/documents at the College/ University Library have been entered in the KOHA Library Management software.

This LMS is open Source Software and useful for the computerization of library activities and services in the networked environment. This software contains various modules such as Administration Acquisition Cataloguing Circulation Serial control Article Indexing Budget Control OPAC (Online Public Access Catalogues) etc. Apart from this the dissertation submitted by students have been digitized and uploaded in the KrishiKosh Institutional Repository of NARS. CCTV have installed on all the floor of Central Library. Connectivity of CeRA facility are using by the Faculty and students of University.

NCC/NSS UNITS

NATIONAL CADET CORPS (NCC)

The National Cadet Corps (NCC) is the largest uniformed youth group in the world. Our University has started the NCC Army wing from academic year 2019-20. The NCC program is a voluntary program for the students. To implement this program an NCC Officer is designated by the NCC authority from amongst the faculty members. This has been inducted in the University with the aim to inculcate the Officer-like qualities in the students while making them understand the importance of discipline in the day to day life. Further it aims at creating a pool of organized trained and motivated youth with leadership qualities in all walks of life who will serve the Nation regardless of which career they choose.



NATIONAL SERVICE SCHEME (NSS)

NSS is offered to students during first two years of their programme to develop leadership qualities and motivate them for voluntary service to University.



CULTURAL CENTER

All the colleges has a mini auditorium meant for organizing the literary cultural and other events. Various events are conducted on yearly basis like fresher's day World Veterinary Day Milk day Oath-taking ceremony world zoonosis day world rabies day colleges foundation day Cultural nights Student farewell parties beside scheduled sports cultural and literary inter college competitions.



The faculties along with student representatives organize events on different occasion. The talent search starts from the first year of admission itself and students are groomed by senior students and faculty to represent colleges and university at various levels of youth festivals and meets.

On regular basis the tournaments at college levels are organized and a team of faculty postgraduate students and undergraduate students actively participate in the sports to encourage positive interaction and growth.

Time to time the speakers alumni and international speakers visits colleges and deliver talk and interact with students to motivate and shape their career.
