ONLINE PERSONAL INTERACTION CUM INTERVIEW FOR THE ENGAGEMENT OF GUEST FACULTY FOR THE COLLEGE OF FISHERIES, KISHANGANJ

Due to COVID-19 and under urgent situation for smooth functioning of academic programme in the College of Fisheries, Kishanganj applications are invited for **Online Personal Interaction cum Interview for engagement of Guest Faculty (Assistant Professor) in College of Fisheries, Kishanganj, Bihar Animal Sciences University, Patna Bihar** on contractual basis on a consolidated remuneration of Rs. 40,000/- (Rupees forty thousand only) per month. The university reserves the right to change the number of vacancy (ies) and also to withdraw partial or full notification without assigning any reason. Minimum eligibility is as per UGC guidelines (Qualification experience, publication desirable criteria are as approved by Academic Council) of BASU, Patna.

Application must be incorporated with relevant documents (not more than 10 pages) along with relevant caste certificate, (non- creamy layer certificate for candidates belonging to BC /EBC category only) and permanent residential certificate issued by C.O./Competent Authority, Bihar must reach by 08.10.2020 through e-mail to registrarbasu@gmail.com till 4.00 PM, along with NOC in case of in-service candidates.

Online Personal Interaction cum Interview will be conducted on 14.10.2020

The engagement of Guest Faculty is purely temporary and for a period of one semester (six months) or till regular appointment whichever is earlier. The period of engagement may be extended (if so, required by the university).

TERMS & CONDITIONS

1. Candidate registered for the Ph. D. Programme prior to July 11, 2009 shall submit a certificate in accordance with the UGC on minimum qualification for appointment of teachers and other academic staff in universities and colleges and measured for the maintenance of standards in higher education (3rd amendment) regulation, 2016.
 2. University reserves the right to cancel all /or any post without assigning any reason thereof.
 3. *Personal Interaction cum Interview will be conducted through virtual mode via Zoom on 14.10.2020.*
 4. The selected candidates will be engaged on purely temporary basis (on contract) for a period of one Semester / six months or till regular appointment whichever is earlier. Engagement may be terminated earlier with one-months' notice on either side, without assigning any reason. Under any circumstances, candidate cannot claim any right for permanent position.
 5. *Candidates may note that these contract positions are basically to meet the immediate academic requirement of the university and at no point selected candidates will have any claim for regular appointment to be made in future.*
 6. The prescribed qualifications and experience are minimum, and does not entitle candidate to be called for Personal Interaction cum Interview. If number of candidates is large, a minimum cut-off in academic score can be imposed or by any other condition that may deem fit.
 7. Addition/deletion/corrigendum (if any) in this advertisement shall be posted on the university website/notice board.
 8. The number of vacancies may increase or decrease as per the decision of the competent authority.
 9. The statutory provision for relaxing of age, experience, etc. prescribed in case of the candidate's belongings to state SC/ST/BC/EBC categories will be made applicable as per Govt. of Bihar norms.
 10. Candidates has to fill up the required information in **Undertaking** enclosed with advertisement and submit with Application.
 11. Canvassing in any form on behalf of any candidate will disqualify such candidate.

12. Selection will be made on the basis of candidate's previous record, their performance in the Personal Interaction cum Interview (wherever applicable).
 13. Experience and qualifications will be reckoned as on the last date of receipt of application.
 14. No interim queries regarding Personal Interaction cum Interview will be entertained.
 15. In case of any disputes/suits or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Patna, which is the Head Quarter of the University.
 16. Errors and omissions are subject to corrections.
 17. Applications received after the last date and without complete information will be summarily rejected.
 18. The University shall verify the antecedents or documents submitted by candidate at any time at the time of engagement or during the tenure of service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be terminated.
 19. In case any inadvertent mistake in the process of selection which may be detected at any stage even after issue of appointment letter, the University reserve the right to modify/ withdrawn/ cancel and communication made to the Candidates.
 20. Selected candidate should have to present all original documents along with one self-attested copy of each document at the time of joining for verification along with certificate of medical fitness issued by civil surgeon ranked medical officer or equivalent.
 21. The Selection Committee may decide its own method of evaluating the performance of the candidate.
