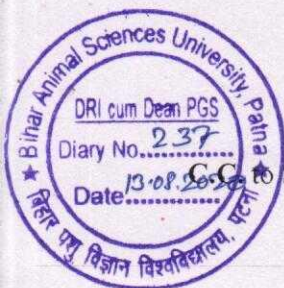

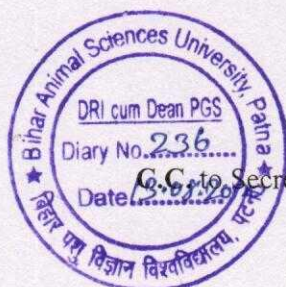



As per the decision taken in the 7th Academic Council of Bihar Animal Sciences University, Patna held on 25/06/2020 vide Agenda No. 11, criteria to be adopted for induction of faculties into the Post Graduate Faculty is mentioned hereunder:

a.	A faculty who desires to be recognized as post-graduate faculty for P.G. teaching and research will apply at appropriate time to the DRI-cum-Dean of Post Graduate Studies.
b.	All faculties holding Ph.D. degree shall be recognized as post graduate teacher/ faculty.
c.	The Assistant Professor holding Master's degree and having not less than two years of experience of teaching /research as well as two research publication in Peer Reviewed Journal will be eligible to become PG Faculty and those who have published three research papers in recognized research journals (NAAS \geq 4.0) will become eligible for guiding P.G. research.
d.	Recognition for Ph.D. guide may only be given to a teacher holding Doctorate Degree and who has successfully guided at least two candidates for Master's degree in the concerned faculty or should be a Professor/Associate Professor.
e.	The DRI-cum-Dean of Post graduate studies shall grant recognition on the recommendation of the Chairman/ HoD and Dean of the concerned faculty in all cases where the academic attainment is in consonance with the prescribed standards.
f.	In the case of persons in respect of whom qualifications and experiences are not of prescribed standards as laid down in the regulations, they will be treated as special cases and final permission shall be taken from Hon'ble Vice Chancellor.

Nothing in these regulations shall affect the recognition of post graduate teachers already granted before the commencement of these regulations under the regulations then existing.

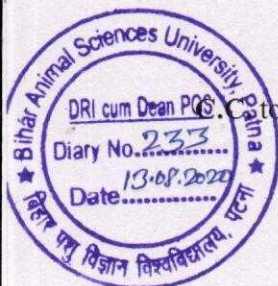

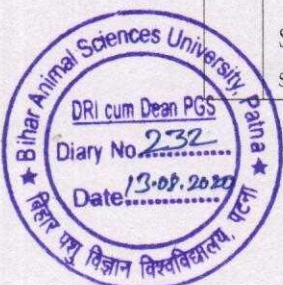

NOTIFICATION

As per the decision taken in the 7th Academic Council of Bihar Animal Sciences University, Patna held on 25/06/2020 vide Agenda No. 12, following revised rules are being adopted for allotment of Advisor to the students:

a.	Each student shall be allotted the Major Advisor for the thesis research work as per their rank/merit from the accredited P.G./Ph. D. Faculty.
b.	In every academic year, the Chairman/Head of Department (HoD) will maintain seniority lists of eligible faculty members as on 30th June of every year for guiding Master's and Doctoral students. The seniority list will be provided by the Chairman/HoD to the University (DRI-cum-Dean PGS) by 15th July of every year for allotting guide to the P.G. students. The Chairman/HoD of the concerned department, in consultation with faculty members, will prepare the list of total number of guides equal to the total number of Master's and Doctoral students. Firstly, allotment of guides will be made to Doctoral students and after that to Master's students admitted in an academic year. Allotment of guide and place of work will be made as per the choice and rank of the student.
c.	In case any faculty member has already in hand two or more Doctoral and Master's students together at any time on 30th June of every year, his/her name will not be included in the list for allotting the student. In an academic year, one student shall be allotted to a guide and maximum number students, including previous years students under his guidance, shall not exceed two in all for Doctoral and Master's together at any time.
d.	However, only in a particular discipline where there is shortage of faculty, they can be considered and also be given more than one student to a particular faculty member in the same academic year which shall be recommended by the Committee giving justification & submit the same to the DRI-cum-Dean PGS for approval. The Committee for allotment of P.G. students will be approved by the DRI-cum-Dean PGS.
e.	For Guiding Ph.D. Students, faculty members eligible for guiding doctoral students shall be considered first for guiding doctoral students as per the choice and rank of the PhD students. The students will have the choice in the allotment of advisor/guide amongst available eligible faculty members. The Committee will recommend the advisors for the doctoral students on the basis of seniority from the eligible faculty members as per the rank and preference of choice of the students.
f.	For eligibility to guide doctoral student, the faculty member holding a Ph.D. degree should satisfy the following condition(s):- a. Should have guided at least two Master's students OR Should be a Professor/Associate Professor with a minimum 10 research publications and that should be in journals with NAAS rating of more than 5.0.

g.	<p>For Guiding Master's Students:</p> <p>After completing the Ph.D. allotment, the Master's students will have the choice in the allotment of advisor amongst equal number of available eligible faculty members (in cyclic order). The Committee will recommend the Advisors for the Master's students as per the rank and preference of choice of the students. The Committee shall give preference to the faculty members, who have not been allotted any student, while nominating the advisor to students for Master's degree program.</p> <p>For eligibility to guide Master's Scholar:</p> <p>a. At least two years of UG Teaching</p> <p>b. Published 3 Research paper in Journals with NAAS rating of more than 4.0</p>
h.	The names of members of the faculty from major discipline will be arranged in the order of their respective seniority in the faculty.
i.	Faculty members who are due for retirement within next 2 and 3 years from the date of admission cannot be considered for allotting Master's and Doctoral students, respectively.
j.	<p>Likewise, in case any Advisor retires or quits the institute for any reason, the second senior most member of major discipline in the concerned student's Advisory Committee will act as Advisor in place of the outgoing faculty.</p> <p>The student of Master's/Doctoral degree programme who drops the study either on Temporary Dropping or any other reason, will not be counted while reckoning the number of students already in position with a faculty member at the time of allotment of guide (i.e. first day of academic year).</p>

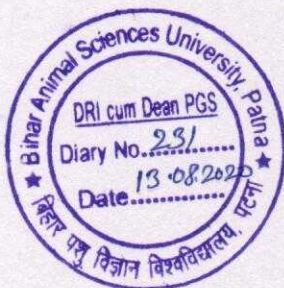

Meeting started with welcome address by Dr. Sanjay Kumar, Member Secretary.

Opening Remarks by Prof. Veer Singh, Chairman Post Graduate Board of Studies

I am thankful to Hon'ble Vice Chancellor, BASU and state Government of Bihar for shouldering the responsibilities. I assure utmost co-operation and strain every nerve and sinew to attain set targets. Imparting good skills which are applicable under field conditions is very important.

In the light of 19th livestock census 2020, Bihar has made significant growth in livestock population by 10.67 per cent. Among all the livestock, cattle and goat population increased by 25.18 and 5.49 per cent, respectively. Importance of this information further increases if we see under the consideration that most of farmers (91%) in Bihar has marginal farm holding and dependent on livestock rearing for their livelihood sustenance. Beside this low productivity of the livestock in Bihar is also a severe constraint for rural development (NITI Ayog, 2015). For increasing livestock productivity shortage of infrastructural facilities for livestock development in the state is also a well-known fact.

We have many expert teachers, well trained in P G education and research. Also, University has spending huge amount of money for their maintenance and development. As University has sufficient infrastructural facility and resource persons, to produce enough number of under graduates and post graduates, to cater the need of the state in term of shortage of skilled man power.

We have to self-analyse in term of our contributions to the university, whether we succeed to exploit the infrastructural facilities and resources of the university to produce enough no. of skilled man power, which will not only able to face their carrier-oriented challenges, successfully but also contribute to improvement of livelihood of the livestock farmers in the state.

So, we need to develop a vibrant Post-Graduation system in the university to keep need based research activities in functional mode and to produce competent graduates and post graduates on regular basis.

In the end, I wish to academic benchmark for PG program in BASU and require cooperation from all the Deans, faculties, Staffs, administration and students.

Agenda Item No. 5.6:

Sub. : Accreditation / Recognition of Teacher as P G and Ph. D. Teacher

As, Post Graduate teaching and research is very important activity for upliftment of University. It is very vital to upgrade quality teacher for P.G. / Ph. D teaching and research. Therefore, proposal/Criteria is being placed before PG Board of Studies for approval and committee members discussed the agenda.

Criteria:

- a. A teacher who desires to be recognized as post graduate teacher for P.G. Teaching and research will apply at appropriate time to the DRI-cum-Dean of Post Graduate Studies.
- b. All teachers holding Ph.D. degree shall be recognized as post graduate teachers.
- c. All teachers of the rank of at least Assistant Professors holding Master's degree and having not less than two years experience of teaching /research will be recognized for post graduate teaching, only and who has published three research papers in recognized research journals (NAAS \geq 4.0) will be recognized for guiding P.G. research.
- d. Recognition for Ph.D. guide may only be given to a teacher holding Doctorate Degree and who has successfully guided at least two candidates for Master's degree in the concerned faculty or should be a Professor/Associate Professor with a minimum 10 research publications and that should be in journals with NAAS rating more than 5.0.
- e. *The DRI-cum-Dean of Post graduate studies shall grant recognition on the recommendation of the Chairman/ HOD and Dean of the concerned faculty in all cases where the academic attainment is in consonance with the prescribed standards.
- f. In the cases of persons in respect of whom qualification and experience is not of prescribed, standards as laid down in regulations, such cases need to be treated as special cases and finally permission will be taken from Hon'ble Vice Chancellor.
- g. Nothing in these regulations shall affect the recognition of post graduate teachers already granted before the commencement of these regulations under the regulations then existing.

Agenda Item No. 5.7:

Sub.: Approval of Comprehensive rules of Allotment of Advisor

Keeping in view the importance and issues arises time to time, there is need to make clear cut rules for allotment of advisor. Therefore, proposal for approval is being placed before PG Board of Studies and committee members approved the agenda.

Rules of Allotment of Advisor: -

- i. Each student shall be allotted the Major Advisor for the thesis research work as per their rank/merit from the accredited P.G/Ph. D. faculty.
- ii. Every academic year the Chairman/Head of Department (HOD) will maintain seniority lists of eligible faculty members as on 30th June of every year for guiding Master's and Doctoral students. The seniority list will be provided by the Chairman/HOD to the University (DRI-cum-Dean PGS) by 15th July of every year for allotting the P.G. students. On the basis of the faculty list supplied by the Chairman/HODs, the Committee constituted for the purpose will make the lists of eligible guides, equal to the total number of Master's and Doctoral students separately (first for Doctoral allotment and after that Master's allotment) admitted in an academic year and allotted the student and their place of work as per choice and rank of the student.
- ii. In case any faculty member has already in hand two or more Doctoral and Master's students together at any time on 30th June of every year, his/her name will not be included in the list for allotting the student. One student shall be allotted in an academic year to a guide and maximum number including previous years students under guidance, shall not exceed two in all for Doctoral and Master's together at any time.
- iii. However, only in a particular disciplines where there is shortage of faculty, they can be considered and also they can be given more than one student to a particular faculty member in the same academic year which shall be recommended by the Committee giving justification & submit the same to the DRI-cum-Dean PGS for approval. The Committee for allotment of P.G. students will be approved by the DRI-cum-Dean PGS.
- iv. For Guiding Ph.D. Students, faculty members eligible for guiding doctoral students shall be considered first for guiding doctoral students as per the choice and rank of the PhD students. The students will have the choice in the allotment of advisor amongst available eligible faculty members. The Committee will recommend the advisors for the doctoral students on the basis of seniority from the eligible faculty members as per the rank and preference of choice of the students.

- v. For eligibility to guide doctoral scholar, the faculty member holding a Ph.D. degree should satisfy the following condition(s):-

a. Should have guided at least two Master's students

OR

b. Should be a Professor/Associate Professor with a minimum 10 research publications and that should be in journals with NAAS rating of more than 5.0.

- vi. For Guiding Master's Students:

After completing the Ph.D. allotment, the Master's students will have the choice in the allotment of advisor amongst equal number of available eligible faculty members (in cyclic order). The Committee will recommend the Advisors for the Master's students as per the rank and preference of choice of the students. The Committee shall give preference to the faculty members, who have not been allotted any student, while nominating the advisor to students for Master's degree program.

For eligibility to guide Master's Scholar

a. At least two years of U.G. Teaching

b. Published 3 Research paper in Journals with NAAS rating of more than 4.0

- vii. The names of members of the faculty from major discipline will be arranged in the order of their respective seniority in the faculty.
- viii. Faculty members who are due for retirement within next 2 and 3 years from the date of admission cannot be considered for allotting Master's and Doctoral students, respectively.
- ix. Likewise, in case, any Advisor retires or quits the institute for any reason, or any other reason, the Guide at later stage, the second senior most member of major discipline in the concerned student's advisory committee will act as Advisor in place of the outgoing.
- x. The student of Master's/Doctoral degree programmes who drops the study either on Temporary Dropping or any other reason, will not be counted while reckoning the number of students already in position with a faculty member at the time of allotment of guide (i.e. first day of academic year).

Sub.: Completion of Ph.D. degree programme for faculty of BASU, Patna under Institutes signed MoU with Bihar Animal Sciences University, Patna


