At the outset, Dr. Pankaj Kumar Singh, Member Secretary welcomed Prof. Veer Singh, DRI-cum-Dean PGS, and Chairman and all members to the 6th PG Board of Studies meeting.

The Chairman welcomed all Directors, Deans, Chairman/ Head of departments and faculty members. He expressed his satisfaction with appreciation to faculty members for their dedication and enthusiasm towards the virtual mode of teaching. He also expressed his thanks for uploading the teaching materials of post graduates studies over the BASU website. He informed the house that the new academic semester will start from 11th Jan, 2021.

Thereafter, Hon'ble Chairman invited member secretary Dr. Pankaj Kumar Singh to present the agenda. Following agenda were presented for approval before PG Board of Studies:

Agenda 6.1 : Confirmation of proceeding of 5th meeting of Board of Post Graduate Studies held on 8th May 2020.

Agenda 6.2: Approval of Guidelines for the Preparation of Synopsis and Thesis / Dissertation for Post Graduate.

The Agenda was thoroughly discussed, and valuable suggestions were received from DR, BASU, Dean, BVC Patna, DSW, BASU and other members.

DR, BASU suggested that the research should be undertaken from the priority area of the concerned department and the Bihar state.

Dean, BVC suggested that a paragraph for research gap should be incorporated in Introduction section of synopsis and thesis. He also suggested that the printing of the thesis should be on both sides to save wastage of papers. Also, the results and discussion part in the thesis should be presented together in one section not separately. In the references/ bibliography section, full name of the journal should be used.

DSW, BASU suggested that detail of high school/higher secondary should be removed from proforma of submission of programme of work for post graduate students (PG form-I).

Agenda 6.3: Adoption of ICAR syllabi of different departments of Post-Graduate studies at SGIDT, Patna

After thorough discussion the members unanimously approved the syllabus for Master degree program (M.Tech.) of (i). Dairy Technology (ii). Dairy Microbiology (iii). Dairy Chemistry in Sanjay Gandhi Institute of Dairy Technology, Patna as per ICAR syllabi.

HOD, Dairy Engineering, SGIDT asked about the minor courses. It was suggested that minor courses should be offered as per ICAR- BSMA guidelines. HOD, Dairy Technology, SGIDT suggested changes in credit hours and course content of some courses as practised at NDRI, Karnal. It was also decided to adopt the ICAR syllabi for M.Tech. programme in Dairy Technology *in toto*.

Agenda 6.4: Inclusion of PG Course LPM-614 (Fodder Production and Conservation) in addition with courses of PG approved by ICAR

HoD, LPM informed the members that PG course LPM-614 (Fodder production and conservation) of 2 (1+1) credit hours of is being offered to the PG students as per approval of PG Board of studies and Academic Council, RAU, Pusa in 2010-11. However, document of the said approval is not available in the office of the Registrar, BASU, Patna. So, in order to facilitate issuance of transcript to the students, this course LPM-614 may be approved through PG Board of Studies of BASU, Patna for the welfare of students.

DR, BASU suggested that the syllabus is of more relevance to the Animal Nutrition and they should take the responsibility to offer the course.

It was decided by all the members that this course LPM-614 should be withdrawn from now onwards as this course is not there in ICAR PG syllabus for LPM. However, approval for course LPM-614 should be given to grant a degree to those students who had already taken this course earlier.

Agenda 6.5: Renaming of Department of Veterinary Physiology and Biochemistry to Department of Veterinary Biochemistry and Department of Veterinary Physiology separately.

After thorough discussion, it was decided that the name of Department of Veterinary Physiology and Biochemistry should be changed to Department of Veterinary Biochemistry and Department of Veterinary Physiology separately to avoid confusion at post graduate level.

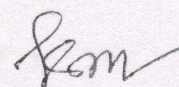
Agenda 6.6: Any other Agenda with the permission of the Chair
