





These amendments will be effective w.e.f. from 23.09.2017.

<i>Existing Regulation as per Resident Instruction for Bachelor's Degree Program, 2013 of BAU, Sabour</i>	<i>Proposed Amendments</i>
3.5 Class Attendance Requirement	No change
3.5.1 Each instructor shall maintain a record of the student's attendance in each course taught by him/her in each semester.	No change
3.5.2 Each student shall be regular in attending classes and shall be required to have a minimum of 85% attendance in each course in each semester, unless otherwise condoned by Dean/ Assoc. Dean cum Principal of the concerned college, up to the limit of 75% failing which, he/she shall not be eligible to appear in semester final examination and will be declared "fail" in the course. To such courses, "F" grade shall be awarded.	Each student shall be regular in attending classes and shall be required to have a minimum of 85% attendance in each course in each professional year/ semester. Dean of the concerned college may allow to appear in the annual/ semester final examination up to the limit of 75% based on critical illness resulting in hospitalization/ natural or personal calamity. In case, the student fails to fulfill the requirement of attendance as above, he/she shall not be eligible to appear in annual/ semester final examination and will be declared "fail" in the course. To such courses, "F" grade shall be awarded.
3.5.3 The percentage of attendance of a student in a course in a semester shall be computed on the basis of the total number of classes (lectures and practical) and tutorials attended by him/her and those actually held between the date of commencement of instructions and the date of closing of instructions, irrespective of the date of registration/or the duration of leave granted to him/her provided that attendance in respect of the students representing the University in games and sports, debates etc. outside the campus shall be calculated after ignoring the period which they spent outside the campus on due authorization by the Dean/ Assoc. Dean cum Principal of the concerned colleges and Director, Student Welfare (DSW) subject to the condition that such authorized absence should normally not exceed 7 days in a semester and further that no condonation even under this clause shall be allowed below 75%.	The percentage of attendance of a student in a course in a semester/ professional year shall be computed on the basis of the total number of classes (lectures and practical) and tutorials attended by him/her and those actually held between the date of commencement of instructions and the date of closing of instructions, from the date of registration/or the duration of leave granted to him/her provided that attendance in respect of the students representing the University in games and sports, debates etc. outside the campus shall be calculated after ignoring the period which they spent outside the campus on due authorization by the Dean of the concerned colleges and Director, Student Welfare (DSW) subject to the condition that such authorized absence should normally not exceed 7 days in a semester/20 days in a professional year and further that no condonation even under this clause shall be allowed below 75%.

3.5.4	The Dean/Assoc. Dean cum Principal of the college concerned, on the recommendation to Instructor / Advisor shall condon shortage in attendance up to 10% in a course(s) in exceptional circumstances and allow student with an attendance of 75% or more to appear at the semester final examination of the concerned course. 3.5.5	The students should get the shortage in attendance of the course(s) condoned before the start of semester/final examination.	The students should get the shortage in attendance of the course(s) condoned before the start of annual/ semester final examination.
3.6	Students Continuance on Roll and Promotion to Higher Semester	Students Continuance on Roll and Promotion to Higher Professional Year/Semester
3.6.1	The student shall cease to be the student of this University :-	No change
3.6.2	If he/she has unauthorized absence continuously for a period of 30 days or more in any of the course(s). Consequently, the name of such student shall be struck off from the roll of the University. The course Instructor shall report such cases to the Dean/Associate Dean-cum-Principal of the college concerned who will forward the case to the Registrar with his/her recommendations.	If he/she has unauthorized absence for more than 50% of the total number of classes (theory and practical) in 30 days period from the date of commencement of instruction. Further the student will have to maintain not less than 50% attendance throughout the Professional Year/Semester. The course Instructor shall report such cases to the Dean of the college concerned who will forward the case to the Registrar for dropping the name of such student from the roll of the University. In case, the attendance is less than 85% in classes in 30 days, warning will be issued to the student advising him/ her to improve the attendance.
3.6.3	If he/she has successfully completed the degree program to which he/she was admitted.	No change
3.6.4	After the completion of four additional semesters in addition to the normal residential requirement prescribed for a particular degree program.	After the completion of four additional semesters in addition to the normal residential requirement prescribed for a particular degree program. However, for students pursuing B.V.Sc. & A.H. program the maximum period allowed to remain on the roll will be nine years & six months excluding the internship as per VCI guidelines. The B.V.Sc. & A.H. students admitted in the years 2015 or earlier in semester system, the maximum period allowed will be eight years or 16 semesters excluding the internship as per VCI guidelines.
3.6.5	The student shall be permitted to drop/withdraw from the University temporarily provided he/she has completed at least one semester of study in this University on the ground of self serious illness due to infectious diseases or accident followed by hospitalization in Govt. hospital and supported by valid medical certificate. In such cases, re-admission shall be permitted by the Dean of the college concerned within two years from the date of student was permitted to drop from the university roll temporarily. In all such cases, admission shall be permitted only in the semester in which the student was permitted to drop. However, if a student is regular in attendance and internal examinations during first	The student shall be permitted to drop/withdraw from the University temporarily provided he/she has completed at least one professional year/semester of study in this University or completed all his/her attendance requirement in the professional year/semester on the ground of severe illness or accident followed by hospitalization and supported by valid medical certificate. The maximum permission will be restricted to one professional year/two semesters only. After recovery from illness, the student shall be permitted to register in the same professional year/ semester with the junior batch provided he/she submits a valid medical certificate for his/her treatment and hospitalization.

3.6.6 It is obligatory on the part of all the registered student of this university to pass the course requirement of a degree program.	No change
3.6.7 The student of the university if failed in more than two courses shall not be permitted to appear for compartmental examination and he/she shall have to repeat the failed courses with junior batches.	The students of B.V.Sc. & A.H. if failed in more than two courses shall not be permitted to appear for compartmental examination and he/she shall be retained in the same professional year with junior batches. A student may be allowed to provisionally sit in the next class provided he/she has failed in not more than two subjects and cannot be promoted to next class/ professional year unless he/she has cleared the failed subject (s) through compartmental examination.
3.6.8 All the Students who have appeared in the internal as well as external examinations and declared pass shall be promoted to the next semester. However, the students who have failed in one or more course shall be promoted to next semester but such students shall have to repeat the failed courses along with the junior batches whenever, those courses are offered.
