For appointment on the posts of teachers/scientist in Agriculture,
Veterinary, Ag. Engg., Dairy Technology, Fisheries and Home Science related subject, it would be a basic requirement for the candidate applying
for the posts to hold/possess respective basic professional degree at the
Under-graduate level.

Existing provision in statute of Bihar Agricultural University, Sabour

at Chapter-XIII, Clause 13.1, Note No. 10

Note: - Professional Degree means; B.Sc.(Agriculture)/B.V.Sc. & A.H./B.Tech(Ag. Engg.)/ B.Tech (DT)/B.Sc. (DT) or equivalent/ B.F.Sc./ B.Sc. (Home Science) and Pure Science for Basic Sciences subjects.

Proposed provision for Bihar Animal Sciences University, Patna

This clause is being dropped

Note:- For the appointment of teachers / scientist of Veterinary Faculty guidelines of Veterinal Council of India will applicable

NOTIFICATION

In pursuance of the decision taken in 6th Academic Council Meeting held on 03.01.2020 vide Agenda Item No. 03 and on subsequent approval of Board of Management on 04.01.2020, the criteria to be adopted by Bihar Animal Sciences University, Patna in the disbursement of stipend of Rs. 2000/- per month along with additional annual contingency of Rs. 6000/- per year to Under Graduate students pursuing courses in Agriculture, Dairy, Animal Husbandry and Fisheries are fixed here under:-

- a) He / She should pass and must obtain at least GPA of 5.0
- b) He / She should have attendance of at least 75% in all courses in a Semester in case of B. Tech (D.T) & B.F.Sc.
- c) He / She should have attendance of at least 75% in all courses during last six months of class attendance, in case of B.V.Sc. & A.H.
- d) The stipend/Scholarship will be disbursed on half yearly basis.
- e) Stipend will not be given to students who are on academic or conduct probation.
- f) The stipend/Scholarship will not be given to students beyond 8 semesters to B.Tech (D.T.) and B.F.Sc. students and $4\frac{1}{2}$ years in case of B.V.Sc. & A.H students.
