After detailed deliberation, following decisions were taken unanimously in the 3<sup>rd</sup> Meeting of Resident Instruction Committee:-

**AGENDA 3.1: Resolution on Academic Regulations for B.F.Sc. & B.Tech. (D.T.)**

**Details:** Dean, COF alongwith O/C Academic, COF presented the agenda in detail. Several suggestions were made by the Committee members and after thorough discussion, DRI-cum-Dean, PGS and the Chairman suggested that a Committee headed by DSW be constituted in which Deans of both the Colleges *i.e.* SGIDT and COF be members along with their O/C Academics and Asstt. Registrar (Academic) and Asstt. Registrar (Exam) be members. Dr. A.K. Jha, Asstt. Professor, SGIDT be incorporated as a special member. Asstt. Registrar (Exam.) should act as Member Secretary. The Committee should submit its finalized Academic Regulations for B.F.Sc. & B.Tech. (D.T.) within two weeks to the Chairman of the RIC so that the same may be recommended for discussion in the Academic Council of the University.

**Decision:** *All members unanimously agreed to the proposal and decided that the new Committee will submit its finalized report within two weeks.*
