Eligibility Criteria for admission in M.V.Sc. Degree Programme:

- A candidate should possess at least 60% marks in aggregate or OGPA of **6.0/10.0** in Bachelor's Degree and in case of SC/ST, 55% marks in aggregate or 5.5/10.0 OGPA.
- In-service candidates sponsored from other government Organizations/Institutions may not be required to appear in the Competitive test for seeking admission.
- A candidate who is undergoing internship programme of Bachelors' Degree is also eligible to apply provisionally for admission. However, he/she must have to produce final result with required OGPA, Provisional Degree Certificate and Transcript on or before **the date of 1st counselling**.
- Candidate should have qualified the ICAR-AIEEA (PG) examination 2021 conducted by ICAR.
- Admission to Master Degree Programme is open to **Domicile of Bihar only**.

Admission Procedure:

- Selection of candidate will be made on the basis of ICAR-AIEEA (PG) 2021 score in order of merit. The candidates will have to opt the subject at the time of counselling based on availability of seats in the concerned subject following the reservation policy of Government of Bihar.
- Merit list shall be prepared amongst the candidates who will submit the application for admission in BASU, Patna.
- In case of a tie of score of ICAR-AIEEA (PG) examination 2021, performance at Bachelor's Degree level examination will form the criteria. If performance at the degree level is also equal, then seniority in the age would determine the priority.

Eligibility Criteria for admission in Ph.D. Degree Programme:

- A candidate should possess at least 70% marks in aggregate or 7.0/10.0 in Master's Degree Programme and in case of SC/ST, 65% marks in aggregate or 6.5/10.00 OGPA.
- A Candidate who is appearing in the Master's Degree Examination may also apply provisionally with score card for admission. However, he/she must have to produce final result with required OGPA and Provisional Degree Certificate as well as Transcript on or before the date of 1st counselling.

- c. A candidate can apply for admission to only one subject. No change would be allowed, thereafter.
- d. Admission to Ph.D Programme is open for the candidates having **Domicile of Bihar only**.

Admission Procedure:

Selection of candidates will be made on the basis of ICAR AICE- JRF/SRF (Ph.D.) -2021 score in order of merit in the concerned subject following the reservation policy of Government of Bihar.

- Selection will be made on the basis of merit list based on the scores of candidates in ICAR-AICE- JRF/SRF (Ph.D)-2021.
- Merit list shall be prepared for the candidates who will submit the application for admission in BASU, Patna.
- In case of a tie of Marks, performance at Post Graduate level examination will form the criteria. If performance at Master's level is also equal, then seniority in the age would determine the priority.

Eligibility Criteria for admission in M.Tech. Degree Programme:

- Candidates belong to general category should possess at least 60% marks in aggregate or OGPA of 6.0/10.0 in Bachelor's Degree and in case of SC/ST, 55% marks in aggregate or 5.5/10.0 OGPA.
- In-service candidates sponsored from other government Organizations/Institutions may not be required to appear in the Competitive test for seeking admission.
- The candidate who is appearing in the final Examination for Bachelors' Degree Programme is also eligible to apply provisionally for admission with Score Card. However he/she must have to produce final result with required OGPA, Provisional Degree Certificate and Transcript on or before **the date of 1st counselling**.
- Admission to Master's Degree Programme is open for **Domicile of Bihar only**.

Admission Procedure:

- Selection of candidate will be made on the basis of ICAR-AIEEA (PG) 2021 merit in order of merit. The candidates will have to opt the subject at the time of counselling based on availability of seats in the concerned subject following the reservation policy of Bihar Government.

- b. Merit list shall be prepared amongst the candidates who will submit the application for admission in BASU, Patna.
- c. In case of a tie of score of ICAR-AIEEA (PG) 2021, performance at Bachelor's Degree level examination will form the criteria. If performance at the degree level is also equal, then seniority in the age would determine the priority.

Note :

1. The University reserves the right to make addition or deletion in number of seats without any notice.
2. The category wise distribution of seats would be as per the reservation policy of Govt. of Bihar.

General instruction for reservation:

Rules regarding filling of vacant seats in reserved category shall be followed as per Govt. of Bihar Reservation Act No 16 of 2003 for admission in educational institution.

- A. Reserved category candidates who is selected on the basis of his/her merit, shall be counted against the vacancies in the open merit category and not against the reserved category vacancies.
- B. No reservation shall be made except reservation percentage granted by the concerned educational institute and amended reservation percentage granted from time to time for the candidates out of Bihar.
- C. If the reservation percentage of any reserved category is not filled, it shall be regulated as per the following rules of Bihar Act No. -16 of 2003:-
 - Exchange shall be possible between the Schedule Caste and Schedule Tribes.
 - Exchange shall be possible between the Extremely Backward Classes and Backward Classes.
 - After having complete the procedure contain above, if the reservation percentage of any reserved category is not exhausted then candidate belonging to unreserved category shall be admitted against such vacancy after duly declared as de-reserved for the said session by Administrative Department.
 - In case of non-availability of suitable candidates for the vacancy reserved for **women of Backward classes**, the vacancies shall be filled in order of preferences as follows:-
 - ❖ By the candidates of the Schedule Castes.
 - ❖ By the candidates of the Schedule Tribes.
 - ❖ By the candidates of the Extremely Backward Classes.
 - ❖ By the candidates of the Backward Classes.

4. Copy of score card ICAR-AIEEA (PG) 2021 / ICAR AICE- JRF/SRF (Ph.D.)-2021.
5. Certificate of Character from the Head of last Institution attended and also another one from a Gazetted Officer or a College or University teacher not related to the candidate, but intimately known to the candidate.
6. Certificate of Physical fitness from a Registered Medical Practitioner.
7. The candidates under reserved category, i.e. EWS, BC, EBC, WBC, SC, ST and Divyang shall attach the Caste certificate in the prescribed format issued by a competent authority in support of their claim without which their claim will not be considered.

For PWD/Divyang Candidates: Medical Certificate issued by the Civil Surgeon / Medical Board indicating the nature and extent (including percentage) of Physical Disability in support of their claim for admission against reserved quota for PwD.

7. 06 sets of recent passport size color photographs.

8. The candidates under reserved category, i.e. EWS, BC, EBC, WBC, SC, ST and Divyang shall produce the certificate in the prescribed format issued by a competent authority in support of their claim without which their claim will not be considered.

For EWS Candidates - The income and assets certificate in the prescribed format issued by -

- District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner / first class Stipendary Magistrate/ Sub Divisional Magistrate / Taluka Magistrate Executive Magistrate / Extra Assistant Commissioner.
- Chief Presidency Magistrate/Additional Presidency Magistrate/Presidency Magistrate.
- Revenue Officer not below the rank of Tehsildar and
- Sub Divisional Officer or the area where the candidate and/or his family normally resides.

For PwD/Divyang Candidates: Medical Certificate issued by the Civil Surgeon / Medical Board indicating the nature and extent (including percentage) of Physical Disability in support of their claim for admission against reserved quota for PwD.


- The candidates enjoying employed status and selected for admission to any programme of study in the University, are required to produce LEAVE SANCTION /RELIEVING ORDER AT THE TIME OF ADMISSION/REGISTRATION from their employer for the duration of the programme permitting them to pursue their studies at the University, failing which the offer of admission shall stand withdrawn. In case of any dispute the decision of the University shall be final.
- The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
- Any candidate failing to appear in the counselling shall not be considered for admission. No TA/DA is admissible for appearing in the counselling.

General Instructions:

- The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study; if it is found that the candidate has/had produced fake/forged certificate(s) /documents(s), indulged in any act of misconduct/indiscipline and has/had concealed any other relevant information at the time of seeking admission.
- The admission of the candidate to the concerned Course of Study shall be subject to such ordinances, rules and regulations as framed time to time by the University.
- The Category (UR/EWS/BC/EBC/WBC/SC/ST/PwD) declared by the candidate in application form will be final. No subsequent change will be allowed. Reservation of seats shall be given as per the Policy of the Government of Bihar.
- Only the Hon'ble High Court of Patna shall have the jurisdiction in case of any dispute relating to the provisional admission.
