**GENERAL INSTRUCTIONS & CONDITIONS FOR THE POST OF
PROFESSOR AND ASSOCIATE PROFESSOR, COLLEGE OF FISHERIES KISHANGANJ**

This is a rolling advertisement. Applications will be accepted throughout the year. The composite rolling advertisement will remain alive all the time and will be updated every time when a new vacancy is created or when the earlier advertised positions are filled up by selection. The prospective applicants, therefore, can apply anytime during the year, but the applications will be processed after the cut-off date indicated on the website.

- 1 The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle for his/her selection.
- 2 Applicants are requested to submit the desired certificates and page no. of the all documentary evidence should be mentioned in the application formats as and where required. Incomplete applications will liable to be **REJECTED**.
- 3 The University reserves the right to:
 - a) Withdraw any advertised post(s) at any time without giving any reason.
 - b) Fill or not to fill up some or all the posts advertised for any reason whatsoever
 - c) Increase/decrease the number of posts at the time of selection and make appointments accordingly.
 - d) **Alter / insert any corrections/additions / corrigendum/addendum in the advertisement/website in the event of any error / or otherwise before the last date prescribed for the receipt of applications shall be published only on the website of the University.**
 - e) After screening the applications, to restricts the number of candidates to be called for interviews will be done as per **O. O. No.- 27/Reg./Rect./BASU, Patna dated 05/05/2022.**
- 4 In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 5 Candidates are advised to check /visit the University website (<https://www.basu.org.in>) regularly for updates on the recruitment process.
- 6 Canvassing in any form on the part of the candidate shall lead to his / her disqualification.
- 7 No interim queries regarding test/interview/selection will be entertained.
- 8 The service conditions shall be as per University rules. New pension scheme will be applicable with subsequent amendments to fresh regular recruited person.
- 9 In case of any disputes/suites or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Patna.
- 10 The University shall verify the antecedents or documents submitted by a candidate at any time of selection procedure, at the time of appointment, or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be liable to be terminated forthwith and other legal action will be taken.
- 11 The person appointed shall be governed by the Act, Statutes, Rules, and Regulations of the University as framed and amended from time to time.
- 12 Persons appointed may be transferred to any equivalent post within the jurisdiction of the University.
- 13 The Chairman of the Selection Committee shall have the power to lay down the procedure in respect of any matter not mentioned above. The Selection Committee may decide its own method of evaluating the performance of the candidates in the interview.
- 14 Experience and qualifications will be reckoned as the last date for submission of applications.
- 15 Candidates have to fill score card and mention respective page number of relevant document; otherwise application shall be treated as incomplete and rejected. Selection will be made on the basis of candidates' previous record (as per relevant score card) and their performance in the interview.
- 16 Every page of the application form and enclosures must be serially numbered and signed by the candidate at the bottom of the page.
- 17 Selection will be made on the basis of candidates' previous record (as per relevant scorecard) and their performance in the interview.

- 18 The candidates will have to produce all the original certificates and documents at the time of interview for verification, failing which their candidature shall be liable to be rejected.
- 19 **Service Bond: -** Selected candidates will have to submit a bond on a non-judicial stamp paper of Rs. 1000/- at the time of joining the service to serve the University for at least three years. No application for outside employment shall be forwarded during the bond period of three years.

20 **Maximum Age Limit: -**

There is no age limit for the appointment on the post of **Associate Professor and Professor.**

21 **Submission of Application: -**

- i) Application along with self-attested relevant / desired documents and fees should reach “**The Registrar, Bihar Animal Sciences University, P.O: Bihar Veterinary College, Patna – 800014**” by speed post. The envelope should be superscripted “Application for the post of.....”
- ii) The in-service candidates should apply through the proper channel. An advance copy of the application form may be considered subject to production of NOC at the time of the interview, failing which their candidature is liable to be rejected.
- iii) Full text of research papers/publications need not be attached with the application, only the first page/ pages showing the necessary details of publication like- title, author (s), date/year/acceptance of publication, and name of journal/publication.
- iv) Candidates have to fill scorecard in the prescribed proforma and mention the respective page number of the relevant document; otherwise, the application shall be treated as incomplete and liable to be rejected.
- v) Applications received after the last date and without complete information or without requisite fees will be summarily rejected. The University will not be responsible for any postal delay.
- vi) For each post candidates have to submit separate application form along with application fee.
