3	Payment of wages after 21 <sup>st</sup> to 30 <sup>th</sup> day of the month.	Rs. 1,00,000/- will be deducted from the bill of the agency.
4	Delay in payment of wages beyond 30 <sup>th</sup> day of a month.	Termination of contract with forfeiture of performance guarantee and the award of contract will be made to 2 <sup>nd</sup> higher scorer bidder on the same rate..
5	The firm must submit the bill for re-imbursment within 10 days of making payment.	Delay beyond 10 days will be treated as non-compliance of terms & conditions.
6	Non-compliance of terms and conditions of contract or under payment of wages or other dues to the manpower including EPF and ESIC or issue of two warnings for delay in payment of wages..	Appropriate action may be taken by University including termination of contract. In case of persistent default, a suit may be instituted before Labour Commissioner under Contract Labour Act-1970 including blacklisting of the firm.
