Approved as per norms of UGC as indicated below – <i>For the purpose of calculating API Score all such periods of duration which have been spent by the teacher on different kinds of paid leaves such as Maternity Leave, Child Care Leave, Study Leave, Medical Leave, Extraordinary Leave and Deputation shall be excluded from the grading assessment. The teacher shall be assessed for the remaining period of duration and the same shall be extrapolated for the entire period of assessment to arrive at the grading of the teacher. The teacher on such leaves or deputation as mentioned above shall</i>

		<p>not be put to any disadvantage for promotion under CAS due to his/her absence from his/her teaching responsibilities subject to the condition that such leave/deputation was undertaken with the prior approval of the competent authority following all procedures laid down in these regulations and as per the acts, statutes and ordinances of the parent institution."</p> <p><u>For example:</u></p> <p>A. If the period of study leave – 03 years during promotion from stage I to II (AGP Rs. 6000 to Rs. 7000), in this case, the minimum cumulative score for eligibility will be calculated as under:- Assessment score = $75 \times (5-3)/5 = 30$ marks</p> <p>B. If the period of study leave availed - 03 years (2 years during promotion from stage I to II and 1 year during promotion from stage II to III), in this case, the minimum cumulative score for eligibility will be calculated as under:- (i) Assessment from stage I to II (AGP Rs. 6000 to Rs 7000) = $75 \times (5-2)/5 = 45$ marks (ii) Assessment from stage II to III (AGP Rs. 7000 to Rs 8000) = $75 \times (5-1)/5 = 60$ marks</p>
