Hiring of Agency for deployment of Manpower on Outsourcing Basis

In the light of the Important Notice bearing No. 990/Reg./BASU, Patna dated 07/10/2022 the representation from M/s GA Digital Web Word Pvt. Ltd and M/s National Protective Security Services were received, which was reviewed by the Committee. After review of the technical bid with reference to the submission made by the concerned agency the following observations has been found by the Committee:-

I. M/s GA Digital Web Word Pvt. Ltd.

1.	The agency has not submitted an affidavit duly corroborated by the executive magistrate as per eligibility criteria duly mentioned in clause 6.12 of the tender as well as S.No. 19 of the Technical Bid.	In our Technical Bid we have submitted an Affidavit at page no. 171 to 180 as per eligibility criteria duly mentioned in clause 6.12 of the tender as well as S. No. 19. We have visited the Hon'ble Executive Magistrate's Office in Delhi and requested them to verify the Affidavit and they rejected our request of verification of the same by saying that the verification for matter of blacklisting does not fall into jurisdiction and advised us for verify it from Notary Public Officer. Hence, we got the Affidavit Notarized from Notary Public Officer. Further, in the eyes of law, as the Affidavit is attested by any Notary Public Officer should be considered. And as Notary Public Officer has its power to verify/certify/authenticate/attest any document. Therefore it hereby requested to kindly consider the same, as whatever we mentioned into the Affidavit is True & Correct best of our knowledge and nothing has been concealed.	One of the mandatory eligibility criteria under Clause 6.12 of the Tender provides that "The sole proprietor or the Partners/Directors of the firm/company should not be involved in any Police Case and have never been punished by any Court of Law; and the agency should not have been blacklisted by any Government or Semi Government Department or any PSU or any other Organization or changed the name of the firm. Also, the agency should not have any statutory dues of Government of India and/or State Government". The Affidavit duly corroborated by the executive magistrate to this effect had to be submitted by the agency. But the agency has failed to comply the same.

2.	The agency has submitted the character certificate which is not valid in as much as the certificate has neither issued on the official pad of the competent authority nor having official issue/letter/certificate number.	We have enclosed herewith a valid Character Certificate issued by Hon'ble Assistant Commissioner of Police, Economic Offences Wing: Delhi as page no. 21 in our Technical Bid, which is valid and can be verified from the Department. It is upto the department how they issue any Character Certificate, we cannot force them to issue the same on their letterhead with reference number. They have imposed their physical stamp on the certificate which is true copy of the original certificate and should not be rejected.	The submission of the agency is not tenable in as much as the submitted Character Certificate does neither have any official issue/letter/certificate number nor in official pad/proforma rather it is just like a testimonial.



The agency has not provided certified copy of minimum 500 manpower (other than security) on its payroll as per eligibility criteria duly mentioned in clause 6.11 of the tender as well as S.No. 18 of the Technical Bid.	More than 500 manpower (other than security) registered under the Contract Labour (Regulation and Abolition) Act 1970/971 is enclosed in our tender at page no. 238 to 261.	One of the mandatory eligibility criteria under Clause 6.11 of the Tender contains that "Agency must have minimum 500 manpower (other than security services) on its pay-roll duly certified by the concerned Govt. Dept. / Universities /Constituent Colleges / Govt. Educational Institutions /PSU." As per submitted documents, the agency has failed to provide the required documents in compliance of aforesaid clause duly certified by the concerned Govt. Dept. / Universities /Constituent Colleges / Govt. Educational Institutions /PSU.
2.	The agency has not provided the proof of at-least Two agreement/work order of manpower (other than security services) currently working with Govt. Dept/ Universities/ Constituent Colleges on the last date of online submission of tender	Minimum 2 agreements /order's 3 Experience / Satisfactory /currently in progress certificates Page no. engaged from 157 to 159.	One of the mandatory eligibility criteria under Clause 6.17 of the Tender provides that "Proof of at-least two agreements/work order of manpower (other than security services) currently working with the

The aforementioned facts itself reveals that both the agency namely **M/s GA Digital Web Word Pvt. Ltd.** and **National Protective Security Services** do not fulfils some of the mandatory eligibility criteria and hence are fit case for ineligibility/disqualification.

In view of the aforementioned facts and circumstances, the screening/evaluation report of the technical bid submitted by the committee dated 29.09.2022 will remain unchanged. Accordingly only one agency namely M/s Frontline (NCR) Business Solutions Pvt. Ltd. is found technically qualified bidders for further process.

The Financial bid of technically qualified bidder M/s Frontline (NCR) Business Solutions Pvt. Ltd. will be opened on **15.10.2022 (Saturday) at 01:00 PM** in the Office Chamber of Dean, BVC, Patna. The technically qualified bidder / tendered/ their authorized representative may be present, at the time of opening of financial bid. No separate intimation will be send in this regard to the technically qualified bidders for deputing their representative. The financial bid of technically qualified bidder will be opened on scheduled date and time as mentioned above irrespective of the no. of bidders or their representative of bidders present.
