Hiring of Agenc0y for deployment of Manpower on Outsourcing Basis

The Technical Bids received under Tender No. BASU/Reg. / 03/2022 Dated 07/09/2022 for Hiring of Agency for deployment of Manpower on Outsourcing Basis are screended out and evaluated by the duly constituted technical bids opening / evaluation committee.

As per report submitted by the Committee, M/s Biswas Security Services (India) Pvt Ltd. has participated online but disqualified-auto and not submitted hard copy of the bid document. Further M/s Mars Mountain Security Services Pvt. Ltd., 23, Hem Plaza, Frazer Road, Patna-01has not participated online and submitted the hard copy of bid only. Accordingly both the bids are found fit to be rejected. The technical bids of 03 online accepted bidders as listed below were opened and screening / evaluation was undertaken by the Committee:-

As per screening report, one bidder namely M/s Frontline (NCR) Business Solutions Pvt. Ltd., 301, 3rd Floor, Patna Super Market Building, Frazer Road, Patna-800001 meet out all the essential eligibility criteria and accordingly found eligible. The rest two bidders have not found eligible with the following key reasons:-

1.	M/s GA Digital Web Word Pvt. Ltd	 The agency has not submitted an affidavit duly corroborated by the executive magistrate as per eligibility criteria duly mentioned in clause 6.12 of the tender as well as S. No. 19 of the Technical Bid. The agency has submitted the character certificate which is not valid in as much as the certificate has neither issued on the official pad of the competent authority neither having official issue/letter/certificate number.
2.	M/s National Protective Security Services	 1. The agency has not provided certified copy of minimum 500 manpower (other than security) on its pay roll as per eligibility criteria duly mentioned in clause 6.11 of the tender as well as S.No. 18 of the Technical Bid. 2. The agency has not provided the proof of at-least Two agreement / work order of manpower (other than security services) currently working with Govt. Dept/ Universities/Constituent Colleges on the last date of online submission of tender duly certified by the concerned University/Govt. Department or PSU as per eligibility criteria duly mentioned in clause 6.17 of the tender as well as S.No. 23 of the Technical Bid.



As per technical evaluation report M/s Frontline NCR Business Solution Private Limited scored 60 marks as per the technical evaluation parameters/criteria and accordingly fulfils the minimum qualifying score of 55 marks out of 100. Hence, M/s Frontline NCR Business Solution Private Limited also found technically qualified as per the criteria of the tender by the Committee.

As per the provision of Bihar Financial Rule duly amended and notified by Finance Department, Govt. of Bihar vide its Memo No. 7806 dated 30/09/2016, it is decided to open the Financial Bid of the eligible bidder namely M/s Frontline NCR Business Solution Private Limited in order to finalize the tender.

Any bidder may submit, if he/ she so desires, his / her written representation or submission on the basis of the papers / documents already submitted / uploaded in online mode at the time of submission of bid to the Registrar, BASU, Patna latest by 12.10.22 upto 4.00 PM.

It is clearified that no documents of the papers in this regard will be entertained, if provided or indicated other than already submitted / uploaded in online mode at the time of submission of bids. Furhter, representation received after the prescribed date and time will neither be entertained nor be valid for his / her claim in future.
