It is expressly clarified that the quoted rate is inclusive of Cost of uniform including shoes per annum, two wheelers, security cabins, walkie talkie, search lights, torch, whistle, batten, traffic light device, rain coat, jackets, stationery and office expenditure, Accounting & Administrative Charges, Cost of Recruitment Process, Paddle Cycles, Handheld Walkie-Talkiesets, Megaphone/PA system., Profit etc. as briefed below:-

Accordingly, you are offered to execute the agreement for the work as well as to complete other formalities as per terms & conditions of the tender so that work order for deployment of security (armed & unarmed) personnel may be issued.

Following clauses of the tender are re-itereted for proper compliance in order to issue the work order:-

- Clause-9.1- The successful bidder will be required to submit the Performance Security Deposit of 20.00 Lakhs (Twenty lakhs only) in favour of Finance Comptroller, Bihar Animal Sciences University, Patna in the form of Bank Guarantee valid for 39 months from the date of signing the contract agreement. In case the contract, based on the performance of the security or whatsoever any reasons, is extended / reviewed on the initial terms and conditions, the Bank Guarantee submitted to the University will be renewed accordingly.
- ii) Clause-13.26- The successful bidder shall enter into an Agreement with the University on Non-Judicial Stamp Paper of Rs. 1,000.00 (Rupees One Thousand) only within 07 days from the date of offer. The agreement format can be downloaded from the University website. Non-fulfillment of this condition of executing an agreement/contract document by the contractor would constitute sufficient ground for annulment of the award of the contract and forfeiture of Earnest Money Deposit.

iii) <u>Clause-13.38</u>-The successful bidder will have to provide the details of a single point of contact who should be contactable by the designated person of the University to answer any queries and resolve issues. He should be empowered to take decisions.

You are requested to submit the acceptance letter & execute the agreement bond as well as to comply all the formalities as per terms & conditions of the tender within 07 days from the issue of the offer letter. The draft copy of the agreement is enclosed for necessary action at your end.
