Tender Notice No. BASU/Reg. / 04/2022 Dated 15/09/2022

Hiring of Agency for deployment of Security (Armed & Unarmed) on Outsourcing Basis

In the light of the Important Notice bearing no. 1257/ Reg./BASU, Patna dated 30.11.2022, the three bidders i.e. H1, H2 & H3, M/s National Protective Security Services, Nagpur, M/S SIS Pvt. Ltd., Patna & M/s VM Guard Force Pvt. Ltd., Patna have made power point presentation one by one before the Committee on 01.12.2022 at 3.00 PM in online / offline mode with regard to the reasonability of the service charge quoted in their Financial Bid and discussion were made regarding requirement of the services / security devices / transportation etc. as detailed in the tender. On the basis of the presentation, the proceedings was drawn by the Committee and approved by the Competent Authority. As per the proceedings dated 01.12.2022, the following facts / observations was submitted:-

“During the discussions the attention of all the agency were drawn towards the requirement of the services / devices / transportation system apart from the deployment of security (Armed and Unarmed) in different categories as per tender document.


Further the Clause 7.4.1.1, 7.4.1.2 and Note-3 of Financial Bid of the tender were also reiterated and explained to the representative of the bidders.

During the discussions Mr. Rakesh Singh appeared on behalf of M/s NPSS, Nagpur admitted that the amount of service charge on the basis of quoted rate i.e 0.01%, to be collected by the agency from BASU, Patna will be almost negligible.

After due discussion and deliberation the Committee came to the opinion that the Service Charge quoted by M/s National Protective Security Services, Nagpur i.e. 0.01% is abnormally low and highly unreasonable which is tantamount to kill the tender process under the clause duly mentioned in Note-3 of Financial Bid of the tender. Accordingly, it has been decided to reject the Financial Bid submitted by M/s National Protective Security Services, Nagpur under the clause mentioned in Note 3 of Financial Bid of the tender. Further processing of bids will be done accordingly”.

Under the aforementioned facts and circumstances the Financial Bid submitted by M/s National Protective Security Services, Nagpur under Tender No. BASU/Reg./04/2022 dated 15.09.2022 stands rejected and further processing of bids will be done accordingly.
