NOTIFICATION

In exercise of power conferred under section 38 and 39 of the Bihar Animal Sciences University Act, 2016 (Bihar Act 15, 2016), the following amendment in clause 5.2 – (vi) in the chapter V of the Bihar Animal Sciences University Statute, 2020 as approved by the Hon'ble Chancellor, duly conveyed by the Principal secretary to Governor, Governor's Secretariat, Raj Bhavan Bihar vide its Letter No. BASU-09/2022-51/GS(I), dated 12.01.2023 are hereby published under section 39 (5) of the Bihar Animal Sciences University Act, 2016 for general information:-

Clause No. 5.2

(vi) For the purpose of calculating API score all such periods of duration which have been spent by the teacher on different kinds of paid leaves such as Maternity Leave, Child Care Leave, Study Leave, Medical Leave, Extraordinary Leave and Deputation shall be excluded from the grading assessment. The teacher shall be assessed for the remaining period of duration of the assessment period and the same shall be extrapolated for the entire period of assessment to arrive at the grading of the teacher. The teacher on such leave or deputation as mentioned above shall not be put to any disadvantage for promotion under CAS due to his/her absence from his/her teaching responsibility subject to the condition that such leave/deputation was undertaken with the prior approval of the competent authority following all procedure laid down in UGC Regulations and as per the Acts, Statutes and Ordinances of the parent Institution.

For example:

A. If the period of study leave-03 years during promotion from stage I to II (AGP Rs. 6000 to Rs. 7000), in this case, the minimum cumulative score for eligibility will be calculated as under:
Assessment Score = $75 \times (5-3) / 5 = 30$ marks.

B. If the period of study leave availed -03years (2 years during promotion from stage I to II and I year during promotion from stage II to III), in this case, the minimum cumulative score for eligibility will be calculated as under:-

(i) Assessment from stage I to II (AGP Rs. 6000 to Rs. 7000) = $75 \times (5-2) / 5 = 45$ marks

(ii) Assessment from stage II to III (AGP Rs. 7000 to Rs. 8000) = $75 \times (5-1) / 5 = 60$ marks

The above order be published in Bihar Gazette as per section 39 (5) of the Bihar Animal Sciences University Act, 2016 as allowed by the Hon'ble Chancellor, Bihar vide its Letter No. BASU-09/2022-51/GS(I), dated 12.01.2023.


