4. Tender enquiry documents containing detailed specifications along with terms and condition can be downloaded from the e-Procurement Portal <https://eproc2.bihar.gov.in>.
5. **The required amount of Earnest Money (EMD) will be submitted via Online Mode** and enclosed the details of EMD with the hard copy of Technical Bid of the Tender. No interest is payable on Bid Security. **Tenders without EMD shall be summarily rejected.**
6. The Tender Inviting Authority reserves the right to extend the schedule of tender or to reject the tender without assigning any reason.
7. All communication, addendum/corrigendum related to this tender will be issued on the website of <http://eproc2bihar.gov.in> and <https://www.basu.org.in>
8. In the event of any of the above-mentioned dates being declared as a holiday/closed day for BASU, Patna, the tender will be opened on the next working day at the prescribed venue and time.
9. Tenderers need not to be present at the time of opening of tender as all procedures will be done in online mode <https://eproc2.bihar.gov.in>.
10. This Tender Enquiry Document is not transferable.

GENERAL TERMS AND CONDITIONS

1. The technical and financial bids should be submitted through online mode as mentioned in respective stage “Technical bid” / “Financial bid” as applicable.
2. The vendors must have executed same nature of work in the last 3 years. The bidders should submit copies of suitable documents in support of their reputation, credentials and past performance.
3. Price bids of only those bidders will be opened whose technical bids are found suitable by the committee appointed for the purpose. Date and time of opening of price bids will be decided after technical bids have been evaluated by the committee. Information in this regard will be placed on the website or e-mail. No separate information will be send to the firms.
4. **NSIC units only are exempted for submitting EMD as per BFR guideline.**
5. **Earnest Money Deposit (EMD):** Bidder needs to submit the refundable EMD as mentioned. **The required amount of Earnest Money (EMD) will be submitted via Online Mode** and enclosed the details of EMD with the hard copy of Technical Bid of the Tender. Failure to submit the EMD will lead to the rejection of the tender.
6. No interest shall be payable by the buyer to the bidder on EMD.
7. **While sending rates, the firm shall give an undertaking to the effect that “the terms /conditions mentioned in the Tender Notice against which the rates are being given are acceptable to the firm”. In case the firms do not give this undertaking, their rates will not be considered.**
8. All disputes shall be subject to Patna Jurisdiction only.
9. All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer shall be summarily rejected.
10. Bihar Animal Sciences University, Patna reserves the right to cancel the tender at any point of time without assigning any reason.
11. The offer submitted by Telegram/E-mail/Speed post shall not be considered. No correspondence will be entertained in this matter.
12. **Duly signed hard printed copy of all tender documents (submitted on e-procurement portal) should be submitted by the tenderer to Central Purchase Office, Administrative Building, Bihar Animal Sciences University, Patna-800 014 latest by 28/08/2023 upto 17.00 Hrs.**
13. Bidders should go through the tender terms, conditions and specifications carefully and fill in the attached compliance statement accurately and unambiguously. They should ensure that all the required documents are furnished along with the bid.
14. **Signing of Tender documents:** A person signing the tender form or any document forming part of the tender on behalf of another person should have an authority to bind such other person and if, on

enquiry it appears that the person so signing had no authority to do so, Bihar Animal Sciences University, Patna may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.

- 15.** The tenderer should sign and affix his firm's stamp at each page of the tender and all its annexure as the acceptance of the offer made by tenderer will be deemed as a contract and no separate formal contract will be drawn. **No page should be removed/ detached from this Notice Inviting Tender.**

SPECIAL TERMS AND CONDITIONS FOR TENDERERS

1. The following terms and conditions should be complied with during submitting tender:-
2. Online <https://eproc2.bihar.gov.in> tender invited in **two bid systems**.
3. Tenders should be submitted to the e-Procurement Portal <https://eproc2.bihar.gov.in> only.
4. Only consumable items will be considered under rate contract. Under equipment/apparatus, liquid handling system (micropipettes, multi-channel pipettes), gel electrophoresis accessories (gel tray, combs, tank, spacers, gel casting tray, electrode, sponge pad etc.) only covered under this rate contract. Power supply units are not covered under Rate contract.
5. Proposal for rate contract may be submitted in the prescribed format and all columns may be filled up. Incomplete proposal and tenders received after due date shall not be entertained. The University shall not be responsible for any postal delay. Any bids received by the Institute which does not fulfill the desired terms and conditions shall be rejected out rightly and no communication in this regard shall be made.
6. Tender qualified by such vague and indefinite expression such as “Subject to prior confirmation”, “subject to immediate acceptance” etc. will be treated as vague offer and rejected accordingly. Any conditional tender shall be rejected summarily.
7. The Manufacturers (OEMs)/Principals offering for the Rate Contract may furnish the Name and Address of their local authorized distributors/dealer, so that the copies of orders can be endorsed to them for expeditious supply. In such cases where local dealers/stockiest has been nominated by the Principal; the bills raised by them against our purchase order will be accepted.
8. Any addition or deletion of authorized dealership/distributorship shall be intimated to the undersigned immediately on authorization of a new party.
9. The tenderer submitting his tender would be deemed to be considered and accepted all the terms and conditions. No enquiries, verbal or written shall be entertained in respect of acceptance or rejection of the tender.
10. Bihar Animal Sciences University, Patna reserves the right to cancel/ reject in or any part of the tender, which generally do not fulfil the conditions stipulated in the tender without assigning any reason.
11. Any action on the part of tenderer to influence anybody of the university shall make his/ their tender liable for rejection.
12. Bihar Animal Sciences University, Patna may in writing make any revision or modify the terms & conditions of the tender document by a corrigendum displayed on the website of the University as on the e-procure site. In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.

13. **Printed & bound price list for 2023-24 (both hard copy and soft copy-CD/Pen-drive) duly signed & certified by authorized signatory must accompany the tender. The soft copy price list should be downloadable and a copy may be supplied to this office duly signed and sealed by authorized signatory.**

14. **The bidders are required to mention GST applicable on each category otherwise rates will be treated as inclusive of all taxes.**

15. **An undertaking may be given that the price list being furnished with the proposal will remain valid for the current rate contract irrespective of validity period.**

16. **Discount:** The discount which will be offered by the manufacturer/authorized distributors on the manufacturer's price list for the year **2023-24** may be mentioned. Firms must offer a flat discount rate on all items instead of separate discount on different items like culture media, chemicals etc.

17. **GST:** The rate of GST should be mentioned clearly.

18. **Authorization Letter:** Authorization letter from the manufacturer for the contract period should be submitted along with quotation, failing which quotation will not be considered.

19. Trade discount along with certificate certifying that higher discount is not given to any other Department/Organization/Institution than offered should be enclosed with Financial Bid.

20. The price /rates quoted should be indicated in word as well as in figures. In case of any discrepancy, rate quoted in words will be valid.

21. The percentage of discount quoted by each firm in tenders be given both in words and figures. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders.

22. A certificate to be given by the tenderer that the price list supplied is the only one in circulation.

23. In case of supply of good made through valid authorized dealer, their name & mail address may be declared/ indicated in the tender.

24. Enlistment under Rate Contract with this university does not ensure business of any quantum, whatsoever. Any deviation from the terms & conditions mentioned above will imply disqualified for the firm.

25. Disputes, if any, arising between the Institute and the bidder out of or in connection with the terms and conditions contained herein shall be referred for arbitration to the Patna jurisdiction. Disputes shall be decided keeping in view of the terms and conditions of the tender and Bihar financial rules applicable to the Institute.

26. The Bidder must have adequate experience of execution of similar work in govt. Offices/PSUs/ Autonomous Bodies and other similar organization. Necessary supporting documents like work orders, work completion certificate, payment certificate etc. for **last three years** to this effect must be submitted along with the offer.

27. The concerned firm/ company whose product has been declared as of spurious or adulterated quality and any criminal cases is filled and is pending in any court shall not be eligible to participate in the bidding process. Convicted firms/company shall also not be eligible to participate in the bid.

Similarly, blacklisted/ banned/ debarred firms/ company by any central/ state govt. or its organization or autonomous bodies or central drug procurement agency are not eligible to participate in the bid.

28. Risk Purchase: If successful tender fails to supply material within the stipulated delivery date or material supplied other than specification then Bihar Animal Sciences University, Patna reserves the right to procure same or equivalent material from alternative sources at the vendor's risk, responsibility and cost. Any extra cost incurred in the procurement of the material from alternative source will be recovered from the Security Deposit/ Bank Guarantee and Pending Bills and if the value of the material under risk purchase exceeds, the amount of Security Deposit and / or Bank Guarantee and Pending Bills, the same may be recovered if necessary by due legal process.

29. Bihar Animal Sciences University, Patna have DSIR Certificate (Reg. No.: TU/V/RG-CDE (1293)/ 2020 Dated: 07.01.2021). Hence, Customs Duty exempted on all the scientific equipment and GST should be quoted @5% only. So, price should be quoted considering this point and DSIR certificate may be made available on demand at the time of issue of supply order.

30.No Advance payment shall be made.

31.For delay in supply, BASU will charge liquidated damage @0.5% per week maximum 10% after which the order will be cancelled.

32. Performance Guarantee: The successful tenderer shall furnish Rs. 20,000/- (Rupees twenty thousand) only as Performance Security Deposit in the form of Bank Guarantee (BG) / Fixed Deposit Receipt (FDR)/ Term Deposit Receipt (TDR) in favour of "Finance Comptroller, Bihar Animal Sciences University, Patna" for a period of 24 months and shall be kept 60 days beyond completion of all the contractual obligations.

33.The security deposit can be forfeited by the order of this University in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of the contract. Performance Security will be discharged after completion of contractor's performance obligation under the contract.

34.No interest on security deposit and earnest money deposit shall be paid by the University to the tenderer.

35. Validity of the bid shall be 90 days from the date of opening of tender.

36. Periodicity/ Duration of tender: Periodicity/ duration of tender will be initially for a period of one year from date of finalization which can be further extended for a period of one year on the same terms and conditions if the performance is found satisfactory.
