OFFICE ORDER

Under the provision of clause 4 of UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women employees and students in higher educational institutions) Regulations, 2015, the Hon'ble Vice-Chancellor has been pleased to constitute an Internal Complain Committee (ICC) of the University with the following composition in supersession of earlier order in this regard with immediate effect -

b)	<p>Two faculty members and two non-teaching employees, preferably committed to the cause of women or who have had experience in social work or have legal knowledge, nominated by the Executive Authority.</p>	<p><u>Faculty members:</u></p> <ol style="list-style-type: none">1. Master's: Class Representative of senior most batch of Master's Programme of concerned College3. d)	One member from amongst non-government organisations or associations committed to the cause of women or a person familiar with the issues relating to sexual harassment, nominated by the Executive Authority. 2. The term of office of the members of the ICC shall be for a period of three years.
3. The Member appointed from amongst the non-governmental organizations or association shall be paid such fees or allowances for holding the proceedings of the Internal Committee, by the Executive Authority as may be prescribed.
3. Responsibilities of ICC, Process of enquiry and other terms & conditions will be governed by the provisions of UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women employees and students in higher educational institutions) Regulations, 2015 attached herewith.
