Second Special Mop-Up Round Counseling for admission against vacant seats of B.F.Sc. Programme at College of Fisheries, Kishanganj for the Academic Year 2023-24 is organized at **MLT Hall of Bihar Veterinary College, Patna**. The candidates must report by **10.30 A.M.** on the date of counseling failing which their candidature will not be entertained.

The counseling will be held in order of merit provided by B.C.E.C.E.B., Patna attached as **Annexure-I**. The category-wise numbers of vacant seats, schedule of counseling as well as other relevant information are given below-

### 03. Counseling Procedure

3.1 Counseling of the candidate will be made in order of the joint rank/merit of B.C.E.C.E.-2023 as per the list attached as *Annexure-I*. The candidates will have to fill-up the prescribed format of verification/check-slip attached as Annexure-II and submit the same during registration/document verification.

3.2 The candidates shall opt the seat before the seat allotment committee based on seat availability.

### 04. Certificates required at the time of Counseling

On the date of counseling, the eligible/willing candidates are required to appear in person along with original relevant documents as per the check-slip (*Annexure-II*).

4.3 Any candidate failing to appear in the counseling shall not be considered for admission.

4.4 No TA/DA is admissible for appearing in the counseling.

### 5. General rules of reservation

5.1 Rules regarding filling of vacant seats in reserved category shall be followed as per Govt. of Bihar Reservation Act No 16 of 2003 for admission in educational institution.

A. Such reserved category candidates who is selected on the basis of his/her merit, shall be counted against the vacancies in the open merit category and not against the reserved category vacancies.


B. Woman of Backward Classes means women of all reserved classes and includes women of Scheduled Caste, Scheduled Tribes, Extremely Backward Classes and Backward Classes.

C. Reserved seats left vacant due to non-availability of concerned reserved category candidates shall be filled in the following manner: -

- Exchange shall be possible between the Schedule Caste and Schedule Tribes.
  - Exchange shall be possible between the Extremely Backward Classes and Backward Classes.
- D. In case of non-availability of suitable candidates for the reserved seats for women of Backward classes, the vacancies shall be filled in order of preferences as follows: -
- ❖ By the candidates of the Schedule Castes.
  - ❖ By the candidates of the Schedule Tribes.
  - ❖ By the candidates of the Extremely Backward Classes.
  - ❖ By the candidates of the Backward Classes.
- 5.2 **For EWS Candidates:** Certificate of Economically Weaker Sections and not possessing any of the assets mentioned in rule 3(2) of **The Bihar Reservation in vacancies in posts and services and in Admissions in the Educational Institutions for (Economically Weaker Sections) Act, 2019** will be issued by District Magistrate / Sub – Divisional Magistrate / Circle Officer concerned in the prescribed format.
- 5.3 **For PWD/Divyang Candidates:** Disability Certificate in prescribed performa issued by the competent authority as per guideline of B.C.E.C.E.B., Patna

#### 6. Other Terms and Conditions

- 6.1 The University reserves the right to make addition or deletion in number of seats without any notice.
- 6.2 The admission of any candidate is liable to be cancelled and forfeiture of deposited fee without giving any further notice forthwith or at any time during the period of the concerned course of study; if it is found that the candidate has/had produced fake/forged certificate(s)/documents(s), indulged in any act of misconduct/indiscipline and has/had concealed any other relevant information at the time of seeking admission.
- 6.3 The selected candidates must have to submit the undertaking regarding not to indulge in any kind of raging and other in-disciplinary activities at the time of Registration/Admission.
- 6.4 The admission of the candidate to the concerned Course of Study shall be subject to such ordinances, rules and regulations as framed time to time by the University.
- 6.5 The Category (UR/EWS/BC/EBC/WBC/SC/ST/PwD) declared by the candidate in application form will be final. No subsequent change will be allowed.
- 6.6 Candidates are advised to regularly keep visiting the University website for latest updates in this respect.
- 6.7 In case of any disputes, suites or legal proceedings against the University, the territorial jurisdiction shall be restricted to the Courts in Bihar at Patna only.
