Terms of references:

1. To coordinate with the affiliated colleges/institutions under the domain of the University.
2. To call for reports from the Heads of institutions in regard to the activities of the Anti-Ragging Committees; Anti-Ragging Squads, and the mentoring Cells at the Institutions, as the case may be, the compliance with instruction on conducting orientation programmes, counseling sessions, the incidents of ragging, the problems faced by the wardens or other officials.
3. To keep it abreast of the decisions of the District level Anti-Ragging Committee.
4. To review the efforts made by institutions to publicize anti-ragging measures, soliciting of affidavits from parents/guardians and from students, each academic year, to abstain from ragging activities or willingness to be penalized for violations.
5. To function as the prime mover for initiating action on the part of the appropriate authorities of the university for amending the statutes or ordinances or Bye-laws to facilitate the implementation of the anti-ragging measures at the level of the institutions.
6. To send the status reports periodically and as such frequencies that it may lay down, to the State level Monitoring Cell.


