



GENERAL INSTRUCTIONS & CONDITIONS

- The engagement is purely temporary and for a period of one semester which may be further extended (if so required by the University).
- On completion of tenure, the contract shall lapse automatically. However, the appointment can be terminated at any time (on either side) by giving one month's notice or by paying one month's salary without assigning any reason.
- 3 The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not be entitled for his/her selection.
- 4 Candidates are advised to check /visit the University website (https://www.basu.org.in) regularly for updates on the engagement process.
- 5 The University reserves the right to:
 - a) Withdraw any advertised post(s) at any time without giving any reason.
 - b) Fill or not to fill up the post advertised for any reason whatsoever
 - c) Alter/insert any corrections/additions/corrigendum/addendum in the advertisement/website in the event of any error/ or otherwise before the last date prescribed for the receipt of applications that shall be published only on the website of the University.
- In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of the offer letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 7 Canvassing in any form on the part of the candidate shall lead to his / her disqualification.
- 8 No interim queries regarding test/selection will be entertained.
- 9 The appointee shall not be entitled to any benefits like any allowances, provident fund, pension, gratuity, medical treatment, seniority, promotion etc. or any other benefits available to the Government servant appointed on regular basis.
- 10 The appointee will not be granted any claim or right to regular appointment to any post under Bihar Animal Sciences University, Patna.
- 11 In case of any disputes or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Patna.
- The University shall verify the antecedents or documents submitted by a candidate at any time of selection procedure, at the time of appointment, or during the tenure of the engagement. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his engagement shall be liable to be terminated forthwith and other legal action will be taken.
- 13 The Chairman of the Selection Committee shall have the power to lay down the procedure in respect of any matter not mentioned above. The Selection Committee may decide its own method of evaluating the performance of the candidates in the interview.



Experience and qualifications will be reckoned as on the date of walk-in-interview.



The candidates will have to produce all the original certificates and documents at the time of Walk-in-Interview, failing which their candidature shall be liable to be rejected.
