Based on the evaluation, out of four bidders, **the two bidders namely M/s- Urmila Enterprises & M/s Satyam Kumar was declared technically disqualified due to the non-submission of Latest income tax return acknowledgement receipt.**

Member Secretary placed before the committee the **Separate comparative Statement** that were prepared for each work. All the members of the committee reviewed all technical bid documents & found them as per tender conditions. **Furthermore, the member secretary summarized the technical evaluation for each work as below;**

### Technical evaluation summary for each work:-

#### Group no- 01

**Name of work-**Repair and painting of boundary wall of office building , Raising of boundary wall (north & west side) and construction of guard shed post at PRTC under BASU, Patna for the Year 2025-26.

Three bidders participated namely- (01) M/s Nirmana Construction, sri ram vilash jha maharaj, s/o sri kubhesh warjha, nelkanth colony raja bazar, patna, ward no-05, 800014. (02) M/s Nikhil Kumar Singh, Road no-01, Vijay Nagar, Hanuman Nagar, Patna-20 (03) M/s Abdul Gaffar Ansari, Mainpura, Saguna, Badi Haveli Road, Saguna, Danapur, Patna-801503. As per comparative statement committee observed that Two bidders namely **(1) M/s Nirmana Construction, Raja Bazar, Patna - 800014 (2) M/s Abdul Gaffar Ansari, Danapur, Patna-801503 were found technically qualified,** while one bidder namely M/s Nikhil Kumar Singh was declared technically non-responsive due to non- submission of Experience certificate.

#### Group no- 02

**Name of work-** Repair/Renovation of layer house-08 including electrical works at PRTC under BASU, Patna of PRTC under BASU, Patna for the Year 2025-26.

Three bidders participated namely- (01) M/s Nirmana Construction, Sri Ram vilash jha Maharaj, S/o Sri kubhesh warjha, Nelkanth Colony Raja Bazar, Patna, Ward No-05, 800014. (02) M/s Krishana Prasad, Chandra Shekhar Nagar East Gola, Danapur, Patna-801503. (03) M/s Hemant Kumar, New Yarpur, Babu Nagar, Road no-01, Ward No-16, Gardanibagh, GPO, Patna-01. As per comparative statement committee observed that **all three bidders namely (01) M/s Nirmana Construction, Raja Bazar, Patna, 800014. (02) M/s Krishana Prasad, Danapur, Patna-801503. (3) M/s Hemant Kumar, Gardanibagh, GPO, Patna-01 were found technically qualified.**

Group no- 03

**Name of work-** Renovation /civil work & Electrical work of feed mill godown and new hatchery building of PRTC under BASU, Patna for the year 2025-26.

Four bidders participated namely- (01) M/s Urmila Enterprises, 1st floor, 624 D, Ward-7, Bhagawanpur, Muzaffarpur, Bihar-842001 (02) M/s Satyam Kumar, Shahpur, P.o- Sonpur, Saran, Bihar-841101 (03) M/s Md. Mubrak, Mahingaon, ward no-09, Hatwar, Kishanganj-855107 and (04) M/s A.H. Construction, Harun Nagar, Sec- 01 Phulwari Sharif, Patna-801505. As per comparative statement committee observed that two bidders namely **(01) M/s A.H. Construction, Phulwari Sharif, Patna-801505** **(02) M/s Md. Mubrak, Mahingaon, Kishanganj-855107** were found **technically qualified**, whereas other two bidders namely (01) M/s Urmila Enterprises (02) M/s Satyam Kumar were declared technically non-responsive due to non-submission of Latest income tax return acknowledgement receipt.

**Recommendation of the Technical Bid Evaluation Committee**

The technical evaluation committee unanimously accepted the technical evaluation summary and further resolved that, in order to maintain transparency, the proceeding of the committee meeting conducted in connection with the technically qualified bidders, shall be uploaded on the e-procurement and university website.

If the bidders participated in the NIT No.- 04/2025-26 of Estate Office, BASU, Patna have any objection, they shall submit their objection through e-proc and university website within 05 days from uploading date of technical bid. **No objection of any kind from any bidders shall be entertained after that 05 days.** In case no objection is received, the financial bid shall be opened.


