GENERAL INSTRUCTIONS & CONDITIONS FOR THE POST OF PROFESSOR

- 1 The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle for his/her selection.
- 2 Candidates are advised to check /visit the University website (<https://www.basu.org.in>) regularly for updates on the recruitment process.
- 3 The University reserves the right to:
 - a) Withdraw any advertised post(s) at any time without giving any reason.
 - b) Fill or not to fill up some or all the posts advertised for any reason whatsoever
 - c) Increase/decrease the number of posts at the time of selection and make appointments accordingly.
 - d) Alter / insert any corrections/additions / corrigendum/addendum in the advertisement/website in the event of any error / or otherwise before the last date prescribed for the receipt of applications shall be published only on the website of the University.
- 4 In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 5 Canvassing in any form on the part of the candidate shall lead to his / her disqualification.
- 6 No interim queries regarding test/interview/selection will be entertained.
- 7 The service conditions shall be as per University rules.
- 8 In case of any disputes/suites or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Patna.
- 9 The University shall verify the antecedents or documents submitted by a candidate at any time of selection procedure, at the time of appointment, or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, then his services shall be liable to be terminated forthwith and other legal action will be taken.
- 10 The person appointed shall be governed by the Act, Statutes, Rules, and Regulations of the University as framed and amended from time to time.
- 11 Persons appointed may be transferred to any equivalent post within the jurisdiction of the University.
- 12 The Chairman of the Selection Committee shall have the power to lay down the procedure in respect of any matter not mentioned above. The Selection Committee may decide its own method of evaluating the performance of the candidates in the interview.
- 13 Experience and qualifications will be reckoned as the last date for submission of applications.
- 14
 - a) *'Basic degree in Veterinary Science at undergraduate level will be part of essential qualification as per VCI regulation 2016.*
 - b) Candidates have to fill score card and mention respective page number of relevant supportive document; otherwise application shall be treated as **INCOMPLETE AND REJECTED**.
 - c) Selection will be made on the basis of candidates' previous record (as per relevant score card) and their performance in the interview.

- d) Applicants for the post of Professor have to fill up page no. of relevant documentary proof as per score card and other information mentioned in the application form of the said post.
- e) Every page of the application form and enclosures must be serially numbered and signed by the candidate at the bottom of the page.
- f) The candidates will have to produce all the original certificates and documents at the time of interview for verification, failing which their candidature shall be liable to be rejected.
- g) *As per Chapter-VII Note-6(iii), University Statute, a candidate must obtain at least 50% marks in the interview to be considered in the merit order for selection. However, as per directive of Dairy, Fisheries and Animal Resource Department, Govt. of Bihar vide its L.No. 06/BASU(II)07/2023-4229, DFARD, Bihar dt. 13.11.2023 candidates belonging to SC & ST Category, Divyang Category and female candidate (irrespective categories) required to obtain 32% marks in the interview in order to consider in merit list.*

15 **SERVICE BOND:** - Selected candidates will have to submit a bond on a non-judicial stamp paper of Rs. 1000/- at the time of joining the service to serve the University for at least three years or as per prevailing university rules. No application for outside employment shall be forwarded during the bond period.

16 **MAXIMUM AGE LIMIT:** - There is no age limit for the appointment on the post of Professor.

- 17 **RETIREMENT AGE :-**
- a) Retirement age for the post of professor is 65 Yrs.
 - b) Person who join the post after superannuation from parent / serving organization or superannuated from parent organization during the service at BASU before attaining 65 Yrs. of age, the pay and leave after superannuation from active service shall be admissible as per the Resolution No.- 3M/10000/GAD, Bihar dt. 10.07.2015 issued from GAD, Govt. of Bihar, in the line of directive received from Governor's Secretariat, Bihar vide L.No.- TMBU-06/2021-686/Governor Sec.(1) dt. 04.05.2021.

18 **RESERVATION:** - University adopts reservation policy as per Government of Bihar.

- i) Reservation shall be applicable to candidates belonging to original resident of Bihar.
- ii) As per (Bihar Extra ordinary Gazette, Bihar Act-2,2019) The Bihar Reservation in vacancies in posts and in Services and in Admission in the Educational Institutes (For Economically Weaker Sections) ACT,2019 Clause-11, if candidate from EWS are not available to the extent of reservation percentage prescribed under ACT the vacancies of this category shall be filled up by the candidates of Open Merit Category in the same transaction.
- iii) As per Circular No.- 962 dated 22.01.2021 and Memo No.- 8962 dt.- 21.05.2025 GAD, Bihar 01 (one) post of Professor will be applicable for Deaf Mute (मूकबधिर) candidate under divyang category, it is only applicable to original resident of Bihar, subject to submission of residential certificate.
- iv) As per Circular No. 2526 dated 18.02.2016 GAD, Bihar 01 (one) post of Professor will be applicable for Grandchild of freedom fighter. Candidates selected under this category will be counted against (UR/R) in which category they belong to.
- v) As per Circular No.- 12575 dated 09.07.2025, 35% female reservation is only applicable to original resident of Bihar, subject to submission of residential certificate.

19 SUBMISSION OF APPLICATION: -

- i) Application along with self-attested relevant / desired documents and fees should reach “**The Registrar, Bihar Animal Sciences University, P.O: Bihar Veterinary College, Patna – 800014**” by speed post. The envelope should be superscripted “Application for the post of....., Department / Discipline & Name of the College”
- ii) The in-service candidates should apply through the proper channel. An advance copy of the application form may be considered subject to production of NOC at the time of the interview along with application fee, failing which their candidature is liable to be rejected.
- iii) Full text of research papers/publications need not be attached with the application, only the first page/ pages showing the necessary details of publication like- title, author (s), date/year/acceptance of publication, and name of journal/publication.
- iv) Candidates have to fill scorecard in the prescribed proforma and mention the respective page number of the relevant document is mandatory.
- v) Applications received after the last date and without complete information or without requisite fees will be summarily rejected. The University will not be responsible for any postal delay.
- vi)
 - Separate application forms need to be filled up for the said post of Bihar Veterinary College, Patna and College of Veterinary and Animal Science, Kishanganj.
 - For each post candidates have to submit separate application form along with requisite application fee.
