Application in the prescribed format are invited from the eligible Teachers/Scientists of the University satisfying/meeting the API Score based on PBAS requirements and other eligibility conditions laid down in the Chapter-V of Bihar Animal Sciences University Statutes, 2020 read with University Officer Order No. 396/1935 dated-13.03.2022 for consideration of placement in higher Academic Grade Pay/Promotion under Career Advancement Scheme, 2006 as per following: -

1. Placement of Assistant Professor or equivalent from Academic Grade Pay (AGP) 6000/- to 7000/- in PB-3 Rs. 15,600-39,100.
2. Placement of Assistant Professor or equivalent from Academic Grade Pay (AGP) 7000/- to 8000/- in PB-3 Rs. 15,600-39,100.
3. Promotion to the post of Associate Professor or equivalent in the PB-4 Rs. 37,400-67000 + AGP 9000/-.
4. Promotion to the post of University Professor or equivalent in the PB-4 Rs. 37,400-67000 + AGP 10000/-.

The Teachers/Scientists of the University who consider themselves eligible for promotions under CAS are required to submit the Application Form duly filled in the prescribed proforma based on Performance Base Appraisal System (PBAS) enclosed as Annexure-A in **three sets** along with relevant documents, for consideration under CAS 2006.

The last date to submit the Application Form along with relevant documents to the concerned Controlling Officers is **31/08/2026**.

The Controlling Officer shall verify the corrections of the eligibility of the teachers/scientists as per the eligibility criteria, make the necessary entry of required information and forward the same to the Registrar, Bihar Animal Sciences University, Patna by **15/09/2026**.

The placement in higher AGP/promotion is subject to fulfilment of all eligibility conditions as per CAS-2006 Regulations.
