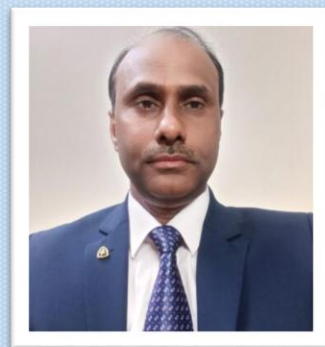

CHAPTER - 1

Profile of the University

1.1 ABOUT THE UNIVERSITY

Bihar Animal Sciences University (BASU) has been established with its headquarters at Patna through an act of Bihar State (BASU Act No. 15 of 2016, notified in the Bihar Gazette on 29 August 2016). The University has two campuses and four constituent Colleges viz. Bihar Veterinary College and Bihar State Institute of Dairy Technology at Patna campus and College of Fisheries and College of Veterinary and Animal Sciences at Kishanganj campus. Besides research facilities available in its constituent colleges, the University also has research farms/research stations namely Livestock Farm Complex, Patna; Poultry Research and Training Centre, Patna; Government Buffalo Farm, Sipaya (Gopalganj) and Krishi Vigyan Kendra, Jamui. The University headquarter is situated near Jai Prakash Narayan International Airport at Patna.

1.2 OBJECTIVES

- To impart education in Veterinary Science, Animal Husbandry, Dairy, Poultry, Fisheries and other allied branches of learning.
- To further the advancement of learning and conducting of research, particularly, in Veterinary and Animal Sciences, Dairy, Fisheries and other allied sciences.
- To undertake the extension of education of such sciences and technologies that are relevant for the livelihood of rural people of the state.
- To facilitate and ensure qualitative improvement in the teaching and learning processes and methodology.
- To facilitate and ensure quality research in the contemporary and frontier areas of animal science and technologies.
- To facilitate the need for an organized process of lifelong learning.
- To disseminate knowledge and findings emerging in the University, its colleges, and institutions.
- To establish partnerships with the industries and other entities working in animal science and technology and agriculture manufacturing.
- To establish Hospital for treatment/ research-role of the University.
- Such other purposes as the University or Government may advise from time to time.
- To establish Dairy processing plant for production of quality dairy products, advancement of research and to impart hands on training to the dairy students.

1.4 THE FACULTIES OF THE UNIVERSITY

1. Veterinary Science & Animal Husbandry

The faculty has two colleges i.e. Bihar Veterinary College (BVC), Patna and College of Veterinary and Animal Sciences, Kishanganj. The following programs are offered at these colleges.

- **Bachelor of Veterinary Science and Animal Husbandry (B.V.Sc. & A.H.):** It is a five years and six months' degree program. It is regularly offered at BVC, Patna and College of Veterinary and Animal Sciences, Kishanganj.
- **Master of Veterinary Science (M.V.Sc.)** is offered in different disciplines at BVC, Patna and COVAS, Kishanganj. It is a two-year postgraduate program. Detailed information is given under section 2.13 and 3.17 respectively.
- **Doctor of Philosophy (Ph.D.)** is offered at BVC, Patna in different disciplines. It involves two semesters of course work and Four semester thesis work to fulfil the degree requirements. Details of disciplines and other information are given under section 2.14.

2. Dairy Technology

The faculty has one institution i.e. Bihar State Institute of Dairy Technology at Patna, which offers the following academic programs:

- **B. Tech. (Dairy Technology):** It is a four years degree program and regularly offered at BSIDT, Patna.

- **B. Tech. (Food Technology):** It is a four years degree program. It will be offered at BSIDT, Patna from Academic Session 2026-27 subject to accreditation of ICAR, New Delhi.
- **M. Tech.** is a two-year postgraduate program and it is offered in different disciplines as given under section 4.16.
- **Doctor of Philosophy (Ph.D.)** is offered at Patna in Dairy Technology disciplines. It involves two semesters of course work and thesis work to fulfil the degree requirements. Details of disciplines and other information are given under section 4.17.

3. Fisheries

The faculty has College of Fisheries located at Kishanganj and following academic programs are offered.

- **Bachelor of Fisheries Science (B.F.Sc.):** It is a four-year degree program.
- **Master of Fisheries Science (M.F.Sc.):** It is a two year postgraduate program. It is offered in disciplines as per details given under section 5.14.
- **Doctor of Philosophy (Ph.D.)** is offered at Kishanganj in different disciplines. It involves two semesters of course work and thesis work to fulfil the degree requirements. Details of disciplines and other information are given under section 5.15.

BIHAR VETERINARY COLLEGE, PATNA

2.1 INTRODUCTION

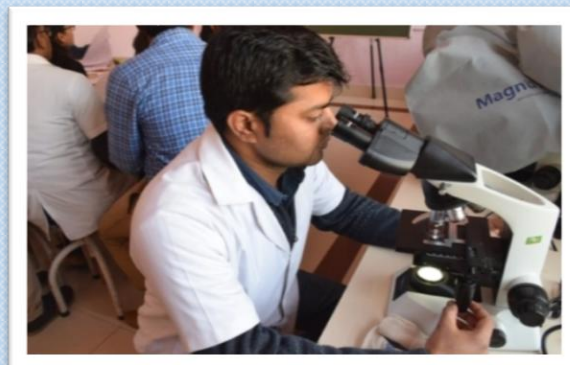
Bihar Veterinary College, Patna, the 5th oldest Veterinary College in pre-independence India, was founded on 2nd April, 1927 by Sir Henry Wheeler, the then Governor of Bihar & Orissa. The College made remarkable progress under the guidance and supervision of Dr. R. T. Davis, the first Principal of this historic College with a team of renowned scientists specialized in Breeding, Feeding, Management and Disease control of Livestock and Poultry. During the post-independence period, Bihar Veterinary College developed to its full capacity and occupied a prestigious status with strong base for teaching and research in the field of Veterinary Science and Animal Husbandry as well as advanced Veterinary clinical services to the society.



Bihar Veterinary College, Patna, for a long time, provided quality Veterinary education and training not only to the candidates from Bihar and Orissa but also from several other states (U.P., Meghalaya, Mizoram, Tripura, Jammu & Kashmir, Assam, Himachal Pradesh etc.) of the country as well as from developing countries like Nepal, Bhutan, Afghanistan, Iran, Malaysia etc. Graduates of this college are serving across the world and have occupied coveted and prestigious positions in State and Central Government, State Agricultural Universities, Research Institutes and National as well as Multinational Industries. It can be mentioned with pride that Dr. C. M. Singh, Dr. B. S. Rajya, Dr. R.C.P. Yadav, Dr. G. C. Mohanty, Dr. O. N. Singh, Prof. A. Ahmad, Dr. H. R. Mishra, Dr. R. B. Prasad, Dr. V. S. Pandey, Dr. D. V. Singh, Dr. G. Biswal, Dr. D. C. Nayak amongst others are the glittering graduates of this alma mater.

2.2 FACILITIES AVAILABLE: Laboratories, Instructional Farm, Veterinary Clinics, Hatchery etc.

All departments of the college are well-equipped with modern laboratories catering to undergraduate teaching as per the norms of the Veterinary Council of India (VCI) and postgraduate teaching in accordance with ICAR guidelines. The college houses a dedicated centre/unit for the



comprehensive diagnosis of infectious and non-infectious animal diseases, serving as a vital support system for both academic and field-level veterinary services.

The Veterinary Clinical Complex (VCC) is equipped with advanced diagnostic and therapeutic facilities, including X-ray, endoscopy, ultrasonography, physiotherapy, a specialized dental unit, blood biochemical analysis, histopathology, antibiotic sensitivity testing, and molecular diagnostic techniques. Faculty members from the Departments of Microbiology, Pathology, Parasitology, and Biochemistry work in close coordination to provide integrated diagnostic services. Veterinary Pathology plays a pivotal role in advancing animal health, safeguarding public health, and promoting research by effectively bridging the gap between basic sciences and clinical practice. A large number of clinical cases are routinely attended at the VCC, where samples are processed with precision for accurate and timely diagnosis. In addition to in-house cases, diagnostic samples are regularly received from field veterinarians, government veterinary hospitals, farmers, and private practitioners.

Whenever necessary, faculty members from allied disciplines such as Pharmacology, Animal Nutrition, Veterinary Public Health & Epidemiology, and Veterinary Physiology extend their expertise in diagnostic and investigative procedures. Confirmatory disease diagnosis remains a core strength of the institution, significantly contributing to disease management and control strategies across the state.

Clinical and para-clinical departments are actively involved in the systematic collection, preservation, transportation, and analysis of diverse biological samples. These include morbid and necropsy materials, body fluids (such as discharges, blood, serum, and plasma), tissues, urine, and faecal samples. Detailed microbiological, pathological, parasitological, biochemical, and toxicological examinations are conducted to ensure rapid and reliable diagnosis, thereby enabling veterinarians to implement effective therapeutic, preventive, and control measures.

The college also actively participates in disease monitoring through both active and passive surveillance under the All India Coordinated Research Projects (AICRP) on Animal Disease Monitoring and Surveillance (ADMAS) and Foot & Mouth Disease (FMD). These initiatives contribute to the generation of baseline epidemiological data, which is crucial for evidence-based policy planning and disease control programs in the state of Bihar.

To strengthen field-level clinical competence, Ambulatory Clinical Classes are conducted for undergraduate students in two adopted villages twice a week (Monday and Friday). This initiative provides hands-on exposure to real-time clinical cases while simultaneously delivering veterinary healthcare services at the farmers' doorstep.

As part of experiential learning programs, a Critical Animal Care Unit under the Department of Veterinary Medicine (funded by ICAR) and a Model Demonstration Unit for Small Animal Slaughter under the Department of Livestock Products Technology (university-funded) have been established. These facilities offer valuable

practical training to students, enhancing their professional skills and competencies. Additionally, the college is equipped with advanced teaching aids and technologies such as a Virtual Dissection Table (Anatomage), Cow model, and other state-of-the-art diagnostic and research equipment.

A modern Embryo Transfer Technology (ETT) and In Vitro Fertilization (IVF) laboratory has been established under the Rashtriya Gokul Mission (RGM). This facility has achieved notable success, including the birth of 19 IVF Sahiwal calves (14 in field conditions and 5 at the institutional farm), with a total of 26 calves produced to date—all of which are female, highlighting the efficiency and potential of the program.

The Livestock Farm Complex (LFC) extends over approximately 30 acres, with nearly 25 acres dedicated to fodder cultivation. It supports undergraduate and postgraduate teaching, research, and extension activities by maintaining well-managed livestock units. Students gain extensive practical exposure to farm management practices, animal breeding, and healthcare under field conditions. At present, the LFC maintains a diverse livestock population, including cattle, buffalo, sheep, and goats. The total bovine strength comprises 187 animals, including 141 cattle (Holstein Friesian and Jersey crossbreds, Sahiwal, and Red Sindhi breeds) and 46 buffaloes (Murrah and Nili-Ravi breeds). The goat unit consists of 129 animals, representing Black Bengal, Beetal, and Sirohi breeds. The college also houses a well-established poultry unit under the Poultry Seed Project, featuring a modern setter unit with a capacity of 16,000 eggs and a hatcher unit with a capacity of 10,000 eggs. The unit maintains parent stock of the Vanraja breed (approximately 1,800 birds), breeding stock of Japanese quail (around 300 birds), and a demonstration unit for Kadaknath poultry, thereby supporting teaching, research, and rural poultry development initiatives.

Besides its regular academic activities, the college actively organizes National and International conferences, dog shows, cat shows, goat shows, and dairy expos. It also conducts workshops, hands-on training programmes, and expert lectures by eminent speakers on need-based and emerging topics. These initiatives aim to enhance practical skills, update knowledge, and promote research activities among both students and faculty members. Additionally, such events provide valuable exposure to recent advancements, encourage interdisciplinary collaboration, and create opportunities for networking with experts from academia, industry, and research organizations.

2.3 COLLEGE LIBRARY

The Bihar Veterinary College is a constituent college of Bihar Animal Sciences University which maintains a well-equipped central library at the University level with all the relevant reading materials to cater the needs of the students, teachers and extension specialists of the university in the Bihar Veterinary College Campus itself. The library also maintains internet services, e-journal access and CD ROM facilities to its members.

2.4 STIPEND/INTERNSHIP

- The stipend of Rs. 2000 per month shall be awarded to all regular students (domicile of Bihar) admitted through NEET/BCECEB, Patna/VCI, New Delhi under B.V.Sc. & A.H. for the normal period (four and half year) during degree program.
- A sum of Rs. 6000 per year shall be given to all students (domicile of Bihar) towards purchase of books and other reading materials including stationeries for all students admitted through NEET/BCECEB, Patna/VCI, New Delhi under B.V.Sc. & A.H.
- Stipend shall be awarded to students during the B.V.Sc. & A.H. degree program as per the University rules and regulations.

2.5 STUDENT INTERNSHIP/EXPERIENTIAL LEARNING PROGRAMS

The Internship Programme is an integral component of the B.V.Sc. & A.H. degree curriculum, undertaken by students for a period of twelve months after the successful completion of the four-and-a-half-year academic coursework. Completion of all prescribed theory and practical courses is mandatory for enrollment in the internship programme. Students are divided into batches based on the total number of candidates. During the internship, they undergo rotational training across various clinical and para-clinical departments of the college, as well as at external institutions such as Patna Zoo, Rajgir Zoo Safari, Government Veterinary Hospitals, poultry farms, and other relevant field units. A significant portion of the internship—particularly three months—is devoted to intensive clinical training in core areas such as Veterinary Gynaecology & Obstetrics, Veterinary Medicine, and Veterinary Surgery & Radiology. During this period, interns are entrusted with round-the-clock clinical responsibilities, enabling them to develop practical skills in diagnosis, treatment, emergency care, and case management. In addition, interns undergo hands-on training in livestock production and management at the university's Livestock Farm Complex for a period of three weeks, where they gain exposure to modern animal husbandry practices, breeding, feeding, and farm management techniques. As per the norms of the Veterinary Council of India (VCI), students are also deputed to reputed veterinary colleges and institutes in other states to broaden their exposure and gain experience in diverse agro-climatic and management conditions. The programme further includes interactions with experts and representatives from pharmaceutical and animal health industries, which helps interns stay updated with recent advancements, therapeutics, vaccines, and professional opportunities in the veterinary sector. Interns are provided a monthly stipend of ₹15,000/- as per the Government of Bihar rules. At the end of the internship programme, each student is evaluated based on their performance, clinical competence, and overall conduct. Upon satisfactory completion, the B.V.Sc. & A.H. degree is awarded, qualifying them to serve as competent veterinary professionals in clinical practice, research, extension, and allied sectors.

2.6 HOSTEL ACCOMMODATION

Separate hostels for boys and girls are available at Bihar Veterinary College Patna. **However, hostel accommodation cannot be claimed as a matter of right.** Hostels shall be allotted subject to availability of rooms. With the permission of the competent authority and guardian, students can be allowed to stay outside the hostel as day scholar.



2.7 LECTURE-CUM-EXAMINATION HALL

The college is equipped with seven air-conditioned lecture-cum-examination halls, each furnished with modern infrastructure including interactive digital panels,

podiums, and other advanced teaching aids. All the classes, internal and external examinations are conducted within these well-maintained halls, ensuring transparency, discipline, and adherence to academic standards. At the university level, a dedicated External Examination and Evaluation Cell with all latest facilities required for the conduct of examinations.

2.8 EXHIBITION HALL/MUSEUM

The department of Veterinary Extension Education is maintaining a museum for display of various activities of the college through posters and models.

2.9 GAMES AND SPORTS AND EXTRACURRICULAR ACTIVITIES

Apart from its core commitments to teaching, research, and extension, the college places strong emphasis on the overall physical, mental, and social development of students through active participation in games, sports, and extracurricular activities. The college has a spacious playground for outdoor sports and provides indoor facilities such as table tennis and other recreational activities. The University/College regularly organizes a variety of sports and games events for both students and faculty members, promoting teamwork, discipline, and a healthy lifestyle. Inter-college and intra-college competitions are also encouraged to enhance competitive spirit and sportsmanship among participants.

In addition, the college actively conducts a wide range of extracurricular and co-curricular activities throughout the year. These include observance of important days such as International Yoga Day, Anti-Ragging Week, World Veterinary Day, Zoonoses Day, International Women's Day, Teachers' Day etc. Cultural programmes, debate competitions, painting and poster-making competitions, and literary events are regularly organized to nurture creativity and communication skills among students. The institution also conducts orientation programmes such as the Diksharambh Programme for newly admitted students and organizes Oath-Taking Ceremonies for graduating students to instill professional ethics and responsibility. Various student development activities are carried out under the aegis of Sports and Games, NCC, NSS, and Cultural and Literary Wings. These initiatives aim at fostering leadership qualities, social responsibility, community engagement, and holistic personality development, while also spreading awareness on important societal and public health issues.





2.10 EMPLOYABILITY

The students who are graduated from this college have 100% employability. Majority of our graduates, around 80% are employed by the government sector in the Department of Animal Husbandry as Veterinary Officers. Many of these veterinary officers join after their B.V.Sc. & A.H. whereas around 15-20% joins after obtaining their specialization. Around 5-10% of graduates who opt for higher studies find a satisfying career in institutes of highest learning in research and academia (universities, ICAR institutes) both in India and abroad. Veterinary graduate students also join other reputed organizations like COMFED, JEEVIKA, RVC, SSB etc.

2.11 SPECIAL FACILITIES

VETERINARY EMERGENCY RESPONSE UNIT (VERU)

Veterinary Emergency Response Unit (VERU) was established in the college during Kosi flood in the year 2008-09 in collaboration with World Animal Protection (WAP), New Delhi. The basic objective of creating Veterinary Emergency Response Unit in this college is to develop human resources capable of conducting rescue of animals during disaster and also to prevent any outbreak of diseases post disaster as well as to conduct impact of such incidents and be prepared for future. The training comprises of a series of lectures spread over 4- days rigorous training including and field exercises.

Under this program the students were exposed to five days' theory classes on prefix animal disaster lecture module and one-day simulation exercise at 9th Battalion NDRF, Bihta (Bihar) and got hands-on- training. This program is first of its kind in the country which imparts specialized training to Veterinary students.

Regular training of veterinary doctors of the Animal Husbandry department, GOB is being imparted apart from training to NDRF and SSB personnel. Training has also been organized for trainers by VERU unit of this college. This helps in creating human resources capable of working as trainers and work under disaster situations to save precious livestock.

2.12 UNDERGRADUATE DEGREE PROGRAM

2.12.1 BACHELOR OF VETERINARY SCIENCES AND ANIMAL HUSBANDRY (B.V.Sc. & A.H.)

The Bachelor of Veterinary Sciences and Animal Husbandry (B.V.Sc. & A.H.) degree course offered at Bihar Veterinary College (Bihar Animal Sciences University) is a full-time five and a half year duration undergraduate course as per Minimum Standards of Veterinary Education (MSVE) issued by the Veterinary Council of India New Delhi (2016). This program aims to prepare young professionals expertise in animal production, animal health management and veterinary medicine to be

responsible and responsive to the demands of society in an ever-changing environment.

2.12.2 ELIGIBILITY FOR ADMISSION

- A. A candidate under General Category for admission to the Bachelor of Veterinary Science and Animal Husbandry Degree Course shall have to qualify in each of the subjects of English, Physics, Chemistry and Biology, and obtain 50% marks in aggregate of these subjects, at the qualifying examination and admission of students to B.V.Sc. and A.H. degree course shall be made only on the basis of his or her merit in the competitive entrance examination and no other merit or weightage shall be considered.

In respect of candidates belonging to the Scheduled Castes or the Scheduled Tribes or other special category of students as specified by the Government from time to time, marks required for admission shall be 5% less than that the prescribed for General Category i.e. 47.5%.

- B. Candidate should have qualified the NEET conducted by NTA.

2.12.3 ELIGIBILITY CRITERIA FOR SELF-FINANCED SEATS

2.12.9 ADMISSION PROCEDURE

All the candidates, who desire to take admission in B.V.Sc. & A.H. degree program at Bihar Veterinary College, Patna, must appear in NEET (UG)-2026 conducted by National Testing Agency (NTA) (website: <https://ntaneet.nic.in>) and shall visit the BCECEB website:- <https://bceceboard.bihar.gov.in> for counselling and further information for the admission.

2.12.10 ATTENDANCE

1. The required condition of attendance shall be deemed to have been satisfied in respect of the subject, unless the student has ordinarily attended all the scheduled theory and practical classes, provided, the minimum requirement of attendance shall not be less than 75% of scheduled theory and practical separately with relaxation of twenty working days for NCC or NSS, Co-curricular activities and medical ground and for the course of 0+1 credit, the relaxation shall be of only seven days.
2. A candidate having attendance below 75% in a subject shall not be eligible to appear in the annual (including compartmental) examination of that subject.
3. The percentage of attendance of a student in a subject shall be computed on the basis of the total number of theory and practical classes scheduled between the date of commencement instructions and date of closing of instructions irrespective of the date of registration, provided, for the students who are reverted back owing to failure in the compartment examination, the attendance shall be counted from the date of declaration of result of compartment examination and the date of closing of instructions. The attendance for the First year shall be counted from the date of registration of the student.
4. Cases of students remaining on un-explained absence for more than 30 days shall be promptly reported to the Registrar and the name of such students shall be struck off from the university rolls for their unauthorized absence with the approval of Vice-Chancellor. The course Instructor/ Advisor shall report such cases to the Dean of the college concerned who will forward the case to the Registrar with his/her recommendations.

2.13 POST GRADUATE DEGREE PROGRAMS

Post graduate course curriculum is expected to build knowledge and skill portfolio of students so as to enhance their employability and marketability as multi-service providers with practical skills and comprehensive knowledge in the subject after qualifying for Master's and Doctorate degrees. The doctorates should, in turn, prove as specialists in the field of their specialization with aptitude and analysis for undertaking specialized and advanced research activities.

2.13.1 MASTER OF VETERINARY SCIENCE (M.V.Sc.) PROGRAM

Master of Veterinary Science (M.V.Sc.) program is of two-years duration covering four semesters offered at Bihar Veterinary College, Patna.

2.13.2 ELIGIBILITY FOR ADMISSION

1. A candidate should possess a basic Undergraduate degree i.e. B.V.Sc. & A.H. with minimum of 60% marks in aggregate or an OGPA of 6 out of 10 in a 10 point scale and 55% in aggregate or an OGPA of 5.5 out of 10 for SC/ST candidates (refer to table below).

Seventy-five percent (75%) of seats in each discipline will be reserved for the resident/domicile of the State of Bihar and the remaining 25% seats will be filled up by the candidates allotted by I.C.A.R. on the basis of All India Entrance Examination. If the seats of I.C.A.R. quota remain unfilled the vacant seats shall be filled by the University from resident/domicile of the State of Bihar.
2. The category-wise distribution of seats as per the reservation policy of Govt. of Bihar will be notified in admission bulletin/notification to be published on the University website.

2.13.5 ADMISSION PROCEDURE

1. Selection of candidate will be made on the basis of ICAR – AIEEA (PG) 2026 examination conducted by the I.C.A.R. followed by counselling by the University. The candidates will have to opt the subject at the time of counselling based on seat availability and reservation policy of Bihar Government.
2. Merit list shall be prepared for the candidates who apply for admission.
3. In case of a tie of score, performance at Bachelor's Degree level examination will form the criteria. If performance at the degree level is also equal, then seniority in the age would determine the priority.

2.13.6 ATTENDANCE

1. Student shall be regular in attending classes and shall be required to have minimum of 85% attendance in each course in a semester failing which he/she will not be eligible for final examination and awarded failure grade in the course unless withdrawal of the course permitted.
2. The Dean concerned may, on the recommendation of the Instructor/Advisor Condon shortage in attendance up to 10% in a course(s) in exceptional circumstances and allow students with an attendance of 75% or more to appear in the final examination.
3. Cases of students remaining on un-explained absence for more than 30 days shall be promptly reported to the Registrar and the name of such students shall be struck off from the university rolls for their unauthorized absence with the approval of Vice-Chancellor. The course Instructor/ Advisor shall report such cases to the Dean concerned who will forward the case to the Registrar with his/her recommendations.

2.13.7 SCHOLARSHIP/ FELLOWSHIP

All the students admitted to Master Program (M.V.Sc.) and are domicile of Bihar are given a monthly scholarship/fellowship of Rs. 7650/- (Rs. Seven thousand six hundred fifty only) for the period of two years subject to fulfilment of residential requirement as well as rules and regulations of the University.

2.14 DOCTORAL DEGREE PROGRAM (Ph. D.)

Doctoral Degree Program (Ph. D.) is of three years duration covering six semesters offered at Bihar Veterinary College, Patna.

2.14.1 ELIGIBILITY FOR ADMISSION

1. The minimum qualification for admission to the Ph.D. Program shall be Master's Degree in the subject concerned with at least 70% marks in aggregate or OGPA 7.0/10.0 at the Master's level and is relaxable up to 65% marks in aggregate or OGPA 6.5 out of 10.0 for candidates belonging to SC/ST categories.
2. Candidate should have qualified the ICAR-AICE-JRF/SRF (Ph.D.)-2026 conducted by ICAR in concerned subject of specialization.
3. A candidate can apply for admission to only one subject. No change would be allowed.

2. The Dean concerned may, on the recommendation of the Instructor/Advisor Condon shortage in attendance up to 10% in a course(s) in exceptional circumstances and allow students with an attendance of 75% or more to appear in the final examination.
3. Cases of students remaining on un-explained absence for more than 30 days shall be promptly reported to the Registrar and the name of such students shall be struck off from the university rolls for their unauthorized absence with the approval of Vice-Chancellor. 2.17 ACADEMIC RULES

- University follows the Veterinary Council of India (VCI) rules and Minimum Standards of Veterinary Education (MSVE) Regulations 2016 for admission in Bachelor of Veterinary Science and Animal Husbandry – Degree Course. (For detailed information the candidates may visit website www.dahd.nic.in or www.aipvt.vci.nic.in).
- B.V. Sc. & A.H. Degree course shall comprise of a course of study consisting of curriculum and syllabus spread over 5½ complete professional years including a compulsory rotational internship of “one year” duration undertaken after successful completion of all credits.
- Medium of instruction for B. V. Sc. and A. H. degree course shall be English.
- "Each professional year shall have at least two hundred ten instructional days excluding annual examination days, except the fourth professional year which consists of 315 instructional days" as per VCI-MSVE-2016.
- The schedule of examination during Bachelor of Veterinary Science and Animal Husbandry course shall consist of internal assessment and annual examinations.
- **A candidate having attendance below 75% in a subject shall not be eligible to appear in the annual examination of that subject.**
- A student shall be promoted to next higher professional class only if he or she has passed in all the subjects of the respective class by obtaining at least 50% marks in theory (internal and external combined) and practical separately.
- After passing the fourth professional examination, every student of B.V.Sc. & A.H. degree course shall be required to undergo compulsory rotating internship to the satisfaction of the University for a minimum period of twelve calendar months so as to be eligible for the award of the degree of Bachelor of Veterinary Science and Animal Husbandry and full registration with the council.
- Courses in P.G. program (M.V.Sc. / Ph.D.) shall be as per ICAR guidelines.

2.18 ADMISSION PREREQUISITES

All the candidates, who have been allotted seats for B.V.Sc. & A.H course, shall have to report at Bihar Veterinary College, Patna for admission on the dates which will be declared during the counselling at BCECE Board, Patna. The candidates have to deposit admission fee in the College by cash or through net banking, Debit card / Credit card or UPI. They must **bring all the documents in original (except those submitted at BCECEB, Patna) along with Surety bond and Affidavit (format provided at the time of counselling).** The format for surety bond can be downloaded from University website (www.basu.org.in).

2.19 SURETY BOND (FOR B.V.Sc. & A.H)

Candidate selected for admission in B.V.Sc. & A.H. course will have to execute a surety bond duly signed by his/her parent/ guardian at the time of admission on the prescribed format as in **Annexure – A**. Failure to execute the surety bond will lead to cancellation of admission.

A student who desires to leave the degree program after closure of B.V.Sc. & A.H. admission or on any day during the subsequent years, irrespective of the fact shall have to repay the total amount of scholarship/fellowship received and a sum of Rs. 3,00,000/- (Rupees three lakhs only) as penalty as per conditions of the bond.

CHAPTER - 3

COLLEGE OF VETERINARY AND ANIMAL SCIENCES, KISHANGANJ

3.1 INTRODUCTION

As per Bihar Gazette No. 797 Patna, dated 21.09.2021, Government of Bihar has given approval for establishing the College of Veterinary and Animal Sciences (COVAS) at Kishanganj, subsequently the college was established on 13th May, 2022 in the campus of Dr. Kalam Agricultural College (DKAC), Arrabari, Kishanganj. This college is a



constituent college of Bihar Animal Sciences University (BASU), Patna. The total sanctioned posts as per above mentioned gazette, for this college is 208, including 122 Academic-cum-Administrative posts and 86 non-teaching and supportive staffs. The institute has started a five and a half year degree program for B.V.Sc & A.H according to VCI minimum standard of veterinary Education (MSVE- 2016) from Academic Year 2023-24.

The college comprises of experienced and highly qualified faculty members having expertise in different disciplines of Veterinary and Animal Sciences. Their knowledge and guidance are crucial for providing high-quality education to the students. The four storied building is available for teaching and extension education activities with well-equipped laboratories, smart class rooms and well facilitated residential accommodation for the college students and faculty as well. The institute has a well-functioning hospital that offers comprehensive veterinary healthcare services to animals. The facilities and necessary infrastructure for diagnostics, teaching laboratories and livestock farms are being put in place on priority.

3.2 LOCATION

The College of Veterinary and Animal Sciences, Kishanganj is situated in Arrabari village of Pothia Block in Kishanganj district of Bihar State, India. The college is located in the campus of Dr. Kalam Agriculture College situated at about 400 KM from Patna, Bihar and well connected via road (NH-31), rail and air. It is 22 KM away from Kishanganj Railway Station and 65 KM away from Bagdogra Airport.

3.3 VISION

- To provide a platform for aspiring veterinary professionals of Frontier area of Bihar for quality education and training in veterinary and animal sciences. This includes comprehensive coursework, practical training, and hands-on experience in diagnosing, treating, and preventing diseases in animals.

- To develop and implement effective strategies to improved animal health, productivity in livestock, and overall animal welfare.
- To get engage actively with the local community by awareness campaigns, workshops, and training programs for farmers, livestock owners, and other stakeholders.
- To train veterinary entrepreneurs for the establishment of veterinary clinics, diagnostic laboratories, and other related entrepreneurship for better employment opportunities and boosting the local economy.

3.4 CLASSROOMS

The college has air-conditioned classrooms with modern audio visual aids for presentation.

Collar mike system is used by the instructors for delivering their lectures.

There is ample space for the students to sit comfortably during the lectures.



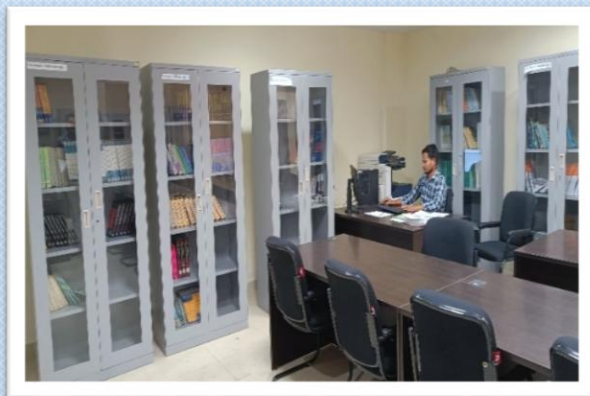
3.5 LABORATORIES

All the departments have their respective UG Laboratories which are equipped as per the MSVE 2016 requirements. New equipment has been purchased, laboratories have been set up and are ready to carry out practical works.



3.6 LIBRARY

The college library serves as the academic heart of the college to support teaching programs, research activities and extension. The COVAS, Kishanganj has a well-established library situated on the second floor of main building and it is divided into service areas, collections stall and reading hall. It is managed and operated by the librarians and support staff. The library has a good collection of text books, reference books, journals, and internet facility for reference purpose. Besides this, there is a central university library of BASU at Bihar Veterinary College Campus, Patna having good number of books on all the subjects, journals, periodicals, internet facility and CD – ROM reference databases to cater the need of students as and when required.



3.7 COMPUTER LABORATORY

The institute has a well-equipped computer centre which is connected through Local Area Network (LAN) for access to internet. This is used for training/teaching, computation report preparation and surfing the net for academic activities.

3.8 CONFERENCE HALL AND AUDITORIUM

A full air-condition conference hall in the college campus provides the right environment and ambiance for various programs, seminars, lectures and conferences. The objective behind the auditorium is to enhance the quality of education. It also provides ample opportunity for the staff and students to exhibit their talents in cultural activities.



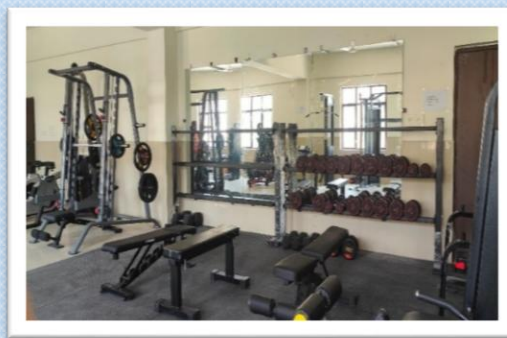
3.9 GAMES AND SPORTS

3.10 GYM FACILITY

3.11 HOSTEL FACILITY

There are separate hostels for Boys and Girls at COVAS, Kishanganj. The allotment of rooms will be made under the instruction of the Dean, COVAS, Kishanganj on the basis availability. However, hostel accommodation cannot be claimed as a matter of right. The Boys and Girls hostel will have separate resident wardens in addition to the supervisors and supporting staff. Proper dining and entertainment facilities are also available in the hostel.



3.12 VETERINARY CLINICAL COMPLEX (VCC)

This serves the need of remedies of all animals, disease diagnosis of animals, clinical teaching and various veterinary extension activities through it. Several facilities are available under this department viz. Out Patient Department (OPD) facility for Veterinary Medicine, Gynaecology & Surgery; Small animal radiography; Small and Large animal abdominal and reproductive ultrasonography; Small animal Electrocardiography; Small animal & large animal Artificial Insemination (AI); Parasitological examinations of both stool & blood; Haematological examinations; Urine analysis; Necropsy (post mortem examination); etc.



3.13 AMBULATORY SERVICES

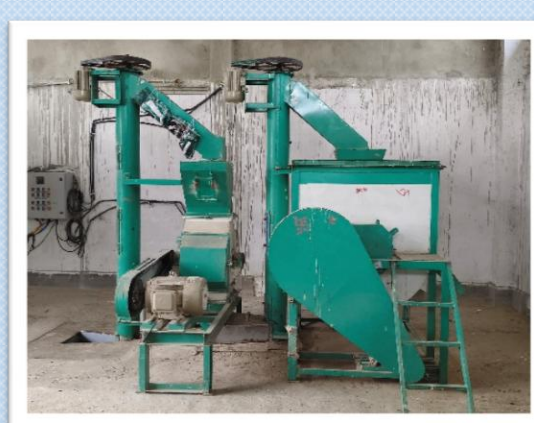
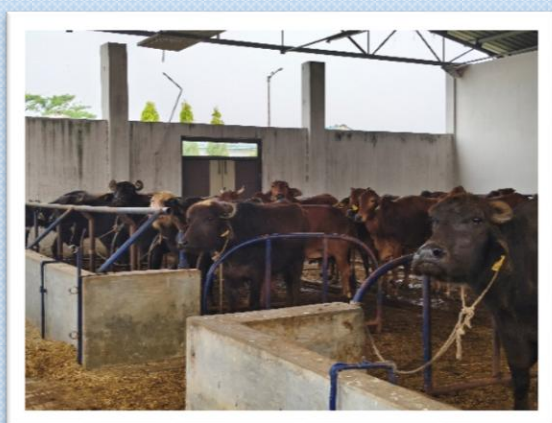
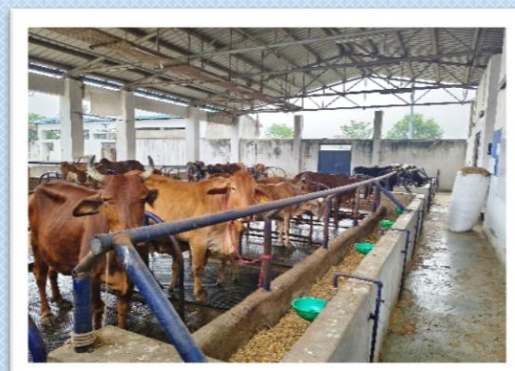
The Ambulatory clinic serves animal farms within a 30 kilometer radius of Arrabari. Our Animal Hospital clinicians offer a variety of on-the-farm services, from individual animal care to herd health. We offer a full range of ambulatory services, including:

- ✓ Routine herd health, including vaccinations, pregnancy examinations, castration and dehorning
- ✓ Herd-level disease surveillance testing
- ✓ Treatment of emergency medical issues
- ✓ Herd health planning to help improve animal health and efficiency



3.14 LIVESTOCK FARM COMPLEX (LFC)

Well functional LFC has been established on the campus. It comprises of Dairy, Sheep & Goat, Poultry, Equine, Piggery and Fodder Production units. Scientific management, feeding, breeding, and housing is being followed at LFC to improve the productive and reproductive performance of animals. The fodder unit produces forages for livestock feeding.





3.15 EXTENSION ACTIVITIES

Kisan samwad-cum-Animal Health Camps are organized weekly on every working Friday. A total of 64 such camps have been organized till date. The faculty of the college along with the students are determined to raise the socio-economic status of the rural people through their knowledge. Twelve infertility-camp-awareness seminars have also been organized in four different districts of Bihar. The college is also pursuing Animal Genetic Resource awareness program. Apart from these 7 villages have been adopted under Village Adoption Program.



3.16 UNDERGRADUATE DEGREE PROGRAM

3.16.1 BACHELOR OF VETERINARY SCIENCES AND ANIMAL HUSBANDRY (B.V.Sc. & A.H.)

The Bachelor of Veterinary Sciences and Animal Husbandry (B.V.Sc. & A.H.) degree course offered at College of Veterinary and Animal Sciences, Arrabari, Kishanganj (Bihar Animal Sciences University), Bihar, is a full-time five and a half year duration undergraduate course as per Minimum Standards of Veterinary Education (MSVE) issued by the Veterinary Council of India (2016). This program aims to prepare young professionals expertise in animal production, animal health management and veterinary medicine to be responsible and responsive to the demands of society in an ever-changing environment.

3.16.2 ELIGIBILITY FOR ADMISSION

- A. A candidate under General Category for admission to the Bachelor of Veterinary Science and Animal Husbandry Degree Course shall have to qualify in each of the subjects of English, Physics, Chemistry and Biology, and obtain 50% marks in aggregate of these subjects, at the qualifying examination and admission of students to B.V.Sc. and A.H. degree course shall be made only on the basis of his or her merit in the competitive entrance examination and no other merit or weightage shall be considered.

In respect of candidates belonging to the Scheduled Castes or the Scheduled Tribes or other special category of students as specified by the Government from time to time, marks required for admission shall be 5% less than that the prescribed for General Category i.e. 47.5%.

- B. Candidate should have qualified the NEET conducted by NTA.

3.16.4 STIPEND/INTERNSHIP

- The stipend of Rs. 2000 per month shall be awarded to all regular students (domicile of Bihar) admitted through NEET/BCECEB, Patna under B.V.Sc. & A.H. for the normal period (four and half year) during degree program.
- A sum of Rs. 6000 per year shall be given to all students (domicile of Bihar) towards purchase of books and other reading materials including stationeries for all students admitted through NEET/BCECEB, Patna under B.V.Sc. & A.H.
- Stipend shall be awarded to students during the B.V.Sc. & A.H. degree program as per the University rules and regulations.
- The interns are paid an amount of Rs 15,000/- per month as an internship allowance.

3.16.5 ADMISSION PROCEDURE

All the candidates, who desire to take admission in B.V.Sc. & A.H. degree program at College of Veterinary and Animal Sciences, Kishanganj, must appear in NEET (UG)-2026 conducted by National Testing Agency (NTA) (website: <https://exams.nta.ac.in>) and shall visit the BCECEB website:- <https://bceceboard.bihar.gov.in> for counselling and further information for the admission.

3.16.6 ATTENDANCE

1. The required condition of attendance shall be deemed to have been satisfied in respect of the subject, unless the student has ordinarily attended all the scheduled theory and practical classes, provided, the minimum requirement of attendance shall not be less than 75% of scheduled theory and practical separately with relaxation of twenty working days for NCC or NSS, Co-curricular activities and medical ground and for the course of 0+1 credit, the relaxation shall be of only seven days.
2. A candidate having attendance below 75% in a subject shall not be eligible to appear in the annual (including compartmental) examination of that subject.
3. The percentage of attendance of a student in a subject shall be computed on the basis of the total number of theory and practical classes scheduled between the date of commencement instructions and date of closing of instructions irrespective of the date of registration, provided, for the students who are reverted back owing to failure in the compartment examination, the attendance shall be counted from the date of declaration of result of compartment examination and the date of closing of instructions. The attendance for the First

year shall be counted from the date of registration of the student.

4. Cases of students remaining on un-explained absence for more than 30 days shall be promptly reported to the Registrar and the name of such students shall be struck off from the university rolls for their unauthorized absence with the approval of Vice-Chancellor. The course Instructor/ Advisor shall report such cases to the Dean of the college concerned who will forward the case to the Registrar with his/her recommendations.

3.16.7 ADMISSION PREREQUISITES

All the candidates, who have been allotted seats for B.V.Sc. & A.H course, shall have to report at College of Veterinary and Animal Sciences, Kishanganj for admission on the dates which will be declared during the counselling at BCECE Board, Patna. The candidates have to deposit admission fee in the College through net banking, Debit card / Credit card or UPI. They must bring all the documents in original (except those submitted at BCECEB, Patna) along with Surety bond and Affidavit (format provided at the time of counselling).

3.16.8 SURETY BOND (FOR B.V.Sc. & A.H.)

Candidate selected for admission in B.V.Sc. & A.H. course will have to execute a surety bond duly signed by his/her parent/ guardian at the time of admission on the prescribed format as in **Annexure – A**. Failure to execute the surety bond will lead to cancellation of admission.

A student who desires to leave the degree program after closure of B.V.Sc. & A.H. admission or on any day during the subsequent years, irrespective of the fact shall have to repay the total amount of scholarship/fellowship received and a sum of Rs. 3,00,000/- (Rupees three lakhs only) as penalty as per conditions of the bond.

3.17 POST GRADUATE DEGREE PROGRAMS

Post graduate course curriculum is expected to build knowledge and skill portfolio of students so as to enhance their employability and marketability as multi-service providers with practical skills and comprehensive knowledge in the subject after qualifying for Master's and Doctorate degrees. The doctorates should, in turn, prove as specialists in the field of their specialization with aptitude and analysis for undertaking specialized and advanced research activities.

3.17.1 MASTER OF VETERINARY SCIENCE (M.V.Sc.) PROGRAM

Master of Veterinary Science (M.V.Sc.) program is of two-years duration covering four semesters offered at College of Veterinary and Animal Sciences, Kishanganj.

3.17.2 ELIGIBILITY FOR ADMISSION

1. A candidate should possess a basic Undergraduate degree i.e. B.V.Sc. & A.H. with minimum of 60% marks in aggregate or an OGPA of 6 out of 10 in a 10 point scale and 55% in aggregate or an OGPA of 5.5 out of 10 for SC/ST candidates (refer to table below).

3.17.4 ADMISSION PROCEDURE

Seven thousand six hundred fifty only) for the period of two years subject to fulfilment of residential requirement as well as rules and regulations of the University.

CHAPTER - 4

BIHAR STATE INSTITUTE OF DAIRY TECHNOLOGY, PATNA**4.1 INTRODUCTION**

Bihar State Institute of Dairy Technology (BSIDT), Patna is a constituent College of Bihar Animal Sciences University (BASU), Patna. Prior to that it was a part of Bihar Agriculture University (BAU), Sabour since 2010 and a part of RAU (Rajendra Agriculture University), Pusa since the inception of the institute i.e. from 1980.



The institute imparts teaching, research and extension in the area of Dairying encompassing Dairy Engineering, Dairy Technology, Dairy Microbiology, Dairy Chemistry, Dairy Extension and Dairy Business Management. The institute runs a four year degree programs leading to Bachelor of Dairy Technology B.Tech. (D.T.) and Bachelor of Food Technology B.Tech. (F.T.), two year post graduate degree program in M.Tech (D.T.), M.Tech (D.C.), M.Tech (D.M.), M.Sc. (Agricultural Extension Education) and M.Sc. (Agricultural Economics) at present. The institute has adopted the course curricula as per recommendation of the Dean's Committee constituted by the ICAR, New Delhi and presently the courses are offered as per ICAR 6th Deans' Committee recommendations.

4.2 ACTIVITIES AND LINKAGES

Since inception the institute has provided high dividends in terms of excellent academic and research outputs. The institute has been producing B.Tech. (D.T.) graduates with spectacular placement records. Many students are persistently securing Junior Research Fellowship (JRF) and have qualified competitive examinations seeking admissions in National Dairy Research Institute (NDRI), Karnal and other State Agricultural Universities (SAUs) in India. A number of students have qualified CAT, GATE and are studying in IIMs, IRMA etc. Alumni of BSIDT are serving in many of the prestigious dairy plants like AMUL, COMFED (Bihar), Mother Dairy, Nestle etc. Besides, its alumni are also serving in various Government organizations, State Agricultural Universities, National Banks etc.

4.3 STATUS OF THE INSTITUTE

The institute has six departments namely Dairy Technology, Dairy Engineering, Dairy Chemistry, Dairy Microbiology, Dairy Business Management and Dairy Extension Education. With the passage of time a number of infrastructure development have

taken place in its own campus at Jagdeopath, Patna. A new building of college is under construction and will be ready in a few months.

4.4 ACADEMIC STATUS

With the view to meet the requirement of trained graduates in Dairy and Food Industry, the institute admits sixty students for the Bachelor of Technology (Dairy Technology) and forty students for Bachelor of Technology (Food Technology) which are four year degree program. The courses are being offered as per the ICAR 6th Dean's Committee syllabus. Hands on Training and Experiential Learning Program prepare students for professional and practical competence which make them ready for absorption in the industry. Since 2016 Student READY Program is included in the semester breaks to make students acquainted with all steps involved in procurement processing and marketing of milk and milk products.

4.5 TRAINING AND PLACEMENT CELL

4.5.1 OBJECTIVES

1. To provide the facilities for Training and Student READY programs and In-plant training to students as per the ICAR 6th Deans Committee curriculum.
2. To provide placement opportunities to students in different organization like State Milk Federation (COMFED), private dairy & food plants, dairy training institutes, and allied industry/agencies.

4.5.2 STIPEND FOR THE UNDERGRADUATE STUDENTS

- All the students having domicile of Bihar are given a monthly stipend of Rs. 2000/- (two thousand only) along with annual contingency of Rs. 6000/- (Six thousand only) for the period of four years, subject to fulfilment of residential requirement as well as rules and regulations of the University.
- Besides, some of the organizations imparting in-plant training to students also provide remuneration to the students during their trainings.
- ICAR has made a provision to provide stipend for one semester @ Rs. 3000/ per month to those students who do not receive any remuneration from industries.

4.6 LABORATORIES

The institute has a central fine instrument laboratory and six other well-equipped laboratories e.g. Dairy Technology, Dairy Chemistry, Dairy Microbiology and Dairy Business Management, Dairy Engineering and Language laboratory etc., for the practical classes and carrying out experiments for the research work.



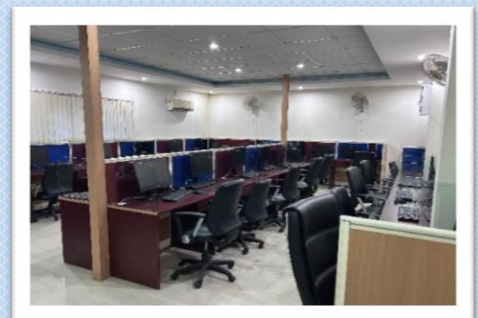

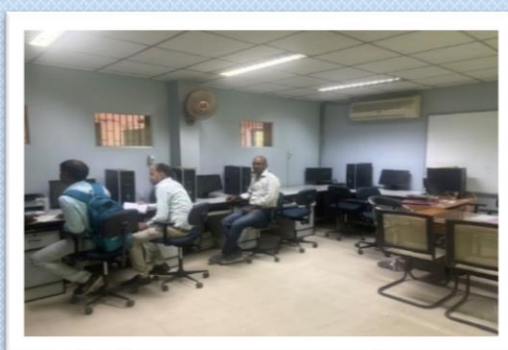

4.7 CLASS ROOMS

The institute has air-conditioned classrooms with audio visual presentation equipment and modern facilities. A new lecture theatre complex is under final stage of construction that shall be having one large hall on ground floor with 175 seats that may be utilized as mini-auditorium for organizing seminars, meetings and small events along with class lectures. The complex has two 48 seated lecture halls on first floor equipped with Audio Visual (AV) facilities. Engineering drawing laboratory, workshop laboratory, electrical technology laboratory, fluid mechanics laboratory and Instrumentation engineering laboratory are part of the upcoming new building of Dairy Engineering apart from the existing dairy and food process engineering laboratory.

4.8 LIBRARY

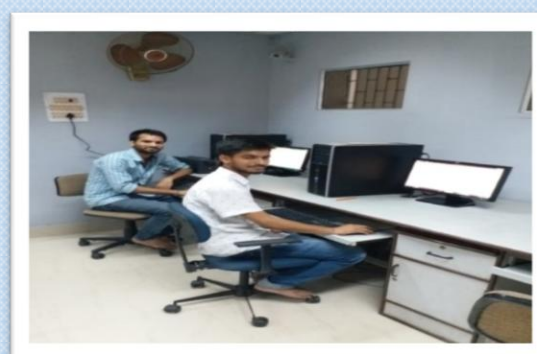
The BSIDT library provides facilities to support research teaching and scholarly communication across various disciplines. The library serves as an information hub for the students and the staff of the college to access national and international journals, periodicals, textbooks and reference books to the students for their course work and



research through CeRA. The library has a good collection of text books, reference books, few journals, project reports and internet facility for reference purpose. Besides this, there is a central university library of Bihar Animal Sciences University at Bihar Veterinary College Campus Patna having good number of books on all the subjects, journals, periodicals, internet facility and CD – ROM reference databases to cater the need of students.

4.9 COMPUTER LABORATORY

The institute has a well-equipped computer centre and is connected through Local Area Network (LAN) for access to internet. Staff rooms and various laboratories have also been provided with internet connection through LAN. The faculties students and staffs use this laboratory for training/ teaching computation report preparation and



surfing the net for academic activities. The institute has been connected with the Local Area Network (LAN) of the University to have broadband internet access and other services for faculty, staff and students.

4.10 LANGUAGE LAB

A Language Lab is established in the institute for improving the communication skills of the students. A full batch of 40 students can practice different exercises under the supervision of a language teacher.

4.11 HOSTEL ACCOMMODATION

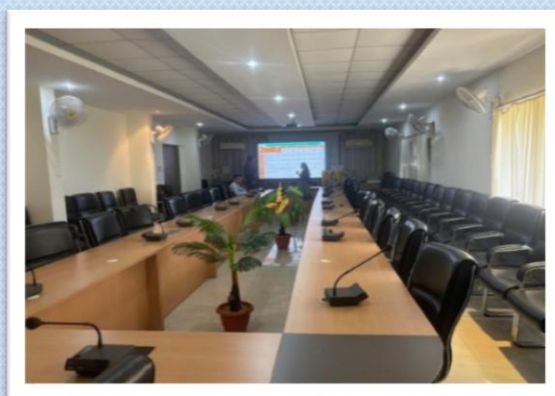

4.14 EXTENSION ACTIVITIES

Department of Dairy Extension Education of Bihar State Institute of Dairy Technology (BSIDT) was established to undertake extension activities, besides teaching and research in Extension Education. Major extension activities include; Training Programs (National & International), Transfer of Technologies, Conducting Demonstrations, Scientist-Farmer-Interactions, Kisan-Gosthies, Animal Welfare Camps (AWCs), Field Days, organization of Research-Extension-Industry-Farmer-Interface, Farmer-Field-School, Self Help Groups (SHGs) formation, Exposure Visits etc. along with this, the experts continuously assist the end users to adopt the technological innovations in dairy farming, facilitate technology assessment and refinement of dairy-based innovations, undertake capacity development programs in dairy extension and promote convergence and collaboration with line departments for sustainable dairy farming. The institute has also been extending consultancy services on the informal basis to dairy entrepreneurs in the state and has been instrumental in encouraging investment in fresh proposals and in upgradation of existing processing facilities in the dairy sector.



4.15 UNDERGRADUATE PROGRAM

4.15.1 BACHELOR OF TECHNOLOGY (DAIRY TECHNOLOGY) [B.Tech.(D.T.)]

B.Tech. Dairy Technology is a four-year Undergraduate Degree Course offered at Bihar State Institute of Dairy Technology, Patna. The course covers different aspects of milk production, milk processing, quality control and managing dairy plant operations as per recommendations of Indian Council of Agricultural Research (ICAR).

4.15.1.1 ELIGIBILITY FOR ADMISSION

1. Higher Secondary/Intermediate/10+2 or equivalent examination from any recognized Board or Council with PCM (Physics, Chemistry and Mathematics) or PCMB (Physics, Chemistry, Mathematics and Biology).
2. Candidate should have qualified the JEE Mains/BCECE-2026 (PCM/PCMB Group).

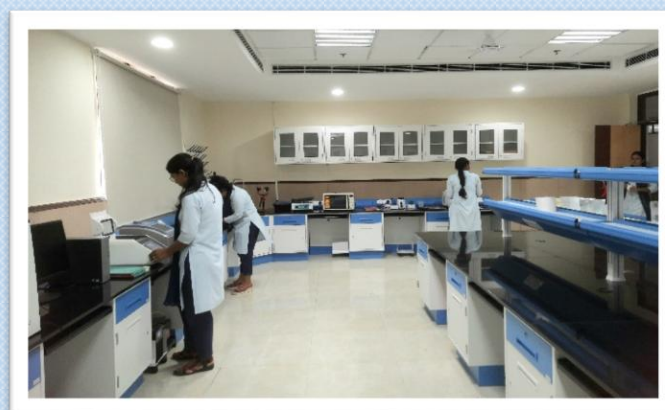
5.6 CLASS ROOMS

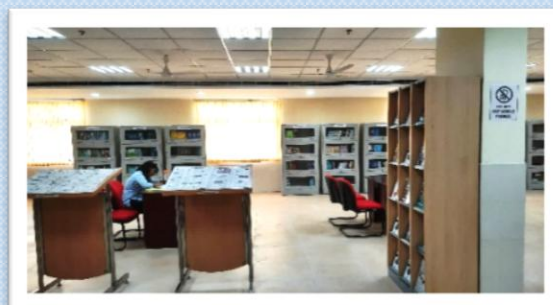

5.13 UNDERGRADUATE PROGRAM

5.13.1 BACHELOR OF FISHERIES SCIENCE (B.F.Sc.)

B.F.Sc. is a 4-year full-time residential degree program offered at College of Fisheries, Kishanganj. Fisheries science is the academic study of understanding and managing fisheries. It is a multidisciplinary science that draws on the study and investigation of fish production, fish health, fish processing, aquaculture and fisheries resource management, fishing technology, aquatic environment and fisheries extension. The course aims to produce graduates capable to perform operation and maintenance of fish farms identifying fish diseases and work in allied areas.
